#### **CONSENT AGENDA DISCUSSION**

The Commission may pull items from the Consent Agenda. During Audience to be Heard, a person may speak on any item on the Consent Agenda, which has not been pulled.

Mayor Hardin announced that Item 2 would be pulled for City Commission discussion.

#### A. PROCLAMATIONS

#### 24-533 Hunger Action Month Proclamation

Mayor Hardin read a proclamation declaring September as Hunger Action Month in the City of Pompano Beach and expressed gratitude to Feeding South Florida for its significant contributions to the community. He invited Lisa Devine, the Grant Manager for Feeding South Florida, to share her thoughts on the initiative.

Ms. Devine accepted the proclamation and discussed the City's support for Hunger Action Month, through community partnership funds and CDBG funds. Feeding South Florida distributed 70 million pounds of food in 2020, up from 34 million in previous years, and over 85.8 million pounds from July 1, 2023, to June 30, 2024. The organization aims to provide food support for families with children during school breaks and weekends. In closing, Ms. Devine encouraged volunteering and directed the public to their website for more information.

#### 24-544 Suicide Prevention Month Proclamation

Mayor Hardin read a proclamation declaring September as Suicide Prevention Month in the City of Pompano Beach. He invited Margie Rohrbach, Education Committee Co-Chair for the League of Women Voters of Broward County, to share her thoughts.

Ms. Rohrbach accepted the proclamation on behalf of the League of Women Voters at Broward and the Florida chapter of the American Academy of Pediatrics, thanking the commission for recognizing Suicide Prevention Awareness Month. She emphasized that over 50,000 Americans die by suicide each year, with half of those being by firearms. Ms. Rohrbach highlighted the importance of locking up guns to save lives and shared the new mental health crisis number, 988. She also mentioned that anyone interested in receiving a free gun lock can email Gloria Lewis at VA.gov.

#### **B. AUDIENCE TO BE HEARD**

Mayor Hardin announced that it was time for "Audience To Be Heard". The following speakers were called to speak before the Commission:

John Bodnar, spoke about repaying Riverside Drive. He noted that the issue had been discussed over a year ago with no visible progress. Mayor Hardin advised Mr. Bodnar to check in with Mr. McCaughan for the dates.

**Norm King**, Lighthouse Point, spoke about kitesurfing at 16th Street and concerns about beach access with the new development in the area. Mayor Hardin stated there should be no change to the beach area.

**Pat Anderson**, expressed concerns about a situation involving attorneys Chris Ema of MacLean and Ema, P.A, and City Attorney Berman. She alleged that they did not acknowledge a significant incident. According to Ms. Anderson, there was a major disruption reported to the Army Corps of Engineers, which involved going seven feet into a cul-de-sac and disregarding code compliance. Additionally, there were allegations of fraudulent real estate transactions and a new construction project that involved an incident of a smash by Qualman, supposedly approved by City Manager Harrison. In closing, Ms. Anderson stressed the significance of uncovering the truth in this case.

**Mary Phillips**, 384 NW 19th Street, Pompano Beach, FL, presented information on *Teens Chasing Dreams*, a new after-school program offering scholarships and community service opportunities for local youth. She invited the City Commission to attend the program's launch event next month and asked for additional City support in promoting the initiative. She also spoke about upcoming events, including Health and Wellness Fest and Employment Lab.

Audrey Fesik, 412 Briny Avenue, Pompano Beach, FL, expressed concerns about a development project

pending resubmittal to the Development Review Committee. While supporting the upgrades, she stressed the importance of ensuring they reflect community use and address safety concerns, particularly for kiteboarders. She urged the City Manager to delay final approval until public input is gathered.

**Jocelyn Jackson**, Pompano Beach, FL, expressed disappointment regarding the lack of representation from City Commission at Mr. Macon's funeral, emphasizing his significant role in the community. Additionally, she recounted a negative interaction with a new BSO officer. Comr. Fournier expressed her sorrow upon learning about Mr. Macon's passing and mentioned that she was informed about the service only after its occurrence. Subsequently, she promptly reached out to City Manager Harrison to address the matter.

**Rodrick Phillips**, 2620 NW 10th Street, Pompano Beach, FL, expressed concern about homelessness and the new law that will take effect on October 1st. He noted that BSO is overwhelmed, officers are underpaid, and they need help to address the situation. He also spoke about the conditions at 164 North Powerline Road, which is affected by homelessness.

Mayor Hardin pulled the item to express appreciation for everyone involved in the project, noting their dedication to the City of Pompano Beach. He highlighted the initiative's importance for both the community and local schools and thanked those who have made efforts to further engage with the City.

Comr. Perkins stated she supports the grant but noted it only covers the Sanders Park and Blanche Ely areas. She asked if the area coverage could be extended.

Earl Bosworth, Assistant City Manager, expressed uncertainty about the current process, noting that the project originated from the Community Foundation of Broward to initiate the planning process. He agreed to consult with Sherry from the Community Foundation to confirm whether they could be in partnership with the City moving forward if the Commission approves the Resolution.

Patricia Williams, State Representative, highlighted the collaboration with the Florida Children Initiative, focusing on securing recurring funding for Pompano Beach, starting with Blanche Ely and Sanders Park. She noted this is the first time Broward County has applied for such funds, despite other Florida cities benefiting. A meeting at the E. Pat Larkins Center will provide more information, though it coincides with the City's budget meeting.

City Attorney Berman noted that Florida Statute 409.147 is the relevant statute for the initiative discussed. He offered to provide copies to any City Commission member or audience member interested in reviewing it, as it outlines the rules, initiatives, and coalitions related to this effort.

Mayor Hardin sought public input on the item.

Vicente Thrower, Pompano Beach, FL, stated that he supported the item. He asked if the Assistant Principal of Blanche Ely could speak on the item.

Dr. Jenny Thelwell, Assistant Principal at Blanche Ely High School, provided an update on the school's progress, highlighting a 13% increase in english, a 25% increase in math, and a 41% increase in biology and U.S. history, which brought their graduation rate to 89%. The school has now achieved a B rating, an improvement from its previous D rating. She attributed the success to the support from teachers, district leadership, and the community. Dr. Thewell invited the City Commission to attend a September 30th event commemorating the renaming of Building 15 in honor of Ernestine Price and Lillian Greaves, two pillars of the community. The event will feature the superintendent and other dignitaries.

There being no further speakers, Mayor Hardin concluded public input and moved on to the Commission discussion; however, no one commented further on the item.

Jean Dolan, Development Services Department, introduced the item and highlighted the proposed Ordinance, which seeks to modify the City's mixed-income housing program by incorporating the Live Local Act. Pompano has been chosen by Broward County to provide expert witness testimony on the implementation of Broward County's mixed-income housing policies 2.16.3 and 2.16.4 due to our expertise in this area. The program has been used to approve 7 projects in the past 2 years resulting in additional affordable units for moderate-income households while preserving flex units and residential entitlements in our transit-oriented districts.

Furthermore, Ms. Dolan discussed the preemptions in the Live Local Act regarding local land use and zoning regulations with regard to multifamily use, density, height, floor area ratio (FAR), and parking in industrial, commercial, and mixed-use districts. The Live Local Act permits residential developments with affordable housing at the highest density and the highest height allowed by any zoning district in the City. In cities with less than 20 percent commercial or mixed-use industrial land use, Live Local projects must be mixed-use. Residential land use and zoning districts, as well as areas affected by the Airpark Overlay District, are excluded from the Act's provisions. Administrative approval, without the need for public hearings, is mandated for affordable housing projects approved under the Live Local Act.

Ms. Dolan noted that adjustments to the City's code have been made to accommodate the Live Local Act, including the increase of the maximum affordable housing percentage to 40 percent in the Dixie Highway corridor and the Powerline corridor between Atlantic Boulevard and NW 15th Street. All projects subject to the City's mixed income regulations must be mixed-use if they are beyond a grocery store's half-mile service radius and on a major transit route, with the aim of promoting balanced communities and expanding neighborhood-serving retail and office uses. The types of uses to be allowed to locate within the non-accessory commercial spaces in mixed-use projects have been defined in the zoning code. Parking requirements for mixed-use projects have been augmented, to include one guest space required per five units in the project.

Attached as **Exhibit 1** is a copy of Ms. Dolan's presentation, which is a comprehensive overview of the proposed code amendment, covering all the relevant details and aspects of the proposal.

Finally, Ms. Dolan noted that the Planning and Zoning Board unanimously recommended approval of the amendments to the Mixed-Income Housing Ordinance to address the 2024 version of the Live Local Act on June 26, 2024 and staff recommends approval.

Mayor Hardin sought public input on the item.

Dwayne Dickerson, 14 SE 4th Street, Boca Raton, representing a residential developer planning a workforce affordable housing development, requested amendments to allow their project to proceed. The amendments would adjust Section 155.4202.A.2.g.i.(A), removing the requirement for a commercial or non-residential component and allowing for 100% residential use. Additionally, he requested an amendment to Section 155.4202.A.2.g.i.(F), which currently limits affordable workforce housing to 50% of the development. The proposed change would allow 100% of the development to be affordable workforce housing. Attorney Dickerson emphasized that the request is narrowly tailored to avoid disrupting other projects, noting that similar developments, including the Broward Partnership for the Homeless and Captiva, have succeeded under the current guidelines.

Jocelyn Jackson, Pompano Beach, FL, asked if previous projects would require amendments as well. Ms. Dolan clarified that code amendments are not retroactive. Ms. Jackson stated she was excited about the new development coming into the community.

Vicente Thrower, Pompano Beach, FL, asked about the proposal's impact on current projects. Mayor Hardin repeated Ms. Dolan's earlier response, stating that it would only affect future projects. City Attorney Berman emphasized that the impact is not retroactive. Mr. Thrower suggested being mindful of introducing affordable units to the neighborhood.

There being no further speakers, Mayor Hardin concluded public input and moved on to the Commission discussion.

Comr. Fournier expressed concerns about parking requirements in the TOD (Transit-Oriented Development) area. Ms. Dolan stated the proposal involves merging the Live Local Act into the City's code and described the limitations imposed by state law. She clarified that the law allows developers to propose projects with zero parking, but it is unlikely due to financial feasibility. Comr. Fournier sought clarity on the implications of voting no on the proposal, and it was explained that rejecting it would remove the safety measures the City had added but would not change state law. Ms. Dolan emphasized that the City's current code already meets many of the incentives promoted by the Live Local Act, and further adjustments, such as parking incentives, are being implemented to ensure the best possible outcomes.

Comr. Fournier and Ms. Dolan discussed the implications of the proposed amendment, with Comr. Fournier seeking clarification on how many projects would be affected, particularly regarding Captiva Cove in her district. She emphasized that expanding an existing affordable project, like Captiva Cove, would be a positive development. Ms. Dolan clarified that the amendment is not about Captiva Cove but about 2050 MLK at the corner of Powerline Road and MLK Boulevard. This area has the highest concentration of subsidized housing in the City, and the amendment would not affect other affordable projects like Captiva Cove, which was approved before the mixed-income policy was implemented.

Ms. Dolan clarified that the project at 2050 MLK is a standalone development and not a phase of an existing project. The entitlements for the project were created through a resolution and initially planned for 263 units, mainly market rate, with 39 flex units and bonus units. The project was designed to bring moderate-income housing into an area with a high concentration of poverty. However, the current request would modify the

project into another tax credit development, contrary to the City's goal of reducing poverty concentrations in the area. Ms. Dolan further emphasized that the 2050 MLK project is located in the center of an area where the City is actively working to reduce poverty concentration. Adding a tax credit project in this zone would undermine the City's efforts over the past two years, which aimed to limit affordable housing developments to 50% in areas with high poverty concentration.

Comr. Fournier questioned if the proposed change would only affect the 2050 MLK project or if other projects would be impacted. Ms. Dolan explained that any previously approved projects requesting amendments could bypass the City's affordable housing policies, using flex units to pursue tax credit projects in areas where the City is trying to deconcentrate poverty.

Vice Mayor McGee asked for clarification on the location and definition of mixed-use, specifically whether non-residential space refers to non-accessory commercial space. Ms. Dolan confirmed this and added that the City's mixed-income housing strategy aligns with federal, state, and county policies. She emphasized that mixed-income housing is beneficial for upward mobility, citing data from HUD and local studies. Additionally, Ms. Dolan noted that while the current focus is on injecting commercial spaces into underserved areas, the long-term goal is to attract a grocery store to the Northwest, where commercial options are currently lacking.

Mayor Hardin expressed that while he appreciates Mr. Dickerson's presence, he hasn't yet seen the proposed changes and feels it's not the best method to address such changes at the podium. He sought clarification from City Attorney Berman on whether modifications could be made before the second reading. Mayor Hardin suggested focusing on the current proposal, passing it on first reading, and using the time before the second reading to review Mr. Dickerson's suggestions and discuss them further. He emphasized the importance of being fully informed before making any final decisions.

Comr. Perkins agreed with Mayor Hardin about needing to know more information.

City Manager Harrison recommended that the City Commission pass the item on first reading. Then, city staff will meet with Mr. Dickerson and hold individual meetings with each commissioner.

#### (Staff Contact: Ty Tabing)

Ty Tabing, Cultural Affairs Director, introduced the item and noted that this was the third round of the underwater garden sculpture program. Velvet Anvil was selected from over 107 submissions for the \$35,000 commission. The seahorse sculpture, standing six feet tall with a saddle, will be displayed at the beach for a year before being submerged at Shipwreck Bay. After feedback from Vice Mayor McGee and Public Works, they are considering allowing public interaction by providing a box for access to the saddle. The artist, experienced in underwater sculpture, will ensure the piece is safely prepared for its time on the beach.

Mayor Hardin sought public input on the item and, receiving none, he moved on to Commission discussion.

Vice Mayor McGee expressed excitement about the sculpture, noting its design and potential for marine life to attach to its crevices once submerged. She supported exploring ways for people to safely interact with the saddle, mentioning the inevitability of people wanting to sit on it. She suggested possibly adding a support ladder and proposed using a rubberized coating to prevent the steel from becoming too hot in the sun, avoiding potential injuries.

Comr. Fournier supported making the sculpture more accessible, noting that preventing children from climbing it would have been difficult. She appreciated the direction of making it safe for interaction and suggested the artist consider safety during the design process.

Mayor Hardin also praised the MLK overpass project, calling it a wonderful addition to the area.

#### G. REPORTS

#### **City Manager's Report:**

City Manager Harrison announced the next Clean Streets project, which will take place on September 19th in the neighborhoods of Blanche Ely, Sanders Park, and Canal Point. He also provided dates for public forums on proposed city charter changes: September 18th at the E. Pat Larkins Center at 6:00 p.m., September 19th at the Emma Lou Center at 6:00 p.m., and October 9th at the Herb Skolnick Center at 7:00 p.m.

In addition, City Manager Harrison reported that the Florida Festival and Event Association recognized the Parks and Recreation staff with multiple awards. The awards included first place for children's programming and multi-agency collaboration. The Cultural Affairs Department was recognized for its Jazz Fest, winning second place for television and third place in social media. The Strategic Communications Department was also awarded for their work on events and marketing. Finally, City Manager Harrison recognized Major Elwood and Sergeant Williams for their efforts with the ShotSpotter program.

#### City Attorney's Report:

City Attorney Berman mentioned that, along with the previously mentioned forum dates, there will be a meeting on September 26th at the Skolnick Center. Informational materials about the proposed charter amendments, including a website notice, video, and pamphlets, will be available at City community centers to provide neutral information to residents.

#### City Clerk's Report:

No report.

#### **Comr. Fournier's Report:**

Comr. Fournier welcomed back Pompano Beach students and discussed a recent Zoom meeting with local school principals on supporting students. She looks forward to organizing another Student Government Day. Next, she expressed concern over the condition of roads in Garden Isles and Cypress Harbor, asking the City Manager about the possibility of accelerating paving projects. Her community meeting, featuring Senator Pizzo, will be held on September 18th at 7:00 p.m. at the American Legion. Topics will include insurance, condo legislation, and short-term rentals. Comr. Fournier also highlighted the 9/11 memorial ceremony at Founders Park. She also expressed concern about House Bill 1365, noting the Sheriff will stop accepting municipal ordinance arrests on October 1st. She highlighted the City's challenge in handling contempt cases, especially without state funding, and asked how the City will respond to potential lawsuits from businesses regarding homeless individuals.

#### **City Commission**

City Attorney Berman explained that the Sheriff's refusal to accept municipal defendants is based on the county jail not being a municipal detention facility, according to Florida Statute 950.1.23. City and county attorneys are actively working on solutions, including the possibility of a countywide ordinance that could allow deputies to cite under it. He noted that this issue extends beyond homelessness to all municipal ordinance violations and acknowledged potential legal risks. Progress is ongoing, and updates will be provided as developments occur.

Discussion ensued between Comr. Fournier and City Attorney Berman regarding the statute and impact on the City.

#### Comr. Moss' Report:

Comr. Moss announced that on October 9th, at 7:00 p.m. at the Herb Skolnick Center, Palm Aire United will host a candidates' forum. Letters will be sent to candidates for City Commission and Mayor positions affecting District Five. The forum will start with city representatives explaining charter-related ballot items, followed by candidate introductions, journalist questions, and an open floor for audience questions. Representatives from The Pelican newspaper will moderate. Comr. Moss also announced the return of Saturday morning meetings at 9:30 a.m. at the Herb Skolnick Center.

#### Comr. Perkins' Report:

Comr. Perkins thanked Chief Elwood for his assistance with a matter. She reminded residents near Blanche Ely and Sanders Park of the clean streets event on September 19th and will post details on her Facebook page. She suggested creating a city master calendar to avoid event conflicts, mentioning challenges with booking the E. Pat Larkins Center. Upcoming events include city charter changes on September 18th and a schools' event in Coconut Creek, which she plans to attend. She also noted a meeting by Commissioner Williams at the E. Pat Larkins Center on Thursday, coinciding with the budget meeting.

#### Vice Mayor McGee's Report:

Vice Mayor McGee applauded the recent pier cleanup event, noting divers, snorkelers, and volunteers helped clean up, with some divers even interacting with the pier camera underwater. She hopes next year's event will receive more promotion. She thanked the Building and Ground Departments, along with the Parks and Recreations Department for the new Pier Park playground, which has received positive feedback from both kids and parents. Additionally, she noted that a pull-up bar, requested by residents, is on its way and will be installed soon. Lastly, she announced the "Music Under the Stars" event this Friday on the Great Lawn.

#### Mayor Hardin's Report:

Mayor Hardin complimented the City on the success of Wahoo Bay, which has received positive press and attention, highlighting its value to the community. He also thanked Assistant City Manager Bosworth for visiting the Charles Drew Resource Center with him to discuss potential partnerships. Mayor Hardin mentioned his upcoming visit to Sanders Park for their student government election, emphasizing the importance of city officials engaging with schools. Finally, he read a letter of praise from a general contractor, commending the

City's Building department for its professionalism and efficiency.

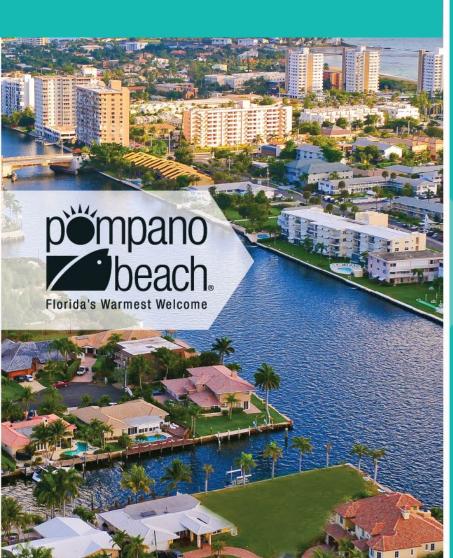

\*100% of these tax credit projects are restricted to affordable.

Benefits in the first two years of implementing the mixed income housing policies:

(1) Created (on paper) 114 moderate income affordable units that would not have been provided otherwise due to 2.16.3 not allowing buyout as an option and 2.16.4 buyout being \$10K+ per unit.

(2) Got back 103 flex units (From Captivl Cove Phase III - originally approved as Aloha) plus saved 563 flex and redevelopment units. Without this policy we would have only 121 flex/redevelopment units left.

(3) Saved 195 units in the Downtown basket of Development Rights that can be used for future projects.

(4) Saved 127 units in the ETOC basket of Development Rights that can be used for future projects.

Note: Policy 2.16.3 is the most popular method for entitling property because it does not require mixed use. This proves that if we want mixed use, we have to require it or it won't be built.



# What the Live Local Act Does

- Preempts local government from applying their land use and zoning regulations in relation to Use (MF rental), Density, Height, FAR and Parking in Industrial, Commercial and Mixed Use Districts. Allows for zero parking for qualified mixed use projects in a Transit Oriented District.
- Gives highest residential density in the City code (not including any bonus density) and highest height
  within a mile of the site to any multi-family project with at least 40% affordable housing in an
  Industrial, Commercial or Mixed Use District. Some limitations if the site has SF on at least 2 sides.
- Requires projects to be mixed use in cities with less than 20% commercial OR industrial land. Pompano is 8.6% Commercial and is 21% Industrial. The City Attorney is interpreting this to mean all Live Local projects in Pompano must be mixed use since we are less than 20% commercial.
- Excludes residential land use and zoning districts and areas affected by Chapter 333.03 F.S. (Airpark Overlay District) from these affordable housing projects.
- Requires administrative approval of affordable housing projects approved under this law with no hearings by elected or appointed bodies.



# Code Amendments

- 1. Increase the 20% maximum affordable on Dixie Highway and Powerline between Atlantic Blvd and NW 15<sup>th</sup> Street to 40% to ensure compliance with the 40% minimum affordable in a Live Local Act project. Otherwise, no changes to our deconcentration of poverty regulations.
- 2. Require all residential projects using 2.16.3 or 2.16.4 to be mixed use if outside of a grocery store (definition added) ½ mile service area. This implements Comp Plan Policy 01.23.01 To create balanced communities, encourage the expansion of neighborhood-serving retail and office uses in areas dominated by the industrial, and manufacturing sectors if appropriate to better serve the local community. All Live Local Act projects already have to be mixed use.
- 3. Define how much nonaccessory commercial is required in one of these mixed use projects which is 50% of the ground floor facing a primary road, public open space or major pedestrian walkway (same as required by 2.16.4 for properties 5-acres or less).
- 4. Increase the parking requirement for all mixed use projects to include the 1 guest space per 5 units requirement and specify that the mixed income housing parking incentives cannot be combined with the Live Local Act parking incentives.
- Define the Minor Site Plan process as the required administrative approval of a Live Local Act project and exclude AAC approval requirement when major building design.









# Additional Definitions

## PART 5 TERMS AND USES DEFINED

### **Convenience Store**

A store with extended opening hours and in a convenient location, stocking a range of household goods, with limited groceries dominated by prepackaged drinks and snacks.

### Grocery or Convenience (nonconvenience) Store

A retail establishment engaged in the sale of food and foodstuffs, sundries, tobacco products, beer, wine, papers and magazines. A large (+15,000 SF) self-service store selling a full range of fresh foods including a comprehensive selection of fresh fruits, vegetables and greens, fresh milk, eggs and other dairy products, various types and cuts of meat and poultry products, ingredients for home cooking and baking, deli meats and salads, and other household goods.

### **Mixed Income Housing Development**

A project with a combination of income restricted and unrestricted units.



# Recommendation

The Planning and Zoning Board unanimously recommended approval of the amendments to the mixed income housing ordinance to address the 2024 version of the Live Local Act on June 26, 2024.

Staff recommends approval.

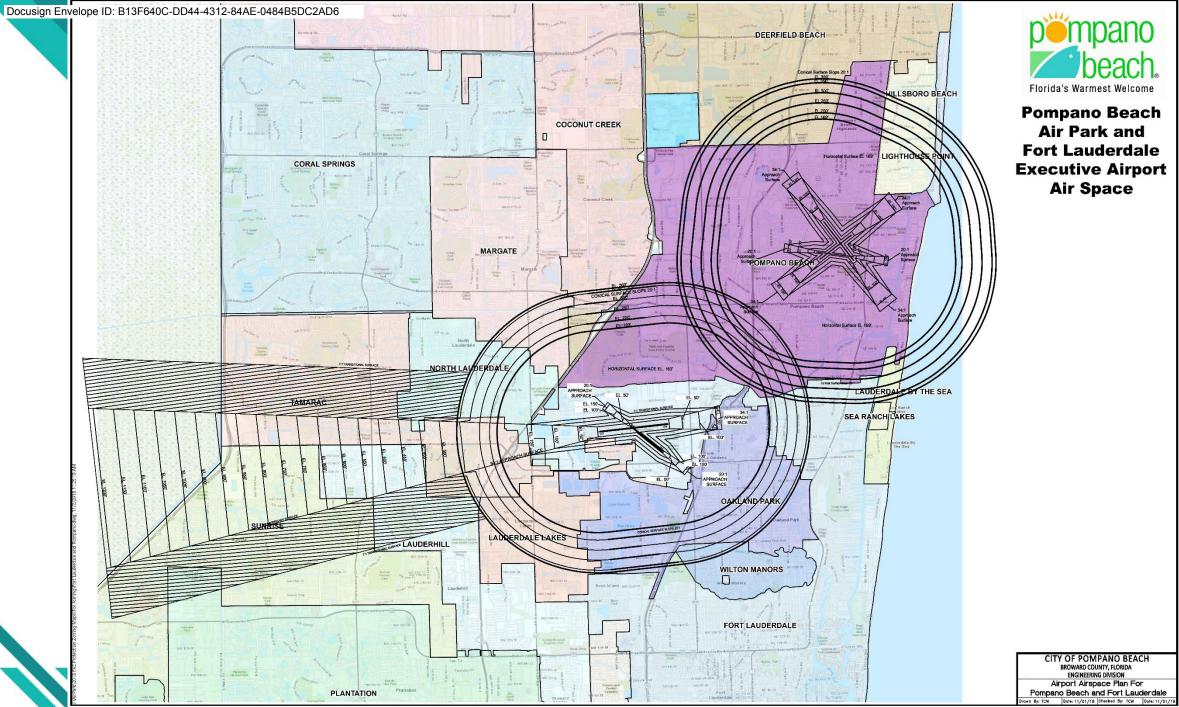
