I wanted to thank you for taking the time to connect with our team yesterday.

Attached, you will find the suggested plan for our solid waste management. After our discussion, we have decided that a 36 CU Yard centralized compactor, serviced once a week, would be the best fit for our operation.

Our management team will be responsible for transferring the trash from each building to the central compactor as needed. Additionally, we will be storing the garbage in a refrigerated room in each building.

We have relocated the compactor to a more centralized location, making it easier for the roll-off garbage truck to access it.

Could you please confirm that this plan is feasible from your operational standpoint? We are currently working on the DRC submittal, and any feedback from Coastal Waste would be greatly appreciated.
