

Know All Men By These Presents:-

That we, E. N. Jelks, his wife, K. C. Moore, and Nellie Hunt Moore, his wife, and J. M. Moore, owners of the land as set forth in the description attached, have caused the same to be subdivided in the manner shown on the attached plat, to be known as WAHOO N<sup>o</sup> 2.

All streets, avenues, and drives, or parts thereof, are hereby dedicated to the perpetual use of the public as thoroughfares, reserving to ourselves, our heirs, administrators, or assigns, owners of abutting property, the reversion or reversions thereof when discontinued by law.
