Horacio Danovich, G.O. Bond and Innovation District Director, presented the item and stated that similar to what was done at the Special Meeting of November 17, 2020, he would like to take a few minutes to make an overhead presentation, provide a brief recap, as well as offer an update to the Commission on what is on the Agenda. Thereafter, the items would be discussed specifically as they come up for discussion. Attached is a copy of the overhead presentation as **Exhibit 1**.

Mr. Danovich mentioned that this could not have happened without the help from everybody in the various departments to commence with the Contract Manager, City Attorney's Office, Finance, Assistant City Manager and the entire G.O. Bond team.

On November 17, 2020 there were First Readings of several projects namely the Ocean Rescue Building second floor addition, Mitchell Moore Park, NE 33rd Street Improvements, North Pompano Park, Terra Mar Drive Bridge Improvements, Youth Sports Complex, Senior Citizens Center, McNair Park Renovations, and Fire Station No. 52, specifically the fuel depot addition.

Continuing, Mr. Danovich indicated that four new projects were added and are coming in as First Readings on the Agenda. Namely, Dixie Highway Segment I, which work is planned to be done for McNab Road to SW 1st Street. In the future, additional Segments affecting Dixie Highway, as well as Atlantic Boulevard will be brought before the Commission. In addition, there is the State Road A1A project, which involves the undergrounding of overhead utilities from Sunset Lane, the southernmost roadway, to Atlantic Boulevard. The Centennial Park Pavilion, is a project initially planned for Phase II but he will provide details on why this is brought forward today. Lastly, the SE 5th Avenue bridge. He then mentioned that a number of issues including COVID-19 related delays affected the completion of the design plans. This caused a few months delay for the start of construction, planned originally to be in September for some of these projects. It also caused an increase in unit prices for January 2021. Therefore, he requested the City Commission allow for Second Reading for these four projects. Providing all items are approved, notice to proceed can be given on all the projects to get started on in January.

Mark Berman, City Attorney, stated that this is of an emergency nature, which is being called for an emergency Second Reading. The State of Emergency that the City is currently under due to COVID-19 statewide, countywide and within the city, being declared, has prevented meetings on a more regular basis, plus the

holidays, and plus everything else, there is no additional time to continue to meet. The City should get these projects moving forward because the pricing will increase if approval is not received at this time. Based on the emergent nature of everything that is happening, he wanted it noted in the record that the basis for the emergency Second Reading is the emergency situation that the City has found itself under at this time.

Mr. Danovich indicated that they will post copies of all the projects schedules on the City's website, particularly on the G.O. Bond pages under the G.O. Bond projects construction schedules. In addition, they will be putting details on roadway closures and will reference traffic plans to be posted under the pages underneath the heading G.O. Bond Construction Lane Closures, which will be on the front page of the website. In the coming months, there will be a lot of construction taking place and a lot of people will be affected by this. The first one on Dixie Highway has already been posted.

Continuing, Mr. Danovich provided a brief recap on the projects that were approved during the first go around - Segment 1, which was presented at the November 17, 2020 Special Meeting and detailed in the attached **Exhibit 2** document. Additionally, he defined GMP as the Guaranteed Maximum Price.

Mr. Danovich then presented the items on the current Agenda, which is detailed in the attached Exhibit 1.

Mayor Hardin reminded everyone that they were still discussing Item 1, which is the Mitchell Moore Improvement Project. Mr. Danovich went through all the various projects at one time, however, each one can be discussed further as they come up in the agenda.

Horacio Danovich, G.O. Bond and Innovation District Director, presented the item and stated that the project has a GMP of \$2.829 million, and an anticipated completion date of winter of 2021. The key thing on this project is that they are going to do everything to ensure that people will be able to navigate those waters safely even during construction time.

There was no public input for this item.

Comr. McGee indicated that the City has quite a number of artists that live in the area and it would be "cool" to

showcase their different types of artwork. Perhaps, the Public Art Committee could be more involved in searching out the local artists who could showcase their artwork. A map could be done to indicate where the various art work can be seen as it relates to the bridges in general.

Comr. McMahon stated that he is excited to see the project moving forward, and the Mayor as well, as this was his district prior to becoming Mayor. He urged Mr. Danovich to be sure to keep communication open. Notwithstanding, he is aware that construction will be challenging at times within the small area they have to work with.

Mayor Hardin agreed with Comr. McMahon's comments. He said communication for all of the projects is critically important. Whether it is in a residential area, such as this bridge, or if it is in some commercial area such as Dixie Highway. There is a need to do a better job as a City of communicating with the residents that are being impacted by the construction of these projects. He does not want another situation that they had previously experienced at MLK Boulevard where people were stranded and could not get to their businesses. They will need to go door to door to make sure people have an idea of what is going on, and ensure they have a telephone number that they can contact to actually reach somebody, if there is a problem. Extra money should be spent to provide door hangers to inform the residents who will be impacted by this project. In addition, the realtor association should be contacted to inform them of what is taking place in the communities. In sum, let everybody know what is happening ahead of time.

Comr. Eaton stated that for NE 33rd Street, there will be some "heartburn" with the project and those residents also need to be notified by mail, and given a contact number, even if she needs to give her number. Everyone wants to see the improvements, but there is that difficult time of construction where communication is important.

Mayor Hardin also mentioned that with the construction planned for the parks, notices should also be put out so people will know what is happening and that life will be disruptive for a period of time.

Comr. McGee suggested that perhaps they could put up large enough signage in the area where construction is taking place, informing people of the dates and times construction will take place, as well as a contact number to call for further information regarding the project.







- Original scope: replacement of SE 5th Avenue Bridge, built in 1959, based on FDOT's Bridge Management System report
 which includes recommendations for repairs to the deck and superstructure as well as substructure components to be
 replaced which includes pilings and jackets. Bridge will be raised to match vertical clearance at US 1/Federal Highway.
- Updated scope: no significant changes. Upon plan review, the design team was asked to make provisions to harmonize the approaches to the bridge with existing driveways. In addition, existing FPL poles will have to be temporarily relocated and re-installed at their original locations. This is necessary to allow cranes and other equipment to safely operate in and around the overhead wires.
- CMAR has a plan in place to manage vessels traffic during construction. During the week, an operator will flag vessels in and out of the work area. Vessels may have to wait for extended periods of time, but they will be allowed to navigate the area. On weekends, the CMAR will make provisions to allow free flow of vessels traffic along the navigational channel except for situations that require added safety measures.










