Scope of Authorization
Federal League, Inc.

A. Introduction/Background & Objective

Federal League, Inc. (“Licensee”) is an Adult Baseball organization whose mission is to provide an adult baseball league from April to October for Adults 18 and up utilizing the athletic fields within the City of Pompano Beach (“City”).

B. Scope of Work

Licensee shall annually utilize City athletic fields within the first three weeks of April to the last three weeks in October to conduct an Adult Baseball League. Times/Dates for each game at each field shall be mutually agreed upon between Licensee and the City’s Recreation Programs Administrator or designee. The maximum amount of games per week shall not exceed eight (8) in total.

Licensee’s primary location shall be the athletic fields at Community Park located at 1660 NE 10th St, Pompano Beach, FL 33060. The City will maintain the right to override scheduling conflicts if it is in the City’s best interest. If scheduling conflicts occur, the City will provide Licensee with available alternate dates. Monday through Friday game times shall start no later than 6:00p.m. on any given date.

C. Summary Schedule of Tasks and Deliverables

Compensation – For the first initial year, Licensee shall pay the City a fee of seventy-two dollars (\$72.00) for each game of the season, including playoffs. This shall be paid to the City of Pompano Beach’s Parks and Recreation Department, located at 1801 NE 6th Street, Pompano Beach, FL 33060, at least 48 business hours before the start of the league. For each additional season, Licensee shall pay the City a fee of ninety dollars (\$90.00) for each game of the season, including playoffs. Payment shall include a report showing a complete list of games entered into league including regular season and playoffs. Rain Out dates shall be mutually agreed upon between the Licensee and the City at no extra cost. If any games can not be completed, appropriate refunds will be issued to Licensee.

Sports Equipment – Licensee shall be responsible for providing all necessary baseball equipment for league play; Balls, Umpires, screens.

Others –

1. **Merchandise Sales:** Licensee shall not sell any goods and/or concessions at any point during this contract without pre-approval. Licensee shall be responsible for providing all outside merchandise vendors’ insurances that list the City as additionally insured and be pre-approved before arriving at the facility.
2. **Compensation Includes:** The seventy-two dollars (\$72.00) for each game fee shall cover all required maintenance costs for the first initial year. For additional seasons, the ninety dollars (\$90.00) for each game fee shall cover all required maintenance.

Maintenance shall pertain to both field and facility maintenance, i.e. dragging, lines, staffing, bathroom supplies, ice, lights, etc.

3. **League Length:** The league may not start earlier than April 1st or go past October 31st unless mutually agreed upon between Licensee and the City.

Trash and Clean-up of Permitted Area - Licensee shall be responsible for clean-up and removal of debris and trash from the Permitted Area during and after league days. Licensee shall further be responsible for dismantling and removing all supplies and equipment if applicable.

Parking - Licensee acknowledges that parking will be available for the public during the event by use of the City's public parking areas and facilities and at no time will parking fees be waived (if applicable).

Additional Dates – Licensee may provide two additional tryout dates after October 31 and before April 1 at an agreed upon time/date prior to the start of the season. This will be at no extra cost to the Licensee. All additional tournaments, tryouts, games shall be charged at a fee of seventy-two dollars (\$72.00) for each game for the first initial season. During additional seasons, after initial season, all additional tournaments, tryouts, and games shall be charged at a fee of ninety dollars (\$90.00) for each game.
