**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATION OF A NOT TO EXCEED AMOUNT OF ONE THOUSAND DOLLARS (\$1,000.00) FOR VICE MAYOR MOSS TO SUPPORT THE COLLIER CITY FAMILY FUN DAY SPONSORED BY THE BROWN'S COMMUNITY DEVELOPMENT CENTER, INC.; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Resolution No. 2019-50, the City has budgeted annual funds in a set amount on behalf of each City Commissioner to use for their specifically requested city events and programs and any associated expenses; and

**WHEREAS**, the Brown's Community Development Center, Inc. is hosting the Collier City Family Fun Day on August 10, 2019; and

**WHEREAS**, Vice Mayor Barry Moss wishes to sponsor the above event and has requested use of a not to exceed amount of \$1,000.00 of his apportioned funds to cover costs; and

**WHEREAS**, the City Commission has determined that the best interests of the public will be served by providing funding, on a cost reimbursement basis, for this event, which is open to all City residents; now, therefore,

**BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:**

**SECTION 1.** That it is the determination of the City Commission of the City of Pompano Beach, Florida, that the Brown's Community Development Center, Inc.'s Collier City Family Fun Day, supported by Vice-Mayor Moss, serves a public purpose.

**SECTION 2.** That the City approves and authorizes the appropriation of a not to exceed amount of One Thousand Dollars (\$1,000.00), from the designated funds for such events for Vice-Mayor Barry Moss, to the Brown's Community Development Center, Inc. for its Collier City Family Fun Day to be held on August 10, 2019, and that such funds shall be disbursed on a reimbursement basis following presentation of verified receipts to the City Manager.

**SECTION 3.** This Resolution shall become effective upon passage.
