Subject: LS 67 emergency Repairs

Importance: High

Good morning Carla and Tammy,

Wastewater Lift Station 67 which is located at 50 SE 12 Street requires immediate emergency repairs to the pump bases and discharge piping. This master lift station which services Garden Isles and Lyons Park discharges up 1.5 million gallons per day of wastewater into the Cypress Road force main.

This past week's extreme rainfall event demonstrated that neither the station pumps nor the bypass pump was capable of maintaining the wet well at a safe level due to the disrepair state of the pump bases and discharge piping.

Given the state of the pump station and the current and ongoing weather conditions, multiple private Jet Vac companies with City Jet Vactors were required to aid in containing the wastewater within the system from Wednesday April 13, thru Sunday April 16; 24 hours a day.

City staff contacted Man Con, Inc. and Reynolds Construction, the two awarded vendors for RFP # P-27-19, Emergency and On Call Utility Repairs Services. Their response to the emergency solicitation to repair the City's Lift Station was considerably more than anticipated at the cost of \$108,030. The City contacted local vendor Trio Development Corporation and received a proposal of \$84,560, which provided a savings of \$23,470. It is recommended to approve Trio Development Corporation; a local Pompano Beach vendor to procure items and begin the emergency repairs to the wet well at Lift Station 67.

It is important that this emergency condition is corrected in a timely manner prior to the next major rain event or upcoming hurricane season.

Funding the emergency repair services will be through CIP 08-968, account number 420-7345-535-6512
