



Broward Sheriff's Office Trespass Program

Dear Property Owner or Operator,

In the interest of providing a safe street environment, the Broward Sheriff's Office has a crime prevention initiative to assist you. Florida State law allows law enforcement officers to serve as authorized representatives of property owners to act on their behalf in their absence. When a property owner/operator completes an affidavit or letter of authorization, deputy sheriffs can legally enforce the provisions of the trespassing law (F.S.S. 810). Areas appropriate for this initiative are all locations where the public is invited or would normally visit. The enclosed information package contains instructions, an affidavit and a sample poster. Once all Trespass Program paperwork is completed, **authorized BSO Trespass signs may be purchased at the following locations:**
