AN ORDINANCE OF THE CITY COMMISSION OF THE CITY BEACH, FLORIDA, **APPROVING** OF **POMPANO** AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE CONTRACTS FOR CONSULTING/PROFESSIONAL SERVICES BETWEEN THE CITY OF POMPANO BEACH AND CALVIN, ASSOCIATES, INC., & **COMPASS** GIORDANO SURVEYORS, PL, COLLIERS ENGINEERING & DESIGN, INC., CRAIG A. SMITH & ASSOCIATES, INC., CRAVEN, THOMPSON & ASSOCIATES, INC., ENGENUITY GROUP, INC., KCI TECHNOLOGIES, INC., KEITH AND ASSOCIATES, INC., MCLAUGHLIN ENGINEERING COMPANY, AND MUNSON INC., DESIGN CONSULTING, **FOR CONTINUING** CONTRACT FOR SURVEYING AND MAPPING SERVICES FOR **VARIOUS CITY PROJECTS**; **PROVIDING FOR** SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

BE IT ENACTED BY THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. That ten (10) Contracts for Consulting/Professional Services for Continuing Contract for Surveying and Mapping Services, between the City of Pompano Beach and Calvin, Giordano & Associates, Inc., Compass Point Surveyors, PL, Colliers Engineering & Design, Inc., Craig A. Smith & Associates, Inc., Craven, Thompson & Associates, Inc., Engenuity Group, Inc., KCI Technologies, Inc., Keith and Associates, Inc., McLaughlin Engineering Company, and

Munson Design & Consulting, Inc., copies of which Contracts are attached hereto and incorporated herein by reference as if set forth in full, are hereby approved.

SECTION 2. That the proper City officials are hereby authorized to execute said Contracts.

SECTION 3. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.
