

**DESCRIPTION**

A PORTION OF THE SOUTHEAST ONE-QUARTER (S.E. 1/4) OF THE SOUTHEAST ONE-QUARTER (S.E. 1/4) OF SECTION 4, TOWNSHIP 49 SOUTH, RANGE 42 EAST, MORE FULLY DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTHEAST CORNER OF SAID SECTION 4; THENCE WESTERLY ALONG THE SOUTH LINE OF SAID SECTION 4, A DISTANCE OF 707.05 FEET; THENCE NORTHERLY AND PARALLEL TO THE EAST LINE OF SAID SECTION 4, MAKING AN ANGLE IN THE NORTHEAST QUADRANT OF 88°22'03", A DISTANCE OF 216.02 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING NORTHERLY ALONG THE LAST DESCRIBED COURSE A DISTANCE OF 300.57 FEET; WESTERLY AT RIGHT ANGLES, A DISTANCE OF 334 FEET; THENCE SOUTHERLY AT RIGHT ANGLES, A DISTANCE OF 269.57 FEET; THENCE EASTERLY AT RIGHT ANGLES, A DISTANCE OF 136 FEET; THENCE SOUTHERLY PARALLEL TO THE SAID EAST LINE OF THE SOUTHEAST ONE-QUARTER (S.E. 1/4) OF SECTION 4, A DISTANCE OF 31.00 FEET; THENCE EASTERLY, PERPENDICULAR TO THE LAST DESCRIBED COURSE, A DISTANCE OF 198.00 FEET TO THE POINT OF BEGINNING.
