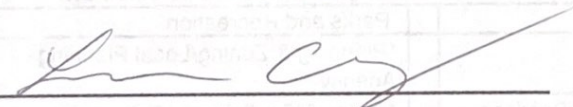
Education: B.A. in Political Science from Furman University. Masters in Liberal Studies from the University of Miami.
