CALL TO ORDER

APPROVAL OF MINUTES

[23-657](#) City & CRA Board Joint Workshop Minutes of May 3, 2023

A motion was made by Vice Mayor McGee, seconded by Commissioner Eaton, that the Minutes be APPROVED. The motion carried by a unanimous voice vote.

[23-658](#) Regular City Commission Meeting Minutes of July 11, 2023

A motion was made by Vice Mayor McGee, seconded by Commissioner Eaton, that the Minutes be APPROVED. The motion carried by a unanimous voice vote.

APPROVAL OF AGENDA

Mayor Hardin announced that a Special Presentation by Representative Chip LaMarca will be added to the Agenda and will be heard before the update from the Broward County Supervisor of Elections Office. Also, he said Items 16 and 17 will be stricken from the Agenda.

A motion was made by Vice Mayor McGee, seconded by Commissioner Eaton, that the Agenda be APPROVED AS AMENDED. The motion carried unanimously by voice vote.

CONSENT AGENDA DISCUSSION

The Commission may pull items from the Consent Agenda. During Audience to be Heard, a person may speak on any item on the Consent Agenda, which has not been pulled.

Mayor Hardin announced that Item 1 would be pulled for City Commission discussion.

DISCUSSION ITEM ADDED

A motion was made by Mayor Hardin, seconded by Commissioner Fournier, to direct staff to go back to the original budget, as submitted by the City Manager, which included Sand and Spurs Stables.

A motion was made by Mayor Hardin, seconded by Commissioner Fournier, to postpone discussion until the first item on the Regular Agenda.

Vice Mayor McGee asked if the motion would take the Commission back into discussion for other budget alterations as well. Mayor Hardin responded the discussion can be on anything the Commission wishes to discuss.

Mayor Hardin further clarified his motions.

Comr. Eaton asked if they are reversing all discussion or only part of the discussion. Mayor Hardin replied the discussion will be about the City Manager's operating budget.

Comr. Eaton asked if they are nullifying the recent budget workshop. Mayor Hardin clarified he is speaking about the direction given to staff concerning the operating budget and Sand and Spurs Stables.

Comr. Fournier recommended the motion be clarified to simply include funding for Sand and Spurs Stables for the FY 2024 budget.

Mayor Hardin recommended postponing the current discussion until Regular Agenda, as it will be the first item for discussion.

In a voice vote, the Commission unanimously agreed to postpone motions and discussion.

A. AUDIENCE TO BE HEARD

Mayor Hardin announced that it was time for "Audience To Be Heard". The following speakers were called to speak before the Commission:

The following are the names of the speakers under Audience to be Heard:

Marlowe Moreland, Pompano Beach, spoke about the violent streak within the community and mass murders. She said they have begged BSO for help and it is not enough. She suggested bringing in the Guardian Angels, who are trained in putting cities back together. She said they also have a Junior Division. She asked how she can present the recommendation for the City Commission to consider. She stated they pay BSO \$50M a year and they need help.

Mayor Hardin asked Ms. Moreland to email him directly so he can direct staff to contact BSO to start the ball rolling to find out more information.

Comr. Perkins said she is aware of the Guardian Angels and noted they were effective in several cities historically. She agreed with Ms. Moreland's recommendation.

Janice Simmons, 208 NW 15th Place, Pompano Beach, said she is here to show appreciation to the Senior Citizen Center, and they are proud of it. She noted Comr. Perkins asked for a state-of-the-art center but the building is too small, there are too many people, and not enough parking spaces. She said Comr. Perkins stands for her community, even when she stands alone.

Comr. Perkins said she received quite a few complaints from the seniors at the Center. She said she plans to discuss the feedback with the City Manager this week.

Tundra King, 124 NW 15th Street, Pompano Beach, expressed concern about the budget meeting occurring at 10:00 a.m. when many community members cannot attend. She said the meeting was not televised nor in the Chamber, and thought it was unfair to plan a meeting in the morning when people work. She also expressed her dissatisfaction with 1:00 p.m. City Commission meetings and requested the Commission to review the meeting start times, so they can be more accessible to the public. Lastly, she noted the crime in the Northwest community is not being addressed.

Jocelyn Jackson, Pompano Beach, said she is excited for new development.

David Hall, 290 SE 8th Court, Pompano Beach, said he is excited about the Pompano Beach Municipal Golf Course improvements. He spoke about the West Palm Beach municipal course. He said they should not

just raise the membership fee for minors. He recommended offering them the opportunity to play on the Pines Course with reduced or free cart fee. He suggested additional options for non-Pompano Beach players and snowbirds.

Avi Goldfedder, 4948 NE 19th Avenue, Pompano Beach, said he has initiated a petition to save Pompano Beach and asked residents to submit their stories at pompanounityproject@gmail.com [<mailto:pompanounityproject@gmail.com>](mailto:pompanounityproject@gmail.com). He noted he had to skip a day of work to attend tonight's meeting to comment about the recent crimes in the community and stated that crime starts at the top. In closing, he expressed his support for the Guardian Angels recommendation.

Vicente Thrower, 1890 NW 6th Avenue, Pompano Beach, said they need to reevaluate whether to have 6:00 P.M. meetings because it conflicts with other meetings, including County meetings. He mentioned there was a homeless person sleeping on the bench outside the E. Pat Larkins Center when he visited today. He spoke about the responsibility of the Park Rangers, and asked whether they are going around to all facilities and parks to ensure there are no homeless on-site, particularly in the mornings.

Mayor Hardin said it is an operational issue and he agreed that people should not be sleeping on benches in front of the community centers. He added they cannot stop the homeless from utilizing resources in parks or facilities since they are open to the public.

Mr. Thrower said women should not feel threatened by situations with homeless people.

Pat Anderson, Pompano Beach, commented about former Building Official Miguel Nunez's employment with the city and a hearing that she alleged should have occurred between Mr. Nunez and City Manager Harrison. Also, she noted no one is talking about the smash at her property. She said she spoke about the matter at a recent Lighthouse Point City Commission meeting and she obtain a copy of the meeting, a copy of which was provided to City Clerk Alfred. She said the Lighthouse Point Commission do not know about the smash, the two cities that were involved or the redistricting.

Jemilah Jones, Vice President of Ashanti Cultural Arts, thanked everyone who supported their programs. She described the programs they offered, and number of Pompano Beach residents served. She said they are excited to be part of Pompano Beach and they are currently hiring. She distributed materials to the dais.

Matthew Higgs, 717 NW 8th Avenue, Pompano Beach, asked for help to guide the homeless in the City. He believes there is property where they can have a homeless shelter, so he urged the City Commission to help the people. He stated if they can find a location to install tents for the homeless, it should help lower the crime rate. He said they need to do something because it is affecting the beauty of the City, therefore he asked the City Commission to come up with a plan.

B. SPECIAL PRESENTATION

Representative Chip LaMarca acknowledged Senator Tina Polsky. He thanked city staff and the lobby team for their assistance this year.

Senator Polsky said they were honored to carry the appropriation and that the project made it in the budget.

Mayor Hardin thanked them for bringing home the funding to the local constituency.

City Manager Harrison confirmed the checks totaled \$950,000.

23-667 Update from the Broward County Supervisor of Elections Office

Mary Hall, Chief Deputy Supervisor for the Broward County Supervisor of Elections Office, thanked the City Commission for working as a partner with her office to ensure a permanent branch office at the E. Pat Larkins Center. She shared the operating hours and encouraged residents to visit for registration and assistance with all voting related matters. The Grand Opening will be held on August 14th.

Comr. Eaton asked if staff can confirm the glitches in the Contract were addressed, of which staff confirmed they were addressed.

Joe Ballard, 4821 NW 19th Street, Coconut Creek and 1861 NW 7th Terrace, Pompano Beach, asked to delay the approval of the Contract. In his review of the Contract, there were items he missed and he noticed it was drastically changed from prior contracts he had in the past. Also, he said there are items in the Contract that he believes are not favorable to his program and the children of Pompano Beach. Therefore, he desires to table the matter, so he can discuss the Contract further with city staff.

Mayor Hardin asked city staff if they had any concerns with the Applicant's request to table the item. Mark Beaudreau, Recreation Programs Admin, stated he has no objections with the request to table the item.

Comr. Perkins asked Mr. Ballard if tabling the item to the September 12th City Commission Meeting be enough time for him to meet with city staff to address his concerns. Mr. Ballard replied that date would work for him.

D. REGULAR AGENDA

23-686 Discussion regarding Sand and Spurs Stables.

Mayor Hardin reiterated the following earlier motion:

A motion was made by Mayor Hardin, seconded by Commissioner Fournier, for discussion to approve directing staff to go back to the original budget, as submitted by the City Manager, which included Sand and Spurs Stables.

Mayor Hardin said he brought forth the item due to the community outpouring.

City Manager Harrison suggested keeping all motions, except the Sand and Spurs Stables motion, from the budget workshop and to direct him to come up with the gap on this item. He noted a recent announcement a \$200,000 grant that could be used to offset costs.

An amended motion was made by Mayor Hardin, seconded by Commissioner Fournier, for discussion to approve directing staff to rescind the action that was taken on the Sand and Spurs Stables, and move forward with the Sand and Spurs Stables, as presented in the City Manager's budget.

Comr. Eaton asked for a list of other workshop motions for review. City Manager Harrison said he did not have the list but reiterated his suggestion about the Sand and Spurs item.

Comr. Eaton said she never wants to raise the millage rate for taxes and to keep the current millage rate, they needed to cut approximately \$900,000 from the budget. She suggested a compromise to wait a year for some projects, which could be funded by the increased ad valorem from upcoming developments. She provided examples of park amenities that could wait a year. She expressed concerns about defunding something that has been within the community for well over half century.

Mayor Hardin spoke about the difference between items funded through the Capital Improvement Plan (CIP) budget versus the annual operational budget.

Comr. Eaton said Comr. Fournier proposed to close Sand and Spurs Stables. She said she has been very upset, and the residents have experienced a week of anguish. She stated she voted no.

Vice Mayor McGee agreed with Comr. Eaton about delaying projects for a year. She said her goal is to lower the millage when budget talks occur. She wants to continue the discussion with Sand and Spurs Stables.

Comr. Fournier said it was a workshop to brainstorm ideas and she admitted the suggestion was a mistake. She appreciated the outpouring of support for the park, and she heard the feedback. She apologized for her suggestion. She noted if they fund Sand and Spurs, they need to support the facility with improvements. She

said part of the issue is the park has not been programmed and advertised. She also understands the history of the property more and wants to know more about the FAA's jurisdiction.

Comr. Moss said he also received copies of emails but none from residents in District 5. He said the City is subsidizing a facility with limited use by other residents. He said it is vulgar for the City to be subsidizing 20-30 individuals with their private horses. He suggested finding a way for the park to pay for itself, even partially, before he will support spending \$400,000.

Comr. Perkins thanked Ms. Charlotte Burrie for providing her with a history of Sand and Spurs. She suggested holding the budget meetings in the Chambers so the public can attend.

Comr. Eaton said the park does produce revenue and held several events in the past. She said part of the problem is the park falls under Public Works. She agreed they need to help the facility and make it more successful. She recommended having staff look into the possibility of moving it under Parks and Recreation.

Mayor Hardin said the FAA charges the City rent for the property. He noted it is designated aviation and not park land. He asked City Manager Harrison to send a letter to the FAA to explore the idea of the City purchasing the land.

Comr. Fournier acknowledged the advocates for the park. She agreed the park should be moved under Parks and Recreation, so it has the same support as the other parks. She stated there is a lack of public input at the budget meetings. She suggested an additional workshop going into the next budget cycle, to provide for public input.

Vice Mayor McGee agreed with the recommendation to move the park under Parks and Recreation, increase marketing efforts, and increase public events. She said there is a large funding discrepancy for the park and they need to try to close the gap.

Mayor Hardin provided clarification on the recent budget workshops. He said all their meetings are open. He acknowledged there was not much public participation. He noted they welcome public input.

City Attorney Berman added that the budget workshop was properly noticed and opened to the public.

Mayor Hardin opened public comment.

The following are the name of individual(s) who gave public comment:

Toni Lee Klemetsmo, 2951 NE 11th Avenue, Pompano Beach, provided history about the Sand and Spurs Stables. She said it is the heart and soul of Pompano Beach. She shared her personal experience with the "You Can Ride" equine therapy program and connection to the facility. She asked the City Commission to reconsider their decision.

Charlotte Burrie, 1100 NE 23rd Court, said Sand and Spurs is a public park and anyone can visit. She supports the recommendation to move the park under Parks and Recreation. She described programming the

park offers. She asked the City Commission to make the park better.

Fred Segal, 289 SE 4th Avenue, Pompano Beach, said the park is part of Pompano Beach's history. He said that horses in Broward County are increasing. He noted the stabling is generating revenue. He agreed the park should be overseen by Parks and Recreation. He spoke about the benefits of the equine therapy program. He noted on the Property Appraiser's website, it lists the City as the property owner. He recommended renegotiating the land lease.

Dawne Richards, 797 S. Riverside Dr., Pompano Beach, said it seems impossible to procedurally close a park at a budget meeting. She recommended an ordinance that states that closing a park needs to be properly noticed. She shared a personal story about Derby Day and the park. She posted a petition last night, which generated significant support.

Mike Grossman, 391 SE 14th Avenue, Pompano Beach, thanked Comr. Fournier for changing her opinion. He said the park has a marketing problem. He said if more people know about it, more people will use it. He said there is a demand for horse facilities. He thanked the City Commission for revisiting the issue.

Jerry Bowman, 717 NE 3rd St., Pompano Beach, said he has been on the Sand and Spurs board for 40 years. He said he was blindsided by the recommendation and was disappointed the park was placed under Public Works. He said the facility brings people to the City.

Joanne Nelson, 2250 NW 28th St., Fort Lauderdale, said she has been at Sand and Spurs for a year. She said the people who pass by their stalls are the nicest people. She noted the park makes people happy, even for people passing by. She agrees with the suggestions to increase park revenue.

Chava Chavous, 2600 NE 13th Terrace, Pompano Beach, shared personal stories about the Sand and Spurs park. She said the park is highly valued and would like to see the City enact a program to increase access. She noted autistic and down syndrome children would benefit greatly from the park. She asked the Commission to reconsider their decision to close the park.

Deborah Strelkow, 1501 E. Ocean Boulevard, Pompano Beach, said she has served in an advisory capacity as a landscape architect for the park. She noticed the park is located over the well fields, which restricts the use of the park. She stated there would be very few uses for the park to generate revenue. She also agreed with the recommendation to place the park under Parks and Recreation for improvements, and noted that horse shoes generate a lot of revenue.

Mayor Hardin clarified that the City pays rent to the FAA because it is used for non-aviation purposes. He said the motion from the workshop was to stop the non-aviation use.

Mike Skversky, 1630 SW 5th Avenue, Pompano Beach, said he is in support for Sand and Spurs and the pickleball courts. He suggested other items that could be cut from the budget. He suggested the City needs to send a letter to the people in Lyons Park and along McNab Road who have damage to their properties from the pipe being laid.

David Hall, 290 SE 8th Court, Pompano Beach, said there are things that can be done to activate parks and generate revenue. He said the impetus for the conversation came from taxes. He agreed there are other things that can be done to save citizens money. He suggested the City stop making large charitable contributions until the budget is balanced and the burden isn't put on taxpayers.

Jennifer Schiappa, 2558 Caramel Circle N., Coconut Creek, said she has a horse at Sand and Spurs and the facility does generate revenue. She thanked Comr. Eaton and Comr. Fournier for meeting with them at Sand and Spurs. She spoke about the park's history, community, and the benefit of horses. She invited the City Commission and staff to visit. She asked them to reconsider their decision.

Steven Lanpropoulos, 425 SW 10th St., Pompano Beach, is an international horse show judge and said there are ways to make the park profitable. He left his contact information and offered his time to discuss ways to generate income.

Anne Ward, 1280 SW 4th Terrace, Pompano Beach, addressed Comr. Moss. She discussed the benefits of the park for non-boarders. She agreed there are ways to make money, but the facility needs to be improved.

Chuck Muvabito (no address provided) shared a personal story about Sand and Spurs and described the 1987 horse show he created. He agreed to move the park under Parks and Recreation. He noted the large mud hole at the entrance to the park.

Rhonda McNeil, 2720 NE 6th St., Pompano Beach, said she is a former member of the Sand and Spurs Advisory Board. She volunteered her time to create solutions, including marketing.

Don McNeil, 2720 NE 6th St., Pompano Beach, said the issue is the City does not own the property. He acknowledged it will cost significant money to purchase the land. He noted it has the potential to draw \$400,000-\$500,000 per year. Also, he emphasized they need to increase marketing efforts.

Mary Ellen Sencer, 2184 Appaloosa Trail, Wellington, said she was on the Sand and Spurs Advisory Board for many years. She noted there are opportunities to better market in Wellington.

Amy Varo-Haub, 410 NE 5th Avenue, Pompano Beach, moved to the City because of Sand and Spurs. She said the park is frequented because of its uniqueness. She noted she is a newly appointed Alternate Member of the Sand and Spurs Advisory Board and would be happy to be involved in brainstorming solutions.

Marcia Kehl, 732 NE 7th St., Pompano Beach, shared history about Sand and Spurs. She noted she is the Sand and Spurs Advisory Board Chair and said they can work together to cut the budget. She said the park needs to be renovated and suggested there are areas of the budget that can be cut.

Zoey Varo-Haub, 410 NE 5th Avenue, Pompano Beach, said they would be losing an important part of history.

Pat Rowley, 610 NE 3rd St., Pompano Beach, noted before Sand and Spurs it was another stable.

Jocelyn Jackson, Pompano Beach, congratulated the residents who showed up to speak out about the park. She would love to visit the park. She appreciated Comr. Fournier's accountability.

Dennis Bandcroff, 601 Pine Drive, Pompano Beach, said he was curious about the use of the park, which is why he came to the meeting tonight. He said the worst thing he heard was to get rid of pickleball courts to fund Sand and Spurs. He thanked Comr. Fournier for reconsidering her position.

Tundra King, 124 NW 15th St., Pompano Beach, said the Northwest community is important as well and things have not changed. She said they have the same love and passion. She briefly commented on what she believes to be discrimination and stated she wants to be safe in her community. She asked the City Manager to find the same funding to support the Northwest community.

Comr. Perkins thanked Ms. King for her comments.

David Miller, Pompano Beach, said he did not know that Sand and Spurs was open to the public for horse rides. He noted that it was a good, informative meeting.

Lisa Nothardt, 129 SW 3rd St., Pompano Beach, thanked Comr. Eaton for standing up for them. She shared her personal experience at Sand and Spurs. She agreed that the park should be moved under Parks and Recreation Department, but suggested the programs should be run by someone educated in equestrian.

Zach Chappie, 1280 SW 4th Terrace, Pompano Beach, spoke about the FAA lease. He said they need to have it resurveyed as the City is overpaying. He said the City has been tearing down stables instead of fixing them, therefore he suggested the City increase revenue to address the improvements.

Mayor Hardin closed public input and invited further Commission discussion on the motion.

Vice Mayor McGee requested if staff can set a meeting or workshop in September or early October with the Sand and Spurs Advisory Board to brainstorm ideas.

Mayor Hardin confirmed they meet monthly. Also, he believes the meetings are properly noticed according to law, but cautioned the commissioners to consider Sunshine Law if they plan to attend. Furthermore, he cautioned them not to give suggestions to the Advisory Board on how to advise the Commission.

City Attorney Berman mentioned it would be noticed if more than one Commissioner attends.

Mayor Hardin asked the City Clerk if the advisory board meetings are noticed by his office or someone else, to which he replied that the Public Works Department post the notices for the board in question. However, he offered to post the notices as well to ensure commissioners are sufficiently covered.

Vice Mayor McGee added that with proper notice, members of the advisory board and stall owners will be made aware of the meeting to provide input. Also, by posting the notice, the Commission will be sufficiently covered.

Comr. Eaton said it is frustrating when another Commissioner calls a meeting in her district, and she cannot attend.

Mayor Hardin stated if the advisory board meeting is properly noticed anyone who wishes to attend can attend.

Mayor Hardin reiterated the motion and stated that the actions taken by the City Manager and staff will be presented before the Commission at the budget hearings. Overall, the motion is essentially to keep Sand and Spurs Stables in the budget.

Comr. Fournier said one item that came up with discussion of the stall owners was the condition of the arena. She noted there was a \$100,000 line item in the CIP, but it disappeared in 2021. It was to repair the equestrian arena in 2025.

City Manager Harrison said he recollects the removal of the amount from the CIP was due to the fact the Public Works Director offered to take care of it through his department.

A motion was made by Commissioner Fournier, seconded by Commissioner Perkins, to create a new CIP item for repairs of the Sands and Spurs Stables equestrian arena/ring in FY 2025.

She said the Advisory Board has been pushing the issue for years. She noted the watering system is not appropriate for an arena of that size and no one is around to drain the arena over the weekends.

Lisa Nothardt, 129 SW 3rd St., Pompano Beach, said the footing needs to be changed. She reiterated the need for an equestrian professional.

Deborah Strelkow, 1501 E. Ocean Boulevard, Pompano Beach, said proper draining is necessary.

Mayor Hardin closed public input and invited further Commission discussion on the motion.

Comr. Eaton expressed concern about next steps. She would commit to fund arena improvement but suggested they should wait until they have a better idea to approach and fund the project.

Vice Mayor McGee suggested stable management first meet with City staff before they allot CIP funding. She also stated they should explore the opportunity to purchase the land from the FAA before funding massive improvement.

Mayor Hardin agreed with Vice Mayor McGee.

Comr. Eaton said she would be willing to make a motion that specifies \$100,000 for Sand and Spurs improvements.

Comr. Moss appreciated the turnout but believes the general public would likely not support the item. He said it is an enormous waste of the money the benefits very few of the total Pompano Beach population. He does not support putting \$100,000 back in the CIP when they do not know what needs to be done.

Comr. Fournier clarified she is not asking for a new item in the CIP. She reiterated it was previously in the budget. She stated the amount is for a future year.

City Manager Harrison said they already have a purchase order out for the sand.

Erjeta Diamanti, Budget Director, presented the item and stated that the purpose of the Fire Assessment Program is to provide a dedicated source of funding for fire operations, however, EMS and Ocean Rescue are not eligible. The City recently hired a consultant, Government Services Group, to conduct a rate study regarding the existing rates used to assess revenues in the city. There are four different rates: Residential, Commercial, Industrial Warehouse and Institutional. The consultant's report was included in the Commission's backup and the recommendation and the findings of the report advised to adjust the rates and all the rates were adjusted accordingly.

Continuing, Ms. Diamanti said it is staff's recommendation to adjust the residential rate to \$331, which is an \$81 increase. In this case, all the other rates will be adjusted accordingly based on this adjustment. The proposed rates will assess approximately \$3.7 million in addition to last year's adopted revenues, and the total revenues will cover approximately 88% of the eligible fire operations services for Fiscal Year 2024. This is the first hearing to approve the Resolution, and the final hearing is scheduled on the same day of the Budget Hearing, that is, September 13th at 5:15 p.m.

Lastly, Ms. Diamanti reiterated that the proposed residential rate is set at \$331 and the other non-residential rates are set based on the square footage. She then provided the rate for each of the 4 categories and noted that the net revenues that will be collected in the General Fund is \$28.8 million. However, the Agenda Item provides the gross revenues before tax and exemptions, which are also referenced in the Resolution, which is approximately \$32.6 million.

Mayor Hardin opened the floor for public input. No one came forth to speak on the item. Therefore, the Mayor closed public input and invited further Commission discussion on the motion.

Comr. Fournier thanked city staff for the Consultant's report that was in the backup and for the discussion earlier today. She said public safety is the most important function of the city.
