The City's Parking system is supported 100% by parking revenues, inclusive of utilizing such revenues to pay debt service on outstanding debt. The City provides for over 1,800 public parking spaces throughout the City. Availability of parking is paramount to supporting the public and businesses in our community. Public parking supports the businesses on the barrier island and in harbor village primarily. Without adequate capacity of the parking system, Business, employees, residents and guests to the area will be negatively impacted and revenues generated to support the system would be in jeopardy. Parking Revenues not only support ongoing operations and maintenance of the system, but is also utilized to service outstanding debt. Failure to provide sufficient parking capacity within the system would be detrimental to businesses as it would constrain adequate supply or turnover of parking spaces.
