Dear Mr. Mohammed,

We have received a request from the City of Hollywood for a renewal of the above-mentioned contract. DuBois Chemicals has received significant price increase from our supplier for Fluorosilicic Acid, copy attached. Additionally, every segment of our transportation chain including rail freight, truck freight and transloading costs has increased, for example, when we calculated our cost for the new bid in December 2021 the fuel surcharge was 32%. Today the fuel surcharge is 43.5% and continues to rise. Attached is a copy of the current CPI-U. As you can see, the actual increase is 8.2%. However, the bid specifications noted costs for any extension terms shall be subject to an adjustment only if increases or decreases occur in the industry. Such adjustment shall be based on the latest yearly percentage increase in the All Urban Consumers Price Index (CPI-U) as published by the Bureau of Labor Statistics, U.S. Department of Labor and shall not exceed five percent (5%) and our price increase requests below reflect only a 5% maximum increase.
