A. Introduction

The City of Pompano Beach is commissioning Taylor Smith (ARTIST) for the design and installation of a painted mural that will be located on third, fourth, and fifth levels of the southeast stairwell exterior wall located at the Pompano Beach Pier Parking Garage next to the Pompano Beach Tourism Center, 3460 NE 3rd St, Pompano Beach, FL 33062. The mural is an expansion of the previously installed mural by the ARTIST entitled *Reef Life*.

B. Objective

To continue to beautify and enhance the City of Pompano Beach and expand on the mural *Reef Life*.

C. Scope of Work

Artist shall coordinate with the City's Contract Administrator on specific dates and times prior to installing the mural.

The City will power wash the wall location prior to the installation of the mural.

D. Summary Schedule

This Agreement is for six (6) months after full execution by both parties; however, the artist shall complete the installation of the artwork in thirty (30) days from the start date that will be established between the Contract Administrator and the Artist via e-mail once the Agreement is fully executed by both parties.

E. Inspections by the City

The CITY's Contract Administrator shall inspect the fabrication and installation of the Artwork at the four completion phases described below to ensure compliance with the Design Proposal approved by the City Commission.

1st Inspection - Artwork installation is 10% complete 2nd Inspection - Artwork installation is 25% complete 3rd Inspection - Artwork installation is 50% complete 4th Inspection - Artwork installation is 75% complete 5th Inspection - Artwork installation is 100% complete

ARTIST shall notify the CITY's Contract Administrator in writing when each of the completion phases has been reached. ARTIST understands and agrees that the CITY's Contract Administrator has sole discretion to determine whether ARTIST has reached the requisite completion phase.

F. Compensation

For and in consideration of the mutual covenants and obligations herein as well as other good and valuable consideration received, ARTIST agrees to provide the Work required hereunder for CITY and CITY agrees to pay ARTIST a maximum not-to-exceed total amount of Thirty-eight Thousand Dollars (\$38,000.00) payable as follows:

- 1. Invoice #1 for \$5,500.00 payable within fourteen (14) business days after this Agreement is fully executed by both parties;
- 2. Invoice #2 for \$11,000.00 payable within fourteen (14) business days after the start date has been established between the Contract Administrator and the Artist via e-mail; and,
- 3. Invoice #3 for \$21,500.00 payable within fourteen (14) business days after City's Final Acceptance of the Artwork, receipt of a proper invoice for the Work, satisfactory completion of the Catalogue Form and Copyright Assignment attached hereto as Exhibits 3 and 4 respectively, and professional video and photos of artwork installation and completed artwork.
