**WHEREAS**, the parties entered into an agreement for merchant card payment services  
on March 17, 2014, ("Original Agreement"), and approved by City Ordinance No. 2014-25; and

**WHEREAS**, the CITY and the PROVIDER have mutually agreed to extend the Original  
Agreement for one (1) additional five (5) year period.

### **WITNESSETH:**

**IN CONSIDERATION** of the mutual terms, conditions, promises, covenants and  
payments herein set forth CITY and PROVIDER agree as follows:

1. Each “WHEREAS” clause set forth above is true and correct and herein  
incorporated by this reference.

2. The original Agreement effective March 17, 2014, a copy of which is attached hereto and made a part hereof as Exhibit "A", shall remain in full force and effect except as specifically amended hereinbelow.

3. The parties hereto agree to extend the Original Agreement for one (1) additional five (5) year period, ending March 16, 2024.

4. This Agreement shall bind the parties and their respective executors, administrators, successors and assign and shall be fully effective as though the extension had been originally included in the Agreement.

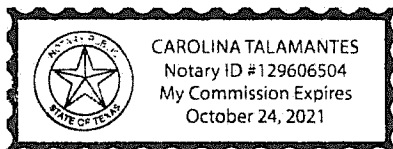
