A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, APPROVING AND RATIFYING THE CITY MANAGER'S EXECUTION OF AN AIRPORT IMPROVEMENT PROGRAM GRANT AGREEMENT BETWEEN THE CITY OF POMPANO **BEACH AND** THE **FEDERAL AVIATION** ADMINISTRATION, ACCEPTING A GRANT FOR THE **CONSTRUCTION OF RUNWAY 10-28 REHABILITATION** WITH A CORRECTION TO THE **EXPANSE OF PAVEMENT RUNWAY** \mathbf{ON} THE **10** END; CONFIRMING THE CITY'S MATCHING CONTRIBUTION IN AN AMOUNT OF \$136,182.00; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Pompano Beach has been awarded a Grant from the Federal Aviation Administration (FAA) for the construction of Runway 10-28 rehabilitation with a correction to the expanse of the pavement on the Run-Way 10 end for the Pompano Beach Air Park; and

WHEREAS, the City of Pompano Beach will match 2.5% of the total project cost of \$5,447,263.00 in the amount of \$136,182.00; and

WHEREAS, the Federal Aviation will cover the remaining 95% in the total amount of \$5,174,899.00; and

WHEREAS, it is the desire of the City of Pompano Beach, Florida, to formally accept the Grant; now, therefore,

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. That the action of the City Manager in executing the Grant Agreement between the City of Pompano Beach and the Federal Aviation Administration (FAA), accepting a grant in the amount of \$5,174,899.00 for the construction of Runway 10-28 rehabilitation with a correction to the expanse of pavement on the Run-Way 10 end for the Pompano Beach Air Park; and confirming the City's matching contribution of \$136,182.00, a copy of which Agreement is attached hereto and incorporated by reference as if set forth in full, is hereby approved and ratified.
