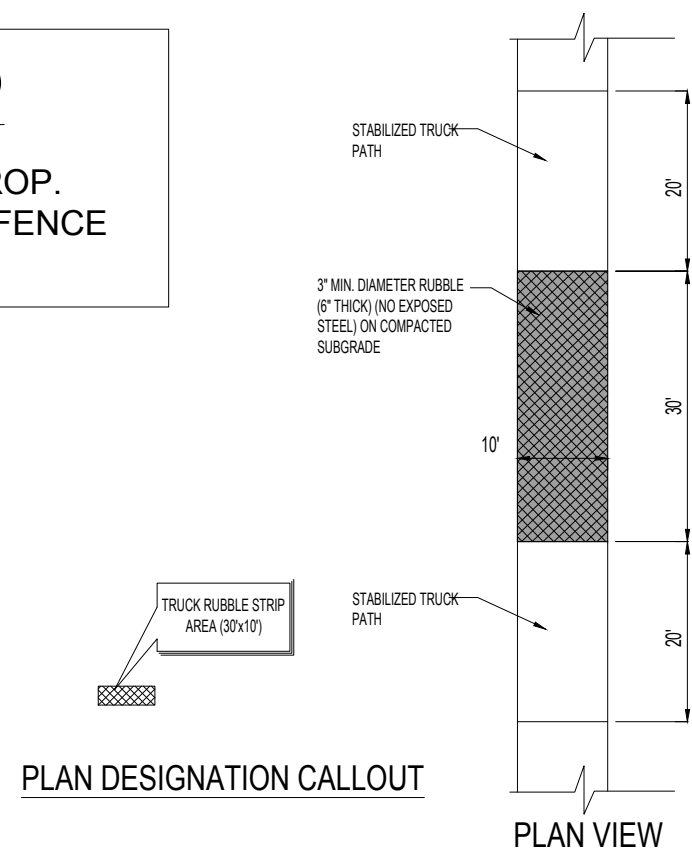
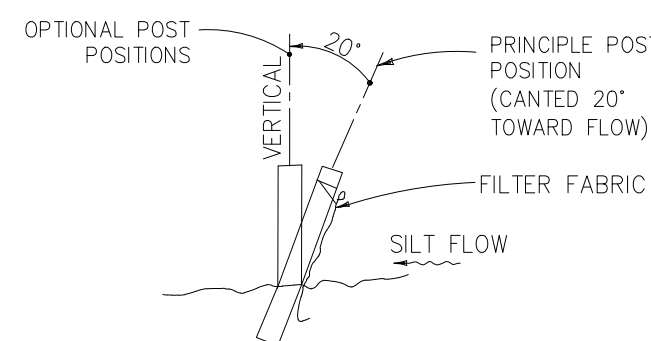


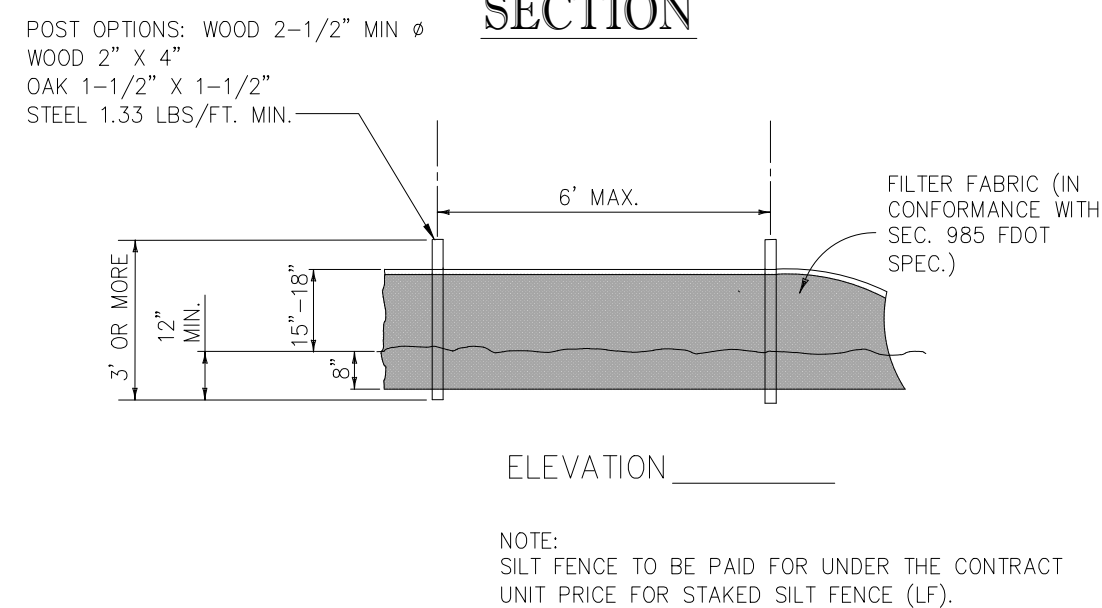

SILT FENCE DETAIL

1. CONTRACTOR SHALL IMPLEMENT THE STORMWATER POLLUTION PREVENT PLAN (SWPPP) PRIOR TO STARTING CONSTRUCTION THAT INVOLVES ANY SOIL DISTURBING ACTIVITIES (INCLUDING SITE GRADING, TREE REMOVALS AND DEMOLITION).
2. THE SWPPP PLAN SHALL GENERALLY EMPLOY THE BEST MANAGEMENT PRACTICES AND FOLLOW THE BASIC PLAN COMPONENTS IDENTIFIED IN THE FDEP'S "FLORIDA STORMWATER EROSION AND SEDIMENT CONTROL INSPECTORS MANUAL."
3. THE CONTRACTOR WILL BE RESPONSIBLE FOR PROVIDING WEEKLY REPORTS TO THE CITY'S INSPECTOR AND UPDATING THE SWPPP AS NEEDED. DIRECTED, THE CONTRACTOR SHALL BE RESPONSIBLE FOR PROVIDING A SWPPP ACCEPTABLE TO THE COUNTY REGARDLESS OF FDEP'S REQUIREMENTS FOR A GENERIC PERMIT.

NOTES:

- 1.) SILT FENCE TO BE CONSTRUCTED WHEREVER OFFSITE AREAS ARE LOWER THAN ADJACENT ONSITE ELEVATIONS.
- 2.) CATCH BASIN FABRIC TO BE PLACED ON AREA INLETS SUBJECT TO SEDIMENTATION FROM THIS PROJECT.
- 3.) ALL EROSION CONTROL DEVICES SUCH AS RUBBLE STRIPS, SILT FENCE AND OTHER BMPs SHALL BE INSTALLED PRIOR TO CONSTRUCTION.
