Hello Karen – yes I am ok with the match coming from the tree canopy trust fund. The tree canopy fund is accounted for in Fund 112, the special purpose fund. We do not actually charge expds. directly to that fund, but instead you can transfer the needed match form fund 112 to the Fund where the expds for the project would be charged. A BA would be need to increase the transfer out account in Fund 112 (i.e. transfer to fund 302) and increase the fund balance account in fund 112 (001-0000-392-1000). Commission approval would be needed unless you initial agenda item to the commission to submit the grant application to the state indicated that the match would come from the tree canopy trust fund (112).
