Note: Attachment relates to Item (j) on the Schedule of Projected Revenues and Debt Coverage (Part V)

Projected Fiscal Year 2017 revenues and expenses (adjusted to remove non-cash items such as depreciation, pension adjustments, compensated absences adjustments and OPEB expense adjustments) are based on the City of Pompano Beach proposed budget for the Stormwater Fund.

Projected Fiscal Year 2018 through Fiscal Year 2021 Stormwater revenues have been adjusted by 3% for each year to coincide with tiered Stormwater Fee increases already authorized by the City Commission through 2023 (see attached). Projected expenses for the same period is shown as increasing at a conservative 2%, despite the trend from fiscal year 2010 through fiscal year 2015 showing an average decrease of 1.6%.

§ 53.12 STORMWATER FEES.
