
Andrew Tamlin called the Meeting to order and proposed the following resolution:

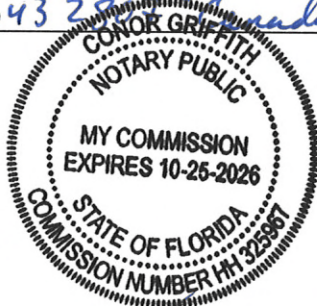


