C. AUDIENCE TO BE HEARD

Mayor Fisher announced that it was time for "Audience To Be Heard" and offered the following guidelines: Once your name is called, please come forward to the podium in front of the commission, state your name and address for the record. Speakers will be limited to three minutes to speak on any item of concern or interest, including those items pulled from the Consent Agenda. In addition, he asked speakers not to speak on any items on tonight's agenda, as they will have that opportunity to do so when that item comes forward. Lastly, he requested that speakers refrain from any emotional outbursts in either support or non-support of the speaker's comments.

Tom Terwilliger, 3160 NW 1st Avenue, Pompano Beach, was called to speak. Mr. Terwilliger indicated that the Commission has the ability to hire and fire only four employees in the City to include the City Manager, Attorney, Clerk, and Internal Auditor and questioned why the Auditor is not in attendance at the regular meetings to provide a financial report on the affairs of the City.

Comr. Dockswell along with Mayor Fisher, and Comr. Hardin indicated that reports are provided by the Internal Auditor to the Commission at its regular meetings on a quarterly basis.

Joanne Grealy Richter, Special Projects Manager, Broward Regional Health Planning Council, Inc. 200 Oakwood Lane, #100, Hollywood, FL, was called to speak. Ms. Richter thanked the Commission for its allocation of the matching funds for Child Care Services for the children in Pompano Beach. She then described the services they provide to the children.

Beverly Perkins, 1516 NW 6th Avenue, Pompano Beach, was called to speak. Ms. Perkins noted that on September 9, 2016, Mr. Gregory Frazier was killed in the City of Pompano Beach. She stated that the residents understand there is an investigation going on; however, the community needs an update as to the Commission's plan. She suggested that while waiting for the results of the investigation, something should be put into place to avoid a repeat of similar incident and to assure the community that the Commission cares.

Elizabeth R. Massey, 540 NW 18th Street, Pompano Beach, was called to speak. Ms. Massey spoke about the issues of the Sober Homes. She thanked Vice Mayor Burrie for providing her a "crash course on Sober Homes and all the problems that surround it." Nevertheless, she along with her fellow neighbors are concerned because they are continuously inundated with these homes "popping up" around the neighborhoods, which does not make for the good of the neighborhood or the residents that the Sober Homes need to serve. Therefore, she urged everyone to become vigilant, watch, and lobby for whatever changes that need to be put in place.

Mayor Fisher assured Ms. Massey that the Commission is vigilant and are

staying on top of what can be done to stop the proliferation of Sober Homes. In fact, they are working as a team with Congresswoman Lois Frankel. Notwithstanding, it is a federal law that protects the ADA Act. Therefore, Congresswoman Frankel is working as a non-partisan and she is making great headway in working with HUD to provide local opportunities for the City to be able to regulate these Homes. Therefore, he encouraged the residents to write to Congresswoman Frankel about their experiences, which will assist her in her endeavors.

Comr. Phillips thanked the residents for their emails on the matter, and said he has forwarded the emails/texts to the City Manager and the Assistant City Manager who are investigating the legalities of those particular homes. Comr. Phillips indicated that there may be some solutions to the problem, which he outlined, but the City needs to be a bit more forthright and assertive/aggressive.

Vice Mayor Burrie explained how the process works with the foreclosed homes. She indicated that investors are normally ahead of the acquisition list and are able to offer higher dollars for these homes to become Sober Homes versus the City acquiring them to avoid the Sober Homes status. In fact, there are 150 Sober Homes just between the Highlands and Cresthaven neighborhoods, so the list continues to be enormous for the City of Pompano Beach. In fact, these Homes are advertised on social media for people to come to Pompano Beach for the fun, sun, and Sober Homes, which is not assisting the addicts desiring to be rehabilitating, or the neighborhoods.

Mayor Fisher explained how these investors are able to pay any price necessary to get those homes and turn them over to become Sober Homes. Nevertheless, he urged the residents to continue to be vigilant and provide the information by calling or writing to the City, which will assist with documenting the negative impacts these homes are having on the neighborhoods.

Comr. Phillips encouraged the residents to get as much of their complaints to all levels of the government to include the state, and congressional representatives who represent the City of Pompano Beach.

Vicente Thrower, 1890 NW 6th Avenue, Pompano Beach, was called to speak. Mr. Thrower asked who is responsible for the wrapping of the City's utility boxes and the decision to use the various types of wrappers.

Mayor Fisher responded that the Commission passed an item for the wrapping

of the boxes with specific artwork for specific boxes.

Mr. Thrower expressed concern of the City promoting, through these wrappers, a certain individual who was not accommodating of certain types of people, specifically, Afro-Americans.

Robert A. McCaughan, Public Works Director, indicated that he is unsure about the wrapper Mr. Thrower was referring to was in fact portraying Mr. McDougald, and would check into the matter.

Comr. Phillips indicated that a number of people have expressed their concerns to him about being unable to identify whether or not the organization was actually assisting those children in the Pompano Beach schools. Therefore, Comr. Phillips suggested that if the organization has gone into a particular school in Pompano Beach, that a letter from the school's principal be provided to the City indicating that there has been some movement or success of their program and perhaps, the Education Advisory Committee could monitor the activity.

Comr. Phillips pulled the item for discussion. Comr. Phillips commended the City on working on some of the capital improvement projects. However, he asked for an update on the Ely Museum, to include how much money has been spent to date. He also recognized Dr. Catherine Gillis, who is head of the Committee for this venture in the community.

Horacio Danovich, CIP Manager, indicated that staff has been working on the Blanche Ely Museum scope. Additionally, the Development Services Director, Robin Bird provided him with a memo regarding the Blanche Ely Renovation Project - status report, which is attached as part of this item. Finally, Mr. Danovich provided a brief background on the project and where they are today in the process.

Comr. Phillips inquired about the amount of money being expended to date.

Mr. Danovich responded that \$452,000 was allocated for the project. However, he may not be able to answer the questions regarding the artifacts; however, staff has been considering the parking opportunities, the design, etcetera.

Robin A. Bird, Development Services Director indicated that Jennifer Lopez, Assistant Development Services Director has been championing the cause. Mr. Bird reported that all the artifacts are archived and is in self-storage and the car is located at the Public Works compound. Although everything has been accounted for, the difficulty with the museum is to make it ADA compliant, which is currently out for bidding. Additionally, there are some challenges with parking.

Comr. Phillips encouraged residents to contact Dr. Catherine Gillis and her committee because they are inside the community. Finally, Comr. Phillips appreciated the collaboration of the City and the committee and indicated that one of the hurdles being money is currently available.

Vicente Thrower, 1890 NW 6th Avenue, Pompano Beach, inquired if the cleaning of the pavers on MLK Boulevard is included in the Capital Improvement Project (CIP) budget.

Mayor Fisher indicated that this would be a maintenance issue, which would be the Public Works Department's responsibility.

Comr. Phillips requested more information on the following items in the CIP budget:

The \$4 million in the budget, he inquired if this amount was what the City received from Florida Department of Transportation (FDOT). Mr. Danovich replied yes, that is correct.

On Page 19 it states, "5.1. Begin implementation of corridor studies and plans for Federal Highway, Atlantic Boulevard, and Dixie Highway." He asked if a portion of the \$4 million, which was slated for Dixie Highway improvements only would be utilized for studies involving Atlantic Boulevard and Federal Highway.

Mr. Danovich responded that it is not for the studies. However, the purpose for the monies is allocated to allow for improvements of the roads as once EDSA, the agency that is doing the analysis for the City, returns with a plan work can then commence particularly from the intersection of Atlantic Boulevard and Dixie Highway. The monies are for FDOT roadways to include Federal Highway.

Comr. Phillips inquired whether any of the \$4 million is being used to conduct study for Federal Highway. Mr. Danovich responded no.

Dennis W. Beach, City Manager explained that the funds coming from FDOT on this particular project are for Dixie Highway, and anything in the CIP budget stating otherwise then the wording is incorrect.

Comr. Phillips indicated that within the CIP budget funds are being allocated for Fire Station 61. However, if the Penny Sales Tax initiative was approved, the City would not need to utilize CIP funds for the fire station.

Mr. Beach explained that a decision would have to be made by the Commission at that time, because this budget was being planned with the referendum not being successful. However, if the plan is successful, staff will bring back an item regarding this matter for the Commission's consideration.

Tom Terwilliger, 3160 NW 1st Avenue, Pompano Beach, referred to Page 8 and Page 68 of the CIP book where there is a designation, "Project Administration Fees" and inquired whether these are fees paid to City employees or outside contractors. Mr. Beach explained it is an allocation being used to pay City employees.

Robin M. Bird, Development Services Director, presented the item for discussion. He indicated that the Planning and Zoning Board recommended approval at their July 27, 2016 meeting. All the conditions have been addressed with the exception of Item F, which the applicant is prepared to address.

In sum, Mr. Bird indicated that the intent of the Planned Development is to encourage innovative land planning, site design concepts for high quality of life and achieve a high quality of development to advance the City's goals and objectives. The planning objective of this development include the objective for the RPUD to provide innovative residential mixed use development that meets the growing demands for housing and variety of economic levels and the demand for greater variety in tenure, type designs and siting of dwellings in a manner that achieves a more efficient use of land. Also, to offer residents convenience in location of accessory commercial and service areas, as well as marine opportunities, which are developed in Phase 1 of the proposed multi-family units constructed around the marina, which will serve as the central amenity for the project.

The aesthetic and architectural integrity, waterfront setting, and convenient location characterize the project. This request for amendment focuses on POD B in the master plan in the area. They will create 92 loft style units created on sheet PD-1 in Exhibit B labeled "Amendment to the Approved RPUD" All other items included specifically to this project in the RPUD are:

Increasing maximum building height from 55' to 85'

Increasing maximum building stories from 4 or 5 to 7

Increasing the number of buildings from 2 to 3

Increasing the maximum building size from 105,000 sq. ft. to 180,000 sq. ft.

Relocating the fitness trail along the east property line to be internalized

around the proposed three (3) buildings of POD B

The zoning of the surrounding uses will be to the north a transit oriented district, retail and offices; to the south the Pompano canal and single-family; to the east is multi-family RM-20, as well as B3 (General Business) its border is currently on vacant land and to the west is B3 (General Business) and multi-family offices.

Dodie Keith, Keith & Associates, 301 East Atlantic Boulevard, Pompano Beach, indicated that they are pleased to present this long awaited project, which has been properly vetted with the residents and staff of the City to work through the challenges and concerns. Therefore, she asked Mr. Longsworth to provide details of the project, which would be followed by a short presentation.

Christopher Longsworth, 1401 Southwest 54th Avenue, Plantation, FL, indicated they are at the end of the first phase, and will finalize construction over the next 30 days. He then explained what they were currently doing with Ethos. He noted that Koi was a risky project; however, the City Commission allowed him to move forward and it was successful. Therefore, Ethos is similar to the Koi project. They are trying to create a more modern environment with open space, loft style that is currently a big trend in the market. He hopes this will bring in more of the millennials and the younger buyers. There are quite a number of diversities to include three (3) different phases, which each phase will support a different type of demographics. As it relates to design, Ethos is the second phase of Koi. Notwithstanding, the entire project will be consistent with the development on Atlantic Boulevard of the Cultural Center, as well as other developments.

Mr. Longsworth is proposing to go up 30 feet higher in elevation in order to accommodate the loft style units. He then referred to the brochure he distributed earlier to the Commission. In addition, he presented the dichotomy between the first approved plan and the plan they are currently proposing. In sum, he indicated that areas are improved, and an amenity rich product has been established. There will be a movie theater, sculptured garden, summer kitchen, resorts, spa and pool, a fishing pier and so forth. They moved the tot lot to the Westside of the project; also, there will be a dog park.

Ms. Keith indicated that they are planning to bring both Phase 2 and 3 together for a faster construction timeline.

Comr. Hardin declared that he has had ex parte communication on the project over the years about Ethos and previously about Koi and the entire development. He asked if the amount of townhomes were reduced, to which Mr. Longsworth replied yes.

Comr. Hardin asked if there would be 92 or 91 units.

Mr. Longsworth replied it would be 91 as he had removed one unit to make it into a gym. In fact, he indicated that Ethos and the towers on Atlantic Boulevard will be going at the same time. If all the financial requests work out they plan to break ground on the apartments, which are luxury rentals and those will go up the same time as Ethos. They have planned to increase the open space as well.

Comr. Moss asked what would be the total amount of units when all the projects are completed.

Mr. Longsworth responded that they were approved at 350, but is now at 342. He explained that Ethos would be a condominium and a town of association. In essence, they created a master association that includes the marina, all the roads and infrastructure, then there is the townhouse association, and the condominium association for Ethos and the rental towers at the front, which are all part of the master association.

Comr. Moss asked if the condominium will govern itself, the HOA will govern itself and then there will be a master association that will handle all the common areas. He also asked for the price ranges.

Mr. Longsworth responded that the rentals would be approximately \$1.85 and \$2.10 per foot. The Ethos will be priced per foot to start at \$285 per foot and upwards. In sum, Mr. Longsworth indicated that the units would start around \$299,000.

In response to Comr. Moss' question on parking, Mr. Longsworth responded that with Koi as a master, they have exceeded parking and have 1.5 parking units per loft as requested by Planning & Zoning Board.

Comr. Phillips asked where the marina would be located.

Ms. Keith explained that they dug an area out to bring a marina into the project.

Mayor Fisher indicated that this is the first development that has occurred in the Old Pompano area for over 50 years. He thanked Mr. Longsworth for taking the chance and the dollars to get investors to come to Pompano Beach, which the City is appreciative. Finally, Mayor Fisher stated that the product is amazing.

Mr. Longsworth thanked the City for also believing in him and allowing him to move forward with his project and thanked the Commission and staff for their support.

Comr. Dockswell wanted to see the minutes from the Planning and Zoning Board, since the membership voted 4 to 3 on the project. He then asked if all the issues were resolved.

Ms. Keith responded that they worked with the residents a great deal and there was some confusion with the increase of the height of the towers. Nevertheless, Mr. Longsworth has made himself easily accessible and available to work through any concerns by the citizens, as the project moves forward.

Comr. Hardin indicated that many residents have communicated how pleased they are with the way the mangroves and the riprap rock turned out and thanked them for a signature project, which he is pleased to see.

Ms. Friedman responded that the language would have to be included in the condominium documents. The enforcement mechanism would be the condominium association itself.

Comr. Dockswell suggested that it should be called a Condo Hotel rather than an Apartment Hotel as stated in the Code.

Ms. Friedman explained that when the zoning code was rewritten in 2012 the consultants recommended the language at that time.

Robin M. Bird, Development Services Director explained that a condominium is a form of ownership and an apartment hotel could be any type of ownership to include condominiums. Therefore, he would prefer to check on the name to bring back additional information at the second reading.

Ms. Friedman then provided a brief history behind the term condominium hotel.

Meeting Reconvened

F. REPORTS

City Manager, Dennis W. Beach - Brownfield Project - Dennis W. Beach, City Manager read into the record the announcement of a Brownfield project. On October 25, 2016 staff will be bringing forward for the first of two public hearing, a request by Home Dynamics Vantage LLC to designate land at the location at the former Palm Aire Gulf Course, at the northeast corner of the intersection of the Florida Turnpike and west Atlantic Boulevard, Folio #484232190020 as a brownfield area pursuant to Section 376.802(c) of Florida Statutes, of Florida's Brownfield Redevelopment Act. The second public hearing would occur on November 8, 2016.

City Attorney, Mark E. Berman - Executive Session on October 16, 2016 - Mr. Berman announced that pursuant to Florida Statutes 286.011(8), the City of Pompano Beach and possibly the Community Redevelopment Agency (CRA) will hold an Attorney-Client Executive Session to be held on October 18, 2016 at 4:00 p.m. prior to the CRA meeting, in the City Commission Chamber Conference Room.

Mr. Berman stated that discussion would be concerning any litigation relating to settlement matters or strategy relating to Pompano Beach Community Redevelopment Agency, City of Pompano Beach et al., versus Florida State et al. and Broward County Case #14-009654(18) 17th Judicial Circuit. The session will be private and the anticipated City Commission members attending as well as the CRA Board members who are one of the same, Dennis Beach, City Manager, Mark Berman, City Attorney, Kim Breismiester and Chris Brown Executive Directors, Claudia McKenna CRA Attorney and outside counsel for the CRA Jamie Cole and Litigation Counsel Daniel Abbott. This notice will be posted and the Commission reminded of the meeting.

Special CRA Meeting - Mr. Berman indicated that they are planning to set a special CRA meeting for about five minutes this week to announce the Closed Door session of the CRA and Executive Session, which will be held on October 18, 2016. It was a consensus among the Commission that this meeting be held on Friday, October 14, 2016 at 10:00 a.m.

City Clerk, Asceleta Hammond - No Report

Comr. Barry Dockswell - Hurricane Matthew - Comr. Dockswell expressed thanks for “dodging the bullet” from hurricane Matthew. However, he indicated that a property owner in a sub division seems to be unwilling to trim his trees away from the powerlines. Subsequently, there have been a few power failures because of that. Comr. Dockswell questioned whether the City had the ability to add an ordinance to provide the opportunity to compel a property owner to trim trees away from powerlines, or could the City take action to trim the trees. A discussion ensued among the Commission on who is responsible to trim the trees away from the utility lines and

the safety factor involved to trim the trees.

Emergency parking in the Pier Garage - Comr. Dockswell indicated that people had asked him if they could park in the garage when a hurricane is imminent for those who do not have good parking and flooding is expected in the area. He said that he understands the liability issues involved as indicated by staff for not accommodating parking in the garage, but, if the issue could be tackled in advance then the City could come up with some solution even if it meant posting a notice to indicate a person is parking at his/her own risk. Nonetheless, he believes the problem should be tackled head on to decide what will be done in an emergency and how this would be handled.

Dennis W. Beach, City Manager responded that staff had researched the issue several months ago and sent the Commission a report on the recommendations regarding the matter. There were a number of reasons staff had gone with the recommendation not to permit parking to include the possible use of the garage for City vehicles, staging, and things of that nature. However, if the Commission desires to make the garage available for public parking under emergency circumstances then staff could design a method to accomplish it.

Comr. Dockswell indicated that he would prefer the option that indicates parking at "your own risk" type of accommodation.

Mayor Fisher suggested that City Manager Beach brings back information to the Commission, through a memo, for the Commission's consideration to make a determination at an upcoming meeting as to what direction to go with this issue.

Comr. Rex Hardin - Garbage Contract - Comr. Hardin suggested that perhaps staff may want to review the garbage contract because of everything that was changed in the new contract, because the four (4) cubic yards limitation is what really "sunken us." Therefore, he said without the limitations, at least 10% of the complaints would not have existed.

Mayor Fisher and Comr. Phillips agreed with Comr. Hardin's comments.

Vice Mayor Burrie indicated that it appears that most people decided to cut their trees the day prior to the hurricane. In her district, this was on a Tuesday but bulk is not picked up until Friday. So perhaps, the City may need to educate the people not to cut the trees down the day before a hurricane.

Comr. Barry Moss - No Report.

Comr. Ed Phillips - Upkeep of Trees at Canal Pointe - Comr. Phillips reported that residents from Canal Pointe has been complaining to him about the trees that have not been maintained. He said the trees are within the swale areas and there is a need to

determine who is responsible to maintain those trees. It was the consensus of the Commission that Robert McCaughan, Public Works Director would check into the matter.

Entry Way Signs - Comr. Phillips inquired about the signs for the Kendal Green neighborhood, as well as the Highland Heights off Northwest 21st and Atlantic Boulevard. He stated that the entryway signs are good for those neighborhoods that do not have a Homeowners' Association.

It was the consensus of the Commission to encourage the residents to formulate a Homeowners' Association to work on the signage for their neighborhood.

Mayor Fisher suggested that for informational purposes that staff provide a typical cost of a sign with perhaps the LEED program involved for future discussion among the Commission.

CRA Groundbreaking Project on MLK Boulevard - Comr. Phillips indicated that there will be a development landmark and a groundbreaking, which will take place on October 19, 2016. This will be a significant project in the Northwest CRA residential area, as well as it will be a \$20 million project.

Vice Mayor Burrie - No Report

Mayor Lamar Fisher - Sand Bags during Hurricane Preparation - Mayor Fisher indicated that there has been some discussion regarding sand bags. Since some cities are providing this to its residents, perhaps the City could look into the possibility of making sand bags available in the near future for emergency purposes.

Hurricane Emergency Preparation - Mayor Fisher congratulated and thanked Kimberly Spill on her leadership in preparing the City for the most recent threat of Hurricane Matthew. He commended her for her skills in preparing the department heads and the City for a natural disaster such as a hurricane.

Hoops for Cure Basketball Fund Raising - Mayor Fisher announced that on Wednesday, October 26, 2016 at 5:00 p.m. at the Blanche Ely High School Gymnasium, there will be a "Hoops for a Cure Basketball Challenge" and encouraged everyone to come out in support of this worthy event.
