Last night, on 08/20/2025 at around 11:30 PM, as I entered my neighborhood, I saw numerous police vehicles surrounding 2500 NE 19th St., with a man in handcuffs being placed into one of them. This raised serious concern for me and my boyfriend, as the incident appeared significant enough to require what looked like over 10 police vehicles to manage. Since the rezoning exception meeting is tonight at 6 PM, I request that this police report be obtained and added to the hearing record in support of denying the change. With multiple incidents at this address, I now feel unsafe in my own neighborhood. This is especially troubling since I grew up a few streets away and just bought my home about a year ago based on multiple recommendations about the neighborhood's improving safety.
