

## **REINSTATEMENT AND EXTENSION AGREEMENT**

**THIS IS A REINSTATEMENT AND EXTENSION TO THE AGREEMENT** dated the September 16, 2019, by and between:

**CITY OF POMPANO BEACH, FLORIDA** a municipal corporation of the State of Florida, 100 West Atlantic Boulevard, Pompano Beach, Florida 33060 ("CITY"),

and

**SZABOWORKS**, a California profit organization whose mailing address is 1433 Yosemite Avenue, San Francisco, California 94124 (hereinafter "ARTIST").

**WHEREAS**, the parties entered into an Agreement for Commissioned Artwork on September 16, 2019 ("Original Agreement") which was approved by Resolution No. 2019-256; and

**WHEREAS**, the Original Agreement was for a six (6) month term with one (1) possible six-month renewal; and

**WHEREAS**, a period of time greater than six-months has lapsed without renewal of the Original Agreement; however, CITY and ARTIST have continued to act pursuant to the terms of the expired Agreement; and

**WHEREAS**, the parties desire to reinstate and extend the term of the Original Agreement for an additional six-months to allow ARTIST to complete the services which ARTIST commenced for CITY.

**WITNESSETH**

1. Each “WHEREAS” clause set forth above is true and correct and incorporated by this reference.

2. That the Original Agreement between ARTIST and CITY to provide community engagement activities and create commissioned artwork, a copy of which is attached hereto and made a part hereof as Exhibit “A,” shall be reinstated and extended for a period of six (6) months ending September 15, 2020.

3. All the terms, covenants and conditions contained in the Agreement now existing between the CITY and ARTIST shall remain unchanged and the parties agree to keep, observe and perform all covenants and conditions contained therein.

4. This Agreement shall bind the parties and their respective executors, administrators, successors and assigns.
