**C. Staff Report**

**D. Evaluation:**

**Shortlist for 3 Artists**

1. **Alejandra Abad** - who also did a fish sculpture. Ms. Atria stated she only saw her 2D work and worries about her abilities to create what she is submitting with rebar.

2. **Mary Angers** – Committee immediately crossed her off the list.

3. **Didier Audrat** – Mr. Davis and Tobi Aycock stated they did not like it and asked for it to be crossed off the list.

4. **Annette Coleman** – Mr. Davis and Kelly Maguire both liked the piece. Mr. Davis stated it was interesting but doesn't show the piece from the Towers. Mike Scanzera stated the fact that it is made of glass he is afraid of it getting damaged or vandalized. Cross it off

5. **Michael Dickoff** – Michael Scanzera asked that it be left on for now. Ms. Aycock didn't hate it and thought it was popular because it had everybody's name on it. Keep.

6. **James Dinh** - Mr. Davis states it looks like a street address and it's boring. Laser cut and spend \$18,000 on it and only collect \$20,000. Cross it off.

Mr. Scanzera asked if the artist doesn't spend all the money does he get to keep it.

Ms. Atria stated yes, that is how these projects work, it's the artist fee. They will budget in their fee for the remainder of it.

Kelly Maguire states it's not just the project it is their expertise as well.

**12-14. Zachary Knudson** - Glass Artist. (3 pieces) - Mr. Scanzera he liked Concept 2 and have the center piece illuminated brighter. Mr. Scanzera asked if the glass could withstand the hurricane winds. The Committee preferred the second concept. Mr. Davis thought the piece did not look artistic enough and he does not say how he is going to etch it. Ms. Aycock stated it is illuminated at night. Keep.

**15. Scape Martinez** – Mr. Davis loved the piece and made the top of his 3 and has seen his work other places. Mr. Davis stated this is the one that showcases the piece from the towers and he turned the base into a piece of art. However, he did not state the size of it in his proposal. Mr. Scanzera likes it because it is simple but has the message. Keep

**16. Cherie Saleeby** – Mr. Scanzera liked the sculpture and wanted to keep it. Mr. Davis stated if you print it on mylar it is easy to work with. Mr. Davis did not want to vote on her because she was a friend. Mr. Davis stated it was not one of his all-time favorites. Ms. Atria was concerned she would be able to etch all of the words in the glass. Keep.

**18-19. Mark Wesbeck** – (2) Ms. Atria stated the piece would be inside the bottom and is hidden. Mr. Scanzera doesn't like the height of the sculpture as they are 18' tall. Mr. Davis stated he does not like it and it reminds him of the towers and they are inflamed and brings back very bad memories. Ms. Davis stated the second one has some hope in it. Cross it out.
