### CITY OF POMPANO BEACH Broward County, Florida

AN ORDINANCE ABANDONING CERTAIN RIGHTS OF WAY UTILITY EASEMENTS IN THE VICINITY OF WADE AND HORN PARK, SECTION 33, TOWNSHIP 48 SOUTH, 42 BROWARD COUNTY, FLORIDA; RANGE EAST, FOR SEVERABILITY; PROVIDING PROVIDING EFFECTIVE DATE.

WHEREAS, pursuant to law, fifteen (15) days' notice has been given by publication in a paper of general circulation in the City notifying the public of this proposed Ordinance and of a public hearing in the Commission Meeting Room of the City of Pompano Beach. Florida; and

WHEREAS, a public hearing before the City Commission was held, pursuant to the published notice described above, at which hearing the parties in interest and all other citizens so desiring had an opportunity to be and were in fact heard; and

WHEREAS, the City Commission has received a request for the abandonment of certain rights-of-way and utility easements.

WHEREAS, the Planning and Zoning Board has made its recommendation upon said request; now, therefore

BE IT ENACTED BY THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1: It is hereby found and determined by the City Commission that the public health, welfare, safety and necessity no longer requires retention of an interest by the public in those certain rights-of-way and utility easements particularly described below.

SECTION 2: It is hereby further found and determined that abandonment and vacation of said rights-of-way and utility easements will not have a detrimental effect to the surrounding property or area.

SECTION 3: That the City of Pompano Beach does hereby abandon and vacate the following described rights-of-way and utility easements, to wit:

That certain Utility Easement described in Exhibit "A".

That certain Utility Easement described in Exhibit "B".

That certain portion of the right of way for N.W. 11th Street described in Exhibit "C".

That certain portion of the right of way for N.W. 9th Court described in Exhibit "D".

That certain portion of the right of way for N.W. 28th Avenue described in Exhibit "E".

All of which Exhibits are attached hereto and incorporated herein by reference as if set forth in full.

SECTION 4: That the City Clerk is hereby instructed to record this Ordinance in the public records of Broward County, Florida.

SECTION 5: If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.
