DEDICATION OF SEWER EASEMENT

THIS INDENTURE, Made and entered into this 29th day of June, A. D. 1966, by H. S. CHESHIRE and GEORGIA E. CHESHIRE, his wife, a partnership, hereinafter called "Owners", who are the owners of the real property hereinafter described.

WITNESSETH as follows:

WHEREAS, the Owners maintain and operate Cheshire's North Federal Building situate on the following described property:

The S 1/2 of Lot 3 and Lots 6, 7, 10, 11, 14, 15, and 18 in Block 5 of PINEHURST, according to the Plat thereof recorded in Plat Book 5, page 13 of the Public Records of Broward County, Florida.

and

WHEREAS, the Owners also own Lot 17 in Block 5 of PINEHURST, according to the Plat thereof recorded in Plat Book 5, page 13 of the Public Records of Broward County, Florida; and

WHEREAS, the Owners desire to provide an easement over the South three (3) feet of Lot 17 in Block 5 of PINEHURST aforesaid for the purpose of connecting the Cheshire's North Federal Building for sewer service to City sewer lines situate on Northeast 22nd Avenue; and

WHEREAS, the City of Pompano Beach, Florida, has required, in order to connect with said sewer facilities, that an easement be granted over the said South three (3)

NOW THEREFORE, the Owners hereby give, grant and dedicate an easement over and across the South three (3) feet of Lot 17 in Block 5 of PINEHURST aforesaid for the purpose of laying, maintaining, operating, repairing and renewing sewage lines or connections and appurtenances thereto for the purpose of serving the Cheshire's North Federal Building.

This easement is granted pursuant to the provisions of Section 4605.1 of the Pompano Beach Building Code as existing on the date hereof.

This Dedication of Sewer Easement may be terminated at any time by the Owners if sewer connections are obtained by them in any other fashion for the Cheshire's North Federal Building.

This easement conveys no ownership or title to the City of Pompano Beach of any structures or facilities constructed therein or thereon, nor does it result in any obligation on the part of the City to maintain or repair any such structures or facilities constructed within its boundaries.
