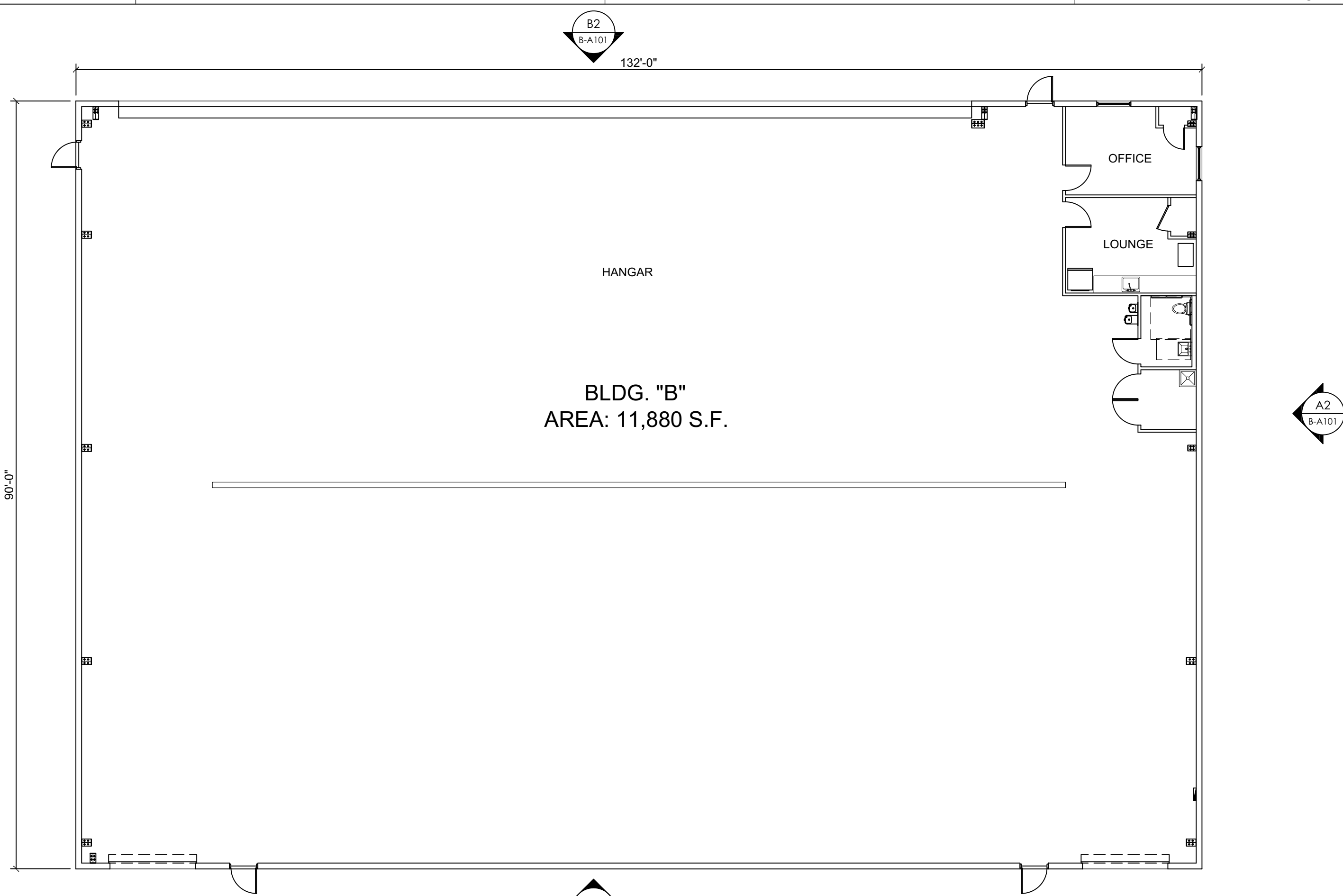

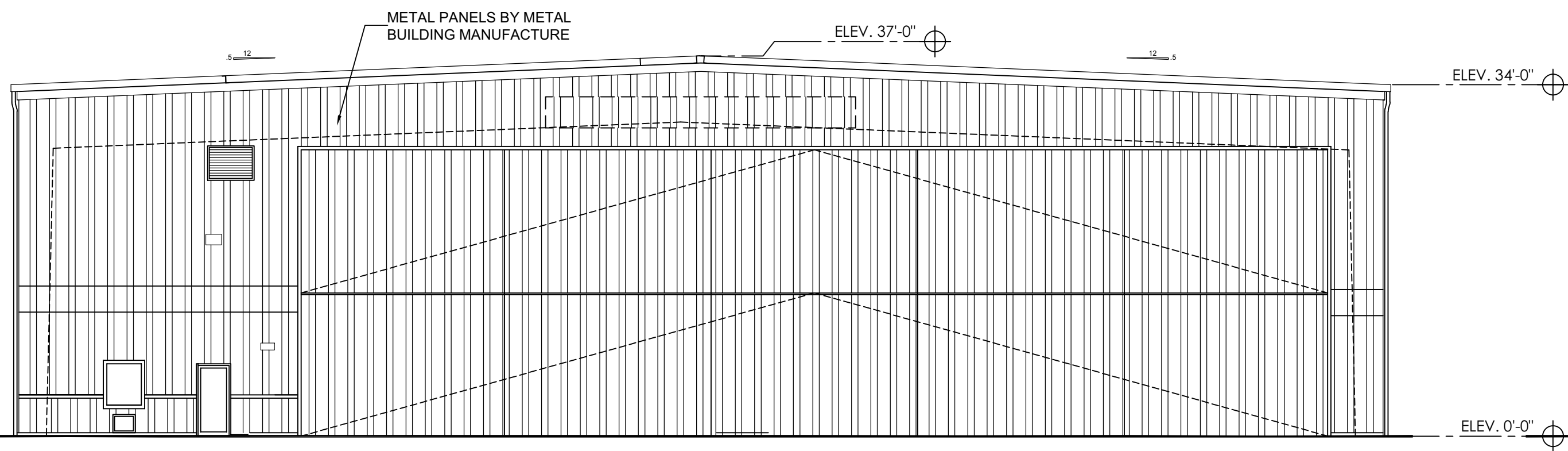

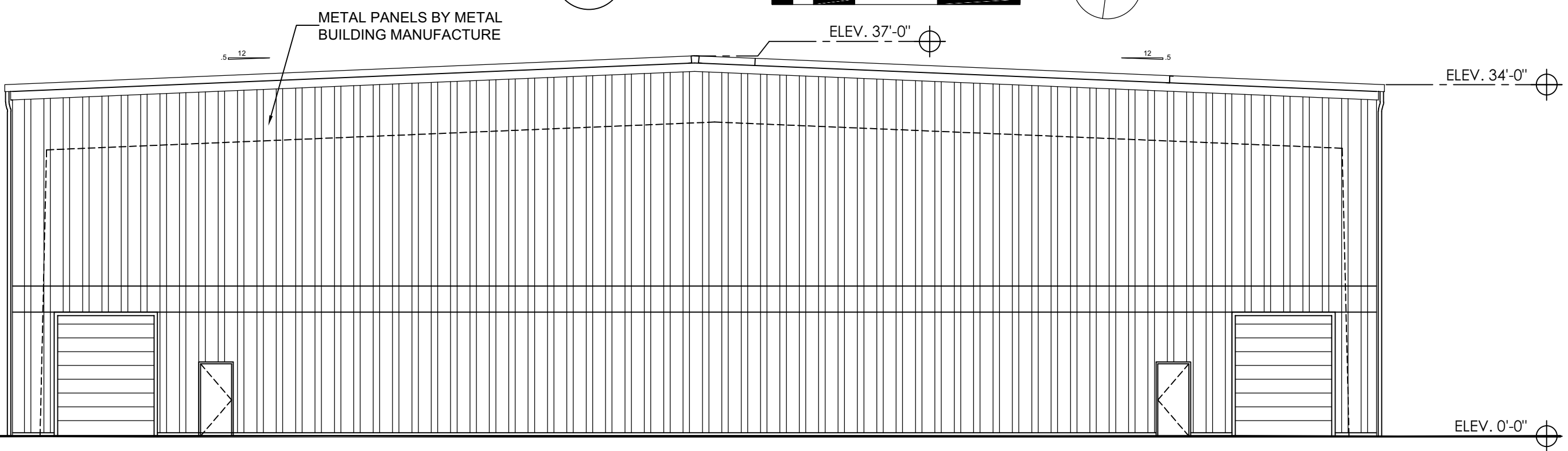

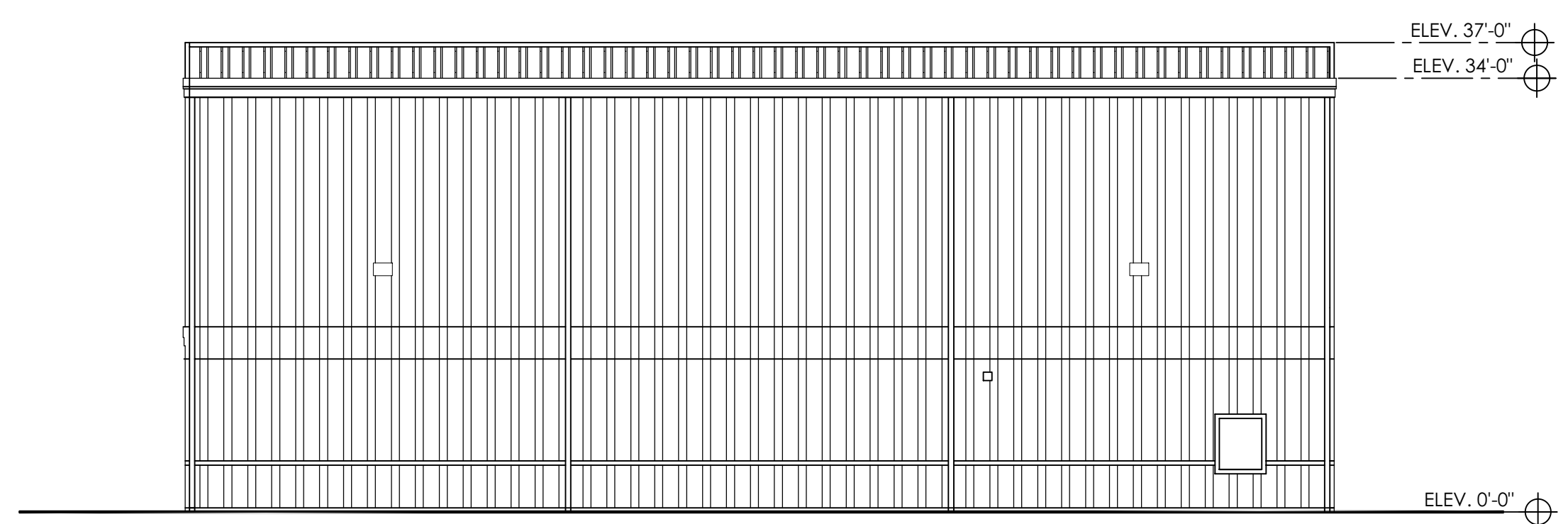
BUILDING B FLOOR PLAN

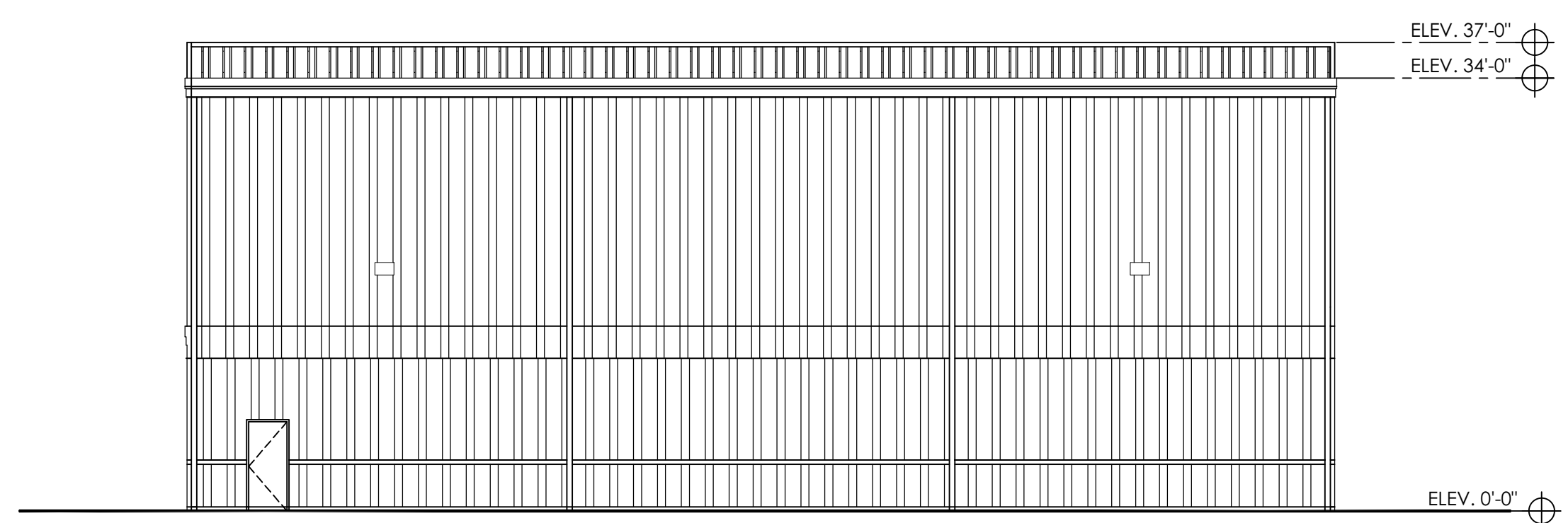
BUILDING B NORTH ELEVATION
