#### 1. Mosaic Team

##### a. Trail of the Honey Bees Location

Ms. Atria read staff report #18-116 pertaining to the Mosaic Trail.

Ms. Atria stated she has worked long and hard with Terrell Davis and the Cultural Center and he suggested putting a mosaic mural on the light pole out front of Cultural Center and on the new signage that will be installed.

Ms. Johnson raised her concerns regarding the Pat Larkin Center and the mosaics being placed there. (31:44)

Ms. Johnson stated that she doesn't think people will like it there. She stated she knows the community and there needs to be conversations with certain folks.

Ms. Barrett stated there needs to be conversation with Parks and Recreation. She thinks there will be a lot of people not okay with it.

Ms. Barrett stated the original idea of the Honey Bee Trail was to create an actual path in the sidewalk to connect the Northwest to the Arts District. Ms. Barrett further stated she liked the idea of putting them on light posts and painting the poles so they stand out and does create the walkability.

Ms. Kaplar stated the mosaics should come from the Ali building down MLK Blvd. and they should be rearranged and place smaller pieces on the light posts to connect the trail.

Ms. Johnson asked the Committee to place a visual as a preview of what's to come that can be placed at the E. Pat Larkins Center and other centers along the trail describing the Honey Bee Trail and what it means.

A **Motion** was made by Marie Goodrum Johnson to display an information board containing the mosaics and meaning behind the Trail of the Honey Bees and be placed at the E. Pat Larkin Center. Motion was seconded by Kim Maguire. All in favor of the Motion. ***Motion passed unanimously.***

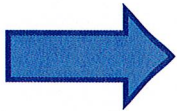
#### 1. Mosaic Team
