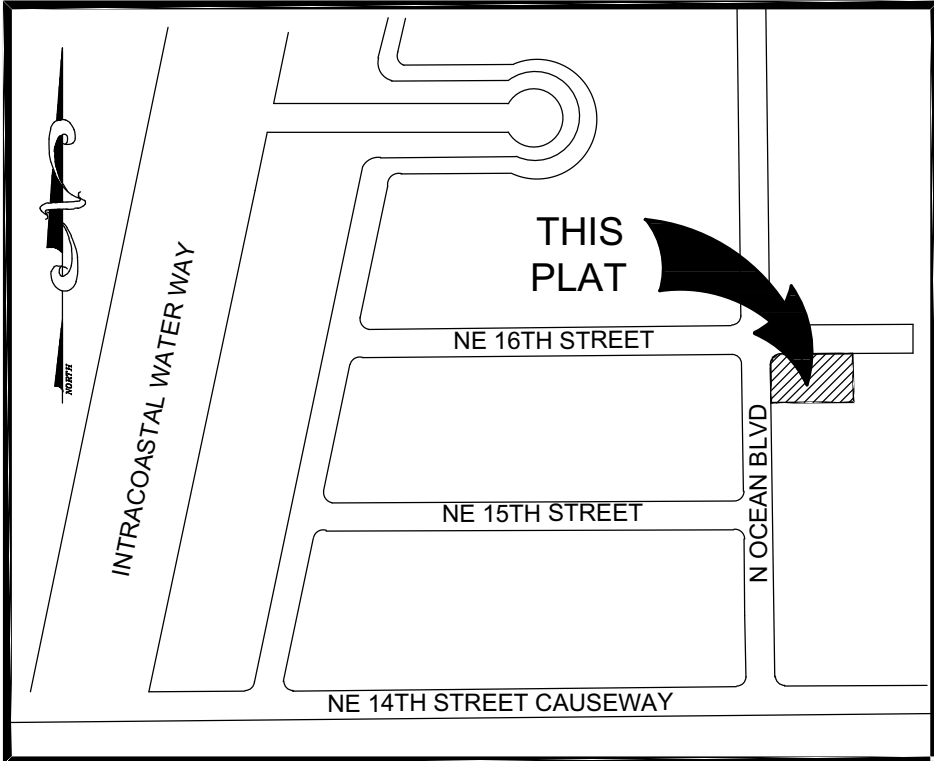


OCEAN PARK POMPANO BEACH
