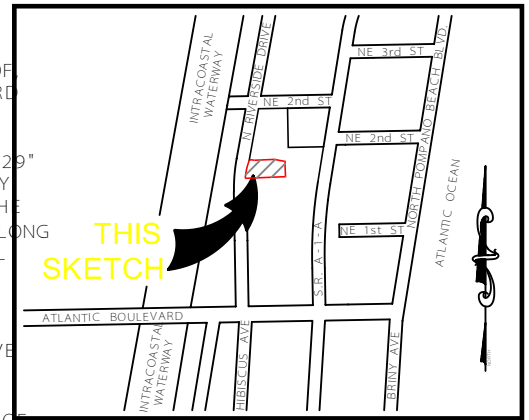


LEGAL DESCRIPTION:

A PORTION OF PARCEL "A", OCEANSIDE FIRE STATION, ACCORDING TO THE PLAT THEREOF AS RECORDED IN PLAT BOOK 179, PAGE 178-179 OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA AND MORE PARTICULARLY DESCRIBED AS:

COMMENCING AT THE SOUTHWEST CORNER OF SAID PARCEL "A"; THENCE NORTH $01^{\circ}03'29''$ WEST, ALONG THE WEST LINE OF SAID PARCEL "A", ALSO BEING THE EAST RIGHT OF WAY LINE OF NORTH RIVERSIDE DRIVE, 316.38 FEET TO A POINT ON A CURVE CONCAVE TO THE EAST (A RADIAL BEARING FROM SAID POINT BEARS NORTH $89^{\circ}08'22''$ EAST); THENCE ALONG THE ARC OF SAID CURVE TO THE RIGHT, HAVING A RADIUS OF 985.42 FEET, A CENTRAL ANGLE OF $05^{\circ}14'56''$, AN ARC DISTANCE OF 90.27 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING ALONG SAID CURVE TO THE RIGHT (A RADIAL BEARING FROM SAID POINT BEARS SOUTH $85^{\circ}36'39''$ EAST), HAVING A RADIUS OF 985.42 FEET, A CENTRAL ANGLE OF $05^{\circ}04'43''$, AN ARC DISTANCE OF 87.35 FEET TO A POINT ON A CURVE CONCAVE TO THE SOUTH (A RADIAL BEARING FROM SAID POINT BEARS SOUTH $28^{\circ}02'33''$ EAST); THENCE, DEPARTING SAID WEST LINE, ALONG THE ARC OF SAID CURVE TO THE RIGHT, HAVING A RADIUS OF 29.33 FEET, A CENTRAL ANGLE OF $38^{\circ}22'56''$, AN ARC DISTANCE OF 19.65 FEET; THENCE SOUTH $79^{\circ}39'37''$ EAST, 24.11 FEET TO A POINT OF CURVATURE WITH A CURVE CONCAVE TO THE NORTH; THENCE ALONG THE ARC OF SAID CURVE TO THE LEFT, HAVING A RADIUS OF 15.67 FEET, A CENTRAL ANGLE OF $11^{\circ}37'35''$, AN ARC DISTANCE OF 3.18 FEET; THENCE NORTH $88^{\circ}42'49''$ EAST, 119.64 FEET; THENCE NORTH $63^{\circ}08'56''$ EAST, 0.88 FEET; THENCE SOUTH $78^{\circ}05'42''$ EAST, 61.78 FEET; THENCE SOUTH $08^{\circ}23'56''$ WEST, 19.19 FEET; THENCE SOUTH $81^{\circ}36'04''$ EAST, 8.62 FEET; THENCE SOUTH $01^{\circ}14'34''$ EAST, 50.43 FEET; THENCE SOUTH $88^{\circ}53'12''$ WEST, 244.19 FEET TO THE POINT OF BEGINNING.

SAID LANDS SITUATE, LYING AND BEING IN THE CITY OF POMPANO BEACH, BROWARD COUNTY, FLORIDA AND CONTAINING 19,652 SQUARE FEET (0.451 ACRES), MORE OR LESS.

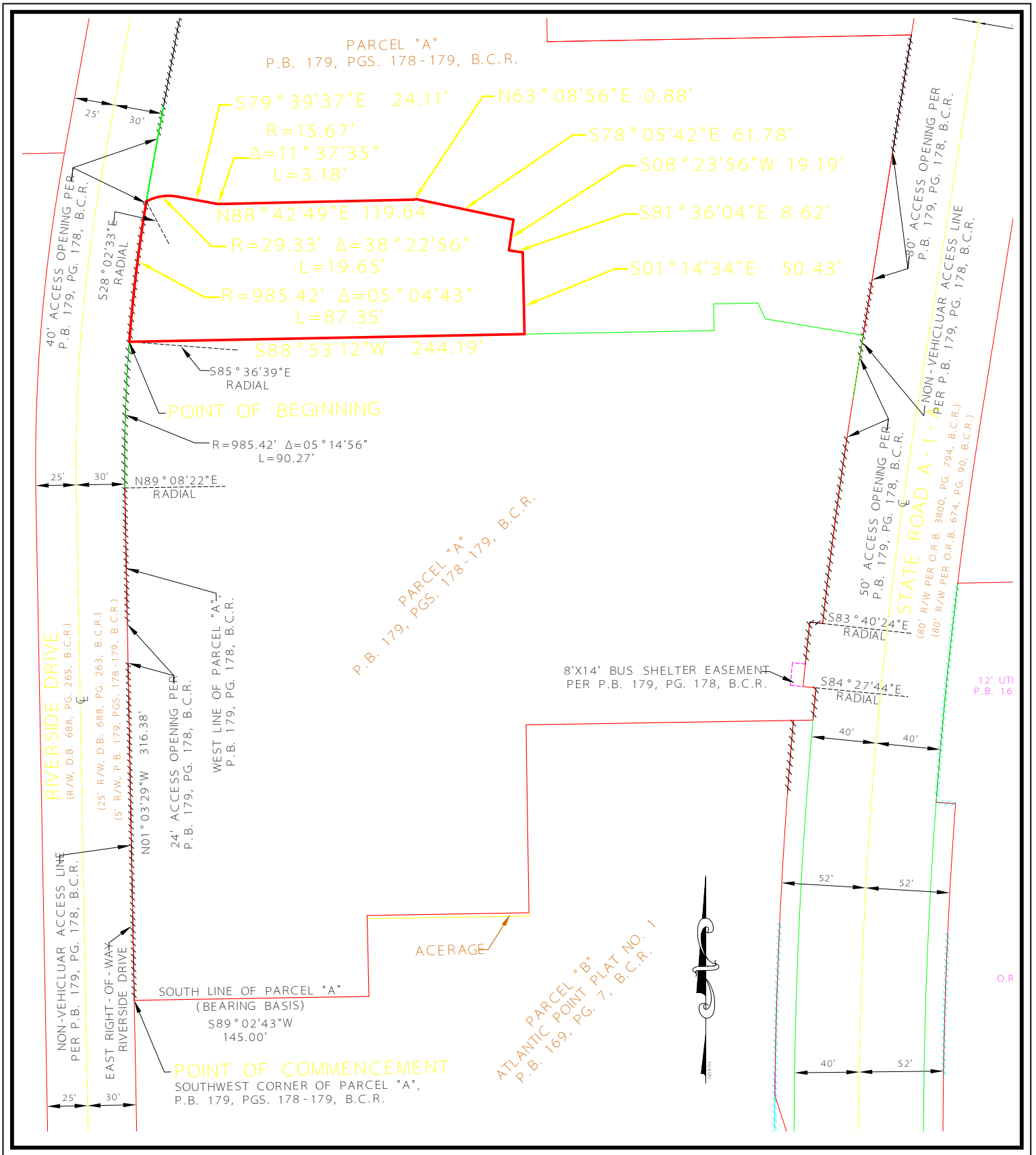
