Wayne, thanks for the email. We discussed that this project was only a Major Site Plan and would not require the review/ approval of the Major Building Design through the Architectural Appearance Committee (AAC). As such, the fee calculator on the website is inflated (because it assumes that all Major Site Plans are also Major Building Designs).

The fee for this project (a Major Site Plan, without Building Design) would be as follows: \$2,550 + \$150 per acre (7.1 acres) = \$3,615.
