City Commission Meeting

CALL TO ORDER

The Honorable Rex Hardin, Mayor called the City Commission meeting to order at 6:00 p.m.

APPROVAL OF MINUTES

23-338 Regular City Commission Meeting Minutes of February 14, 2023

A motion was made by Vice Mayor McGee, seconded by Commissioner Eaton, that the Minutes be APPROVED. The motion carried by a unanimous voice vote.

APPROVAL OF AGENDA

Mayor Hardin announced Items 14 and 15 will be postponed to the March 28, 2023 City Commission meeting

and Item 11 will be stricken from the agenda.

motion McGee, A was made by Vice Mayor seconded by APPROVED AS Commissioner Eaton. that the Agenda be AMENDED. The motion carried unanimously.

CONSENT AGENDA DISCUSSION

The Commission may pull items from the Consent Agenda. During Audience to be Heard, a person may speak on any item on the Consent Agenda, which has not been pulled.

Mayor Hardin announced that no Items have been pulled under the Consent Agenda.

A AUDIENCE TO BE HEARD

Mayor Hardin announced that it was time for "Audience To Be Heard". The following speakers were called to speak before the Commission:

Captain Martin Hedelund, Broward Sheriff's Office, addressed the Commission regarding an ongoing investigation. Capt. Hedelund a lifelong resident and District Command Officer for BSO advised that he was sadden by the tragic and senseless act that occurred in Collier City on February 26th and in his statement, he advised, we are at crossroads, it is a national issue that will take hard work and partnership with BSO and the community. Noting that since 2011, BSO has responded to 1,300 calls for service regarding the Community Food Mart at 401 NW 27th Avenue and requested BSO Captain Darryl Stallings, provide an update on this open investigation.

BSO Captain Darryl Stallings, introduced himself and advised his jurisdiction oversees Area 2 and that he went to the scene in civilian clothes, engaged in conversation with approximately 5 people and BSO does have a vehicle description. Noting that the store has been a problem for quite some time and that just within the last 6 months, BSO has initiated two operations in place, including a violent crimes operation. This included having a deputy assigned daily to the front of the store until about a month ago. Capt. Stallings spoke about cleaning up "Zone 6" which resulted in the individuals then moving onto 2nd Street, which created conflict. Addressing the Commission and the public Capt. Stallings stated, the shooting was unexpected and often times the shooter does not care who else is around when they perpetuate the crime, noting that in this incident, there were 62 shots fired. In closing, Capt. Stallings expressed that he has a vested interest in Pompano Beach, and asked the community for help.

Mayor Hardin said he knows that Capt. Stallings and his colleagues will keep them updated. Adding that it is a community under siege and it is heartbreaking.

Comr. Perkins asked BSO Capt. Stallings if there was a reward. Captain Stallings answered in the affirmative and that the Crime-stoppers flyers should be ready shortly.

Maria McLamore, 613 NW 21st Avenue, Pompano Beach, spoke on the tragedy pleading for immediate action and requested that intersection of NW 4th Street and 27th Avenue be designated a Drug Free Zone.

She acknowledged the two victims and noted that as a Drug Free Zone, they can invest in cameras and enforce a no loitering policy. She asked for a status update on the Police substation that was supposed to be located across the street from the shooting location.

Mayor Hardin noted they have had discussion about the police substation, and they can provide her with an update. The Mayor also asked City Attorney Mark Berman to look into the Drug Free Zone recommendation.

Mary Phillips, 384 NW 18th Street, Pompano Beach, advised that she is a property owner in the Collier City area and suggested implementing a Blue Light District in the area that has a lot of criminal activity. Mrs. Phillips also spoke about her concern over the road reductions stating that she was initially in support of the road reductions but, the street can be beautified without reducing the lanes. She commented, people will not be giving up their cars, and noted the increased development within the City.

Mike Skversky, 1630 SW 5th Avenue, Pompano Beach, said BSO Capt. Stallings is doing a terrific job and advised that he had a card for City Manager Gregory Harrison, Mr. Skversky spoke about the challenges Amway Tire Center is having getting permits and landscaping and asked the City Manager to reach out to the owner.

Cindy Corbett-Elder, 2361 NE 15th Terrace, Pompano Beach, said she was at the meeting on January 24 and asked someone from the City to contact her with information about the plans for streetlights on her street. She said the intensity of the proposed lights affects people's health and animals, in her opinion it is a bad design by Hiller Engineering. Mrs. Corbett-Elder asked for limited streetlights on her street noting that she has reached out to her District Commissioner, Comr. Eaton.

Comr. Eaton said the City Engineer and Ms. Corbett-Elder's neighbor, who works for the City, will reach out to her.

Matthew Higgs, 461 Margate, Pompano Beach, said he just relocated back to the area but there is an epidemic in the City. In his address to the Commission he noted that the Police are doing their job but something different needs to be done. He commented that the buildings are beautiful but noted, there is no drug program here and asked that the City allow others to help them, including programs and churches. Mr. Higgs said he wants his City to be his City, "let's come together and give the Police a break. What can we do?"

Mayor Hardin stated they continue to have discussion about the convenience store and perhaps they will need to purchase the building for parking for the substation. He noted nothing has been determined. The Mayor advised that the City could entertain shutting down 27th Avenue with community support, stating that nothing is off the table and that there are things they can do.

City Manager Harrison stated that the March 14th the Commission Agenda will include an item for a contract to start work on a substation just north of the convenience store.

Ed Phillips, 384 NW 19th Street, Pompano Beach, said he has a sense of rage, but he will temper the rage to get his point across clearly. He spoke about past shootings and said they are looking for solutions, nothing that other cities have rezoned challenging areas. Mr. Phillips stated the community wants the City to come up with

an immediate and concreate initiative to address the issue.

Ryan Johnson, no address provided. Resident and father of one of the deceased victims addressed the Commission introducing himself, his wife and several family members. Mr. Johnson spoke about the activity on 6th Street advising that his son was not a troublemaker and that this incident has raised awareness. He thanked the Pompano Beach clergy for their support and stated emphatically that the community wants to see the changes, noting that they were pushed out of their neighborhood due to development. Mr. Johnson asked, "why is it that the convenience store is still there, after so many black lives have been taken in that block? Our children are being killed." He asked the City to make plan for that block and noted that the street where his church is located has been cleaned up stating that the community wants the convenience store gone and asked the City to help them in the fight.

Pastor Miguel Cruz yielded his time to Reverend Moise.

Reverend Eddy Moise Jr., no address provided, introduced the family members of both deceased victims. In his address to the Commission Rev. Moise acknowledged the churches and organizations invested in the community and thanked the City Commission for their work as well as BSO Captains Hedelund and Stallings for protecting the community. He stated senseless gun violence is a national issue and offered prayers to the family members of the victims, adding that the community is crying out for justice and a brighter tomorrow. He asked for everyone to take 21 days to gather information surrounding community concerns and reconvene to develop an action plan to consist of the following: 1) A permanent police ghost care at the convenience store location; 2) Consider a surveillance camera at the location; 3)The City of Pompano Beach to increase the reward funds to close out open criminal cases; 4) Have regularly scheduled meetings with community leaders and citizens to come together for the common good; 5) Help the bereaved families as they cannot tolerate gun violence in the community any longer. In closing he asked the City to commit to partner with the community.

Sheila Monroe, 11721 NW Place, Sunrise, addressed the Commission stating sadly that she will be burying her granddaughter on her birthday, stating that she is pleading with the City about the store endorsing the substation contract.

Comr. Perkins announced a community meeting that she scheduled for March 9th at the E. Pat Larkins Center and will distribute flyers shortly

Marlowe Moreland, 2236 N. Cyprus Bend Drive, Pompano Beach, addressed the commission and stated that a blind eye has been turned to this store that is supporting illegal activity and needs to be held accountable, "we need a solution". She recommended that the store be shut down immediately adding that the people who loiter in front of the store do not care about the police. Ms. Moreland advised, there are several substance abuse programs within Pompano Beach, and they are there for those that need help and the community is willing to help. She announced a community meeting which she will be hosting on Saturday at 500 NW 3rd Avenue.

Jocelyn Jackson, no address provided, said Lisa Sneed is her classmate. Addressing the Commission Mrs. Jackson commented that back in 2000 the area of Kendall Green was a drug-infested area and she vowed to be a voice on her block. She stated that the community needs to take possession of where they live. She briefly touched on the topic of accountability of landlords and encouraged Comr. Moss to not sit back but to show up

at the community meeting. Before yielding her floor time Mrs. Jackson urged the City Commission to push the envelope to Tallahassee.

Terry Ann Williams Edden, no address provided, commended BSO for their efforts in the 6th Avenue area. She opined, most of the store owners are drug dealers and noted the store can be removed for drug dealing. Mrs. Williams Edden commented that this is a community problem quoted the late Rev. Dr. Martin Luther King. In her parting remarks she asked the City Commission to come together for change.

Comr. Fournier addressing the family of the victims acknowledged their terrible loss, stating that the community is crying out for help right now. She thanked the clergy as well as BSO for their help and support adding that nuisance properties have no place in the City to that end she stated that she has requested a list of areas that need focus agreeing that it is a collective action and the City owes the community more.

Vicente Thrower, 1890 NW 6th Avenue, Pompano Beach, said if this incident had happened under Former Broward Sheriff Ken Jenne's watch, he (Jenne) would have been in the community talking to the victims about how to solve the problem. Mr. Thrower opined that Sheriff Tony should have been in attendance tonight addressing the community. He commented on convenience stores in the area and urged those in attendance, "don't put all owners in the same basket, they need to clean up the ones that have problems". He also asked about the fee for street naming and spoke about residents who deserve to have a street named after them.

Comr. Perkins advised there was an increase of the fee for the street naming application from \$500.00 to \$1,000.00.

Roderick Phillips, 2620 NW 10th Street, Pompano Beach, said he was shocked when he passed by the store and saw a memorial, but the store was open. Noting that the store was still operating when the police were conducting their investigation and yielded his remaining time to Ed Phillips. Mr. Phillips asked for a report on how many times the Police have been to the store for nuisance abatement in the past 5 years.

Vice Mayor McGee asked about the copy of the current process for nuisance abatement.

Mayor Hardin referenced the printed statistics BSO provided, which were added to the record regarding the convenience store which according to the statistics do not rise to the level of nuisance abatement.

Comr. Eaton stated they have tightened up their zoning code and property code violations. She said she has similar issues in her District. She expressed her sympathies to the families affected and the community. She noted community meetings may need to be noticed if multiple Commissioners plan to attend and engage in discussion.

A Pompano Beach resident commented that he's seen a lot of young people die there. He stated that he could have been dead last night, "they sell dope right in front of the Police".

A Pompano Beach resident commented that he heard the AK-47 within 5 minutes of going outside and agrees with the recommendation to make it a Drug Free Zone.

Brigitte Holloway, 1824 NW 6th Avenue, Pompano Beach, addressed the Commission as a Pompano Beach resident and a 20-year military veteran. She advised that the City is under siege and her heart aches because nothing has been done. She spoke about family members lost to violence in the community. She asked the Commission to do their jobs and save the City.

Jimmie Lee Habersham, 2000 NW 4th Court, Pompano Beach, said he represents Circle of Brotherhood, Pompano Beach Chapter who were in attendance to support the grieving families of the victims. Mr. Habersham advised that the Pompano Chapter of Circle of Brotherhood have been canvassing 27th Avenue every Saturday since September acknowledging the presence of BSO and vice versa during the canvassing. Mr. Habersham commented on the love and devotion of the organization to the community and they want to see changes. Before yielding the floor he announced an all men's meeting hosted by the organization to be held on March 3rd, stating the aid the City has the resources to get things solved and they're doing what they are for their children, grandchildren, and the community.

Saracha Peterson, 103 NW 7th Avenue, Pompano Beach, said she lives on a corridor that has always been riddled with crime. Many of the issues pertain to in-house communities. She described how she faced a slumlord and said there is a common thread between slum and blight and crime. In closing, she commended the City for working on the nuisance issues, but noted the specific stores need to be pointed out.

Comr. Fournier commended Ms. Peterson for standing up at the Nuisance Abatement Board meeting.

Comr. Moss said his heart goes out to the families. He indicated that Collier City is slowly getting better but they are not there yet. There have been many conversations over the years to have the store closed. He said he is happy to attend any community meeting but reminded the community of the Sunshine Law. He made a commitment to try to get the store closed and to mitigate the issues in the community. He said he is on the community's side.

Comr. Eaton said the Police substation has always been part of the plan. She recommended a temporary Police trailer in a nearby lot.

Comr. Perkins asked Comr. Moss, how long has he been trying to get this specific store closed? To which Comr. Moss advised, since Day 1 of his service. He spoke about another store they closed on 27th Avenue as part of McNair park. He said it is often a topic of conversation at the Collier City Homeowners Association.

Comr. Perkins asked why the store cannot be closed?

City Attorney Berman advised that they have looked at all the calls for service and most of them were self-initiated by BSO and the store personnel. He noted there must be a direct connection with the store and the crime occurring in the neighborhood. Moreover, he said Florida laws require a certain number of incidences within a certain amount of time and he confirmed they are looking into it. In closing, Mr. Berman noted it looks like there is not enough documented incidences to close the business and the property owner have the right to due process. He then further explained the eminent domain procedures.

Comr. Perkins thanked the community for attending the meeting and speaking on this important issue. She

spoke about two new corner liquor stores. She said this is not a new issue and described past and recent shooting incidences. She said the conditions in District 4 are deplorable and they need more money to address them reiterating the details of the March 9th community meeting.

Vice Mayor McGee said if the community sees an issue with the store, she encouraged them to call-in so that there is a record.

Comr. Fournier asked if the CRA has attempted to purchase the property. City Manager Harrison replied no.

Next, she encouraged everyone to stay committed to the values celebrated during Black History Month including equity, economic participation and inclusion. She reiterated the importance of remaining independent during development and seeking community input. She suggested considering a minimum public input target for NW CRA funding. Lastly, she reminded residents of District 3 of the next community meeting to be held on March 8th at the American Legion.

Comr. Moss' Report:

Comr. Moss said one of the two bridges that joins Palm Aire is now open. He noted the second bridge is now closed for repairs. Also, he commented on his most recent District 5 Saturday meeting, stating it was well attended and encouraged the community to join. Lastly, he reported on Top Golf's activities, stating that they have started construction on Golf Course Road.

Comr. Perkins' Report:

Comr. Perkins thanked the Cultural Arts Department for the Pioneer's Family Reunion and the Pioneer Ball. She said the Black History Month Brunch was awesome as well and expressed the desire to see it continue throughout the year.

Vice Mayor's Report:

Vice Mayor McGee referenced an article about the FAU Shipwreck Park Wahoo Bay project, citing that it pertains to the re-nourishment of mangrove and coral reef. She said this project creates an opportunity for children to experience and learn more about marine life. Also, she thanked the Urbanist for his presentation to the CRA Board last week and she expressed appreciation for his perspective.

Mayor's Report:

Mayor Hardin thanked everyone involved in the Black History Month events. He announced the Mayors' Chess Challenge at the Cultural Center on March 4th. Also, he said a Mayors' Gala will be held on April 29th to benefit the United Way and asked City Manager Harrison to ensure the City has representation at the event. Finally, he spoke about construction and traffic issues in Old Pompano and recommended installing temporary speed humps to reduce the neighborhood traffic.
