RE:	Agenda Item – Application to the U.S Department of Justice, Edward Byrne Memorial Justice Assistance Grant Program (JAG)

BJA released their FY 2019 Local Solicitaion for the JAG program on July 25, 2019. The application was due and submitted on August 23, 2019. The timing of this solication does not provide enough time for staff to present the application for review and comment by the City Commission and residents.

This Resolution, ratifies the application made to the granting agency which was submitted prior to the deadline of August 23, 2019 and authorizes the Mayor to accept and execute the grant agreement if awarded. The grant specifically requires — (a) the application be made public; and (b) an opportunity to comment on the application be provided to citizens and to neighborhood or community based organizations to the extent applicable law or established procedures make such opportunity available.

The Edward Byrne Memorial Justice Assistant Grant (JAG) Program is a formula grant to counties and municipalities based on crime and statistics. Seventeen (17) jurisdictions within Broward County's borders are eligible to apply for \$501,886. The U.S. Department of Justice, Bureau of Justice Assistance (BJA) has identified Broward County as disparate. As a result of the disparity the seventeen (17) jurisdictions must identify a fiscal agent and submit a joint application.

Upon official notification from the BJA for the award. The City of Pompano Beach, through a Memorandum of Understanding (MOU) will administer the programs and funds as the lead administrative and fiscal agent for each jurisdiction. Below is the list of awards, less the 10% of the Formula-Based Allocation for administrative costs for each of the seventeen jurisdictions:

2019 EDWARD BYRNE MEMORIAL JAG AWARDS

*City of Pompano Beach will also be the lead agency and provide fiscal and programmatic oversight.

City of Pompano Beach has applied for a total of \$114,349. \$71,289 to be used towards community outreach, community outreach response & enforcement and support from the Regional Crime Analyst. Deputies will address minor criminal incidents through road patrol, criminal investigations, school resources officers, and traffic enforcement Engage with the community through community policing methods and utilize Sheriff Tony's new initiative "Park, Walk, and Talk". The City will also receive \$43,060 to cover costs associated with administering the award. There is no matching funds requirement. The City will place a brief narrative of this proposed project on the City's website for public comment in October 2019.

The entire application which includes the proposed projects for each of the 17 jurisdications has been attached for your review and comment. Similar to the City, each individual jurisdication is required to provide their governing body and citizens the opportunity to comment on the application. The required information provided by each jurisdiction is prepared by their respective staff and provided to City of Pompano Beach staff which we then submit as a joint application.
