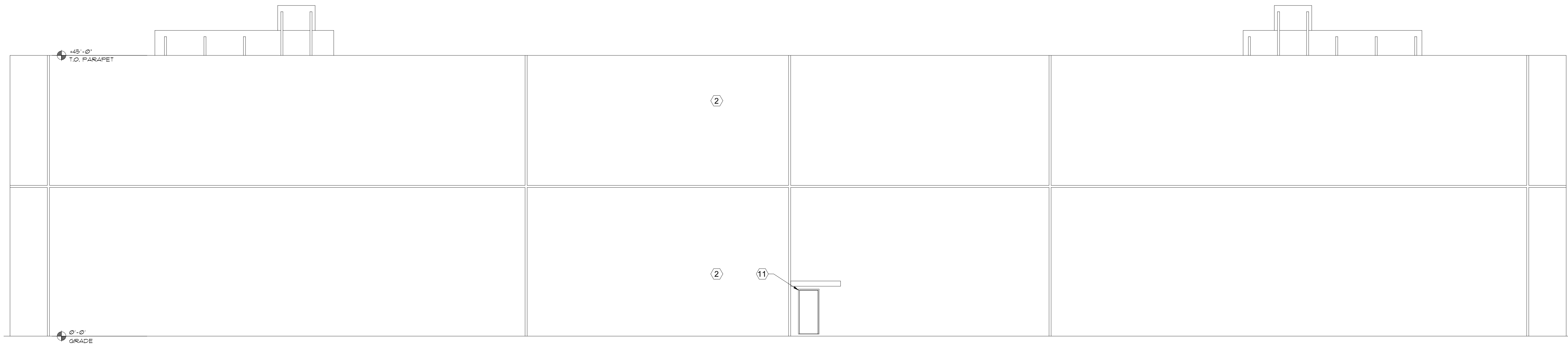


01 EAST BUILDING ELEVATION

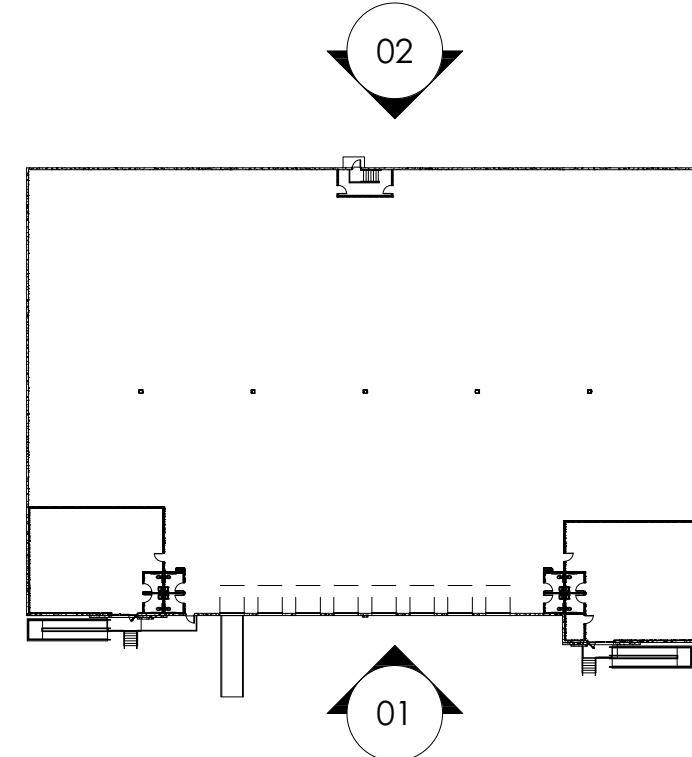
