**FIRST AMENDMENT**

**THIS IS A FIRST AMENDMENT TO THE SERVICE CONTRACT** dated the 1<sup>st</sup> day of April, 2019, between:

**CITY OF POMPANO BEACH**, a municipal corporation of the State of Florida, whose address is 100 West Atlantic Boulevard, Pompano Beach, Florida 33060, hereinafter referred to as "CITY,"

and

**NEW HORIZON COMMUNITY DEVELOPMENT CORPORATION, INC.**, a Florida corporation, having its office and place of business at 1518 NW 17<sup>th</sup> Ave., Pompano Beach, FL 33069, hereinafter referred to as "CONTRACTOR."

**WHEREAS**, the parties entered into a Service Contract to provide Summer youth Employment Training Program services on April 3, 2018 ("Original Agreement"), and approved by City Resolution No. 2018-117; and

**WHEREAS**, the CONTRACTOR have mutually agreed to extend the Original Agreement for one (1) additional one (1) year period.

**IN CONSIDERATION** of the mutual terms, conditions, promises, covenants and payments herein set forth CITY and CONTRACTOR agree as follows:

1. Each "WHEREAS" clause set forth above is true and correct and herein incorporated by this reference.
2. The original Agreement effective April 3, 2018, a copy of which is attached hereto and made a part hereof as Exhibit "A," shall remain in full force and effect except as specifically amended herein below.

3. The parties hereto agree to extend the Original Agreement for one (1) additional one (1) year period, ending April 2, 2020.

4. This Agreement shall bind the parties and their respective executors, administrators, successors and assign and shall be fully effective as though the extension had been originally included in the Agreement.
