AN ORDINANCE OF THE CITY COMMISSION OF THE CITY BEACH, FLORIDA, **APPROVING OF POMPANO** AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE CONTRACTS FOR CONSULTING/PROFESSIONAL SERVICES **OF BETWEEN** THE CITY **POMPANO BEACH AJAMIL** & PARTNERS, INC., BERMELLO, CALVIN, GIORDANO & ASSOCIATES, INC., CRAVEN THOMPSON & ASSOCIATES, INC., CHEN MOORE AND ASSOCIATES, INC., EDSA, INC., KEITH AND ASSOCIATES, INC., KIMLEY-HORN ASSOCIATES, INC., IBI GROUP PROFESSIONAL SERVICES (USA) INC., KCI TECHNOLOGIES, INC., MILLER, LEGG & ASSOCIATES, INC., STANTEC CONSULTING SERVICES, INC., WGI, INC., AND TOOLE DESIGN GROUP, LLC, FOR CONTINUING CONTRACT FOR LANDSCAPE ARCHITECTURAL **SERVICES FOR VARIOUS** PROJECTS; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

## BE IT ENACTED BY THE CITY OF POMPANO BEACH, FLORIDA:

**SECTION 1.** That thirteen (13) Contracts for Consulting/Professional Services between the City of Pompano Beach and Bermello, Ajamil & Partners, Inc., Calvin, Giordano & Associates, Inc., Craven Thompson & Associates, Inc., Chen Moore and Associates, Inc., EDSA, Inc., Keith and Associates, Inc., Kimley-Horn and Associates, Inc., IBI Group Professional Services (USA)

Inc., KCI Technologies, Inc., Miller, Legg & Associates, Inc., Stantec Consulting Services, Inc., WGI, Inc., and Toole Design Group, LLC, for Continuing Contract for Landscape Architectural Services, copies of which Agreements are attached hereto and incorporated herein by reference as if set forth in full, are hereby approved.

**SECTION 2.** That the proper City officials are hereby authorized to execute said Contracts.

**SECTION 3.** If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.
