A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, ACCEPTING A DEED OF GIFT FOR KESTER COTTAGES FROM POMPANO BEACH HISTORICAL SOCIETY, INC.; PROVIDING FOR RECORDATION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Pompano Beach Historical Society, Inc. is the owner of the two cottages donated in 1974 by Stewart Kester, nephew of the City Pioneer, William L. Kester, and currently located in Founders Park; and

WHEREAS, the cottages serve as museums to preserve the rich history of Pompano Beach, displaying artifacts of the working life of Pompano, including farm equipment, military, home front and school memorabilia, and items from a lumber yard, a print shop and a pharmacy; and

WHEREAS, the Pompano Beach Historical Society, Inc. has agreed to operate and manage the cottages and the Hood Center as museums, in consideration for the City's assumption of all building and grounds maintenance and other ownership responsibilities; and

WHEREAS, the City Commission has determined that the best interests of the public will be served by accepting and acquiring the rights being conveyed by the Deed of Gift; now, therefore,

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:

| SECTION 1. That the City of Pompano Beach accepts the Deed of Gift for the Kester |

DEED OF GIFT

I, PETER WILLIAMS, as President of the POMPANO BEACH HISTORICAL SOCIETY ("SOCIETY"), 217 N.E. 4th Street, Pompano Beach, Florida 33060, on behalf of the SOCIETY, irrevocably and unconditionally grant, and convey, by way of gift, to the CITY OF POMPANO BEACH ("CITY") and its successors and assigns, all of the rights, title, and interest in, arising from and to the Kester Cottages ("Historical Site"). By this deed, the SOCIETY makes an unconditional gift of the Historical Site and transfers not only legal and beneficial title, but also all other rights associated with the Historical Site such as physical and intellectual rights.

Affirmation of Title. I, on behalf of the SOCIETY, affirm that the SOCIETY owns the Historical Site and has good and complete right, title and interest in and to the Historical Site and transfer all rights and title, and relinquish any interest from and to the Historical Site. I, on behalf of the SOCIETY, understand and agree that the SOCIETY is giving the Historical Site to the CITY as an unrestricted gift and relinquish any rights which it may possess, not including its contents and movable fixtures.

I, on behalf of the SOCIETY, understand and agree that access to the Historical Site will be granted to the public subject to the rules of the CITY.

<u>Indemnification and Hold Harmless</u>. Upon execution and delivery of this Deed of Gift to the CITY, the SOCIETY agrees to indemnify and hold harmless the CITY for any claims, damages, losses and expenses (including attorney's fees) which may arise out of negligent error or omission in donating a gift that is not free and clear of encumbrances, infringements or any other defect which may make such property unmarketable and draw legal ramifications.

I, on behalf of the SOCIETY, understand and agree that the SOCIETY's access and use of the Historical Site will be according to the policies and procedures of the CITY unless other arrangements are made and agreed upon in writing.

This Deed of Gift shall be governed by the laws of the state of Florida.
