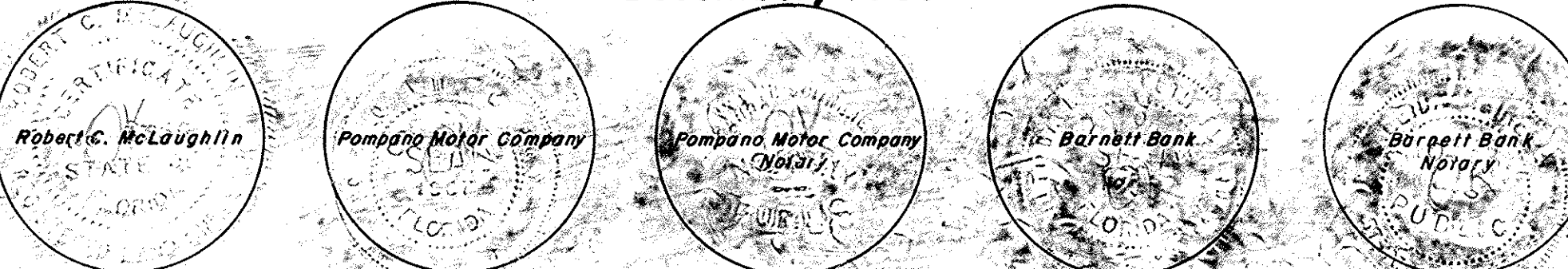

CITY OF POMPAHO BEACH, BROWARD COUNTY, FLORIDA

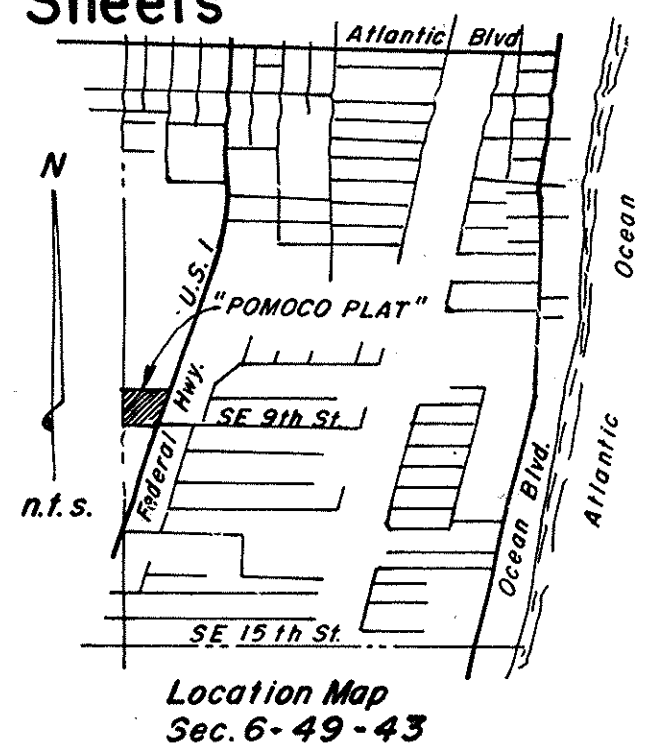
