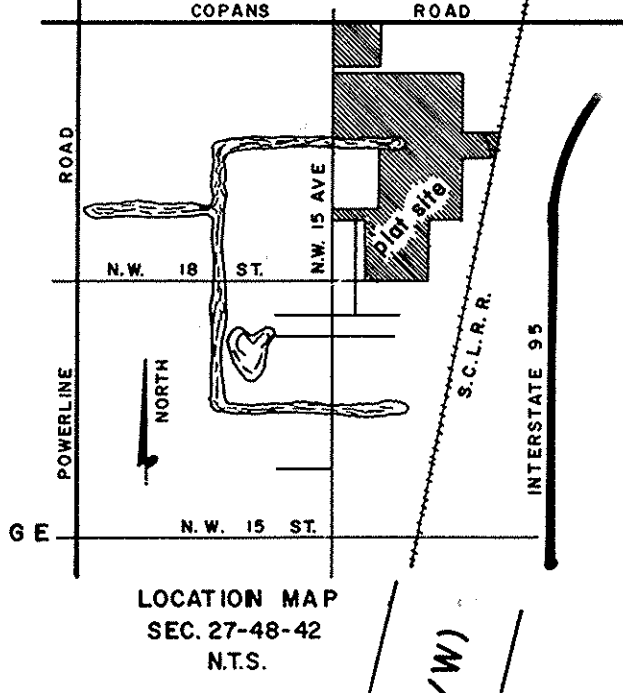
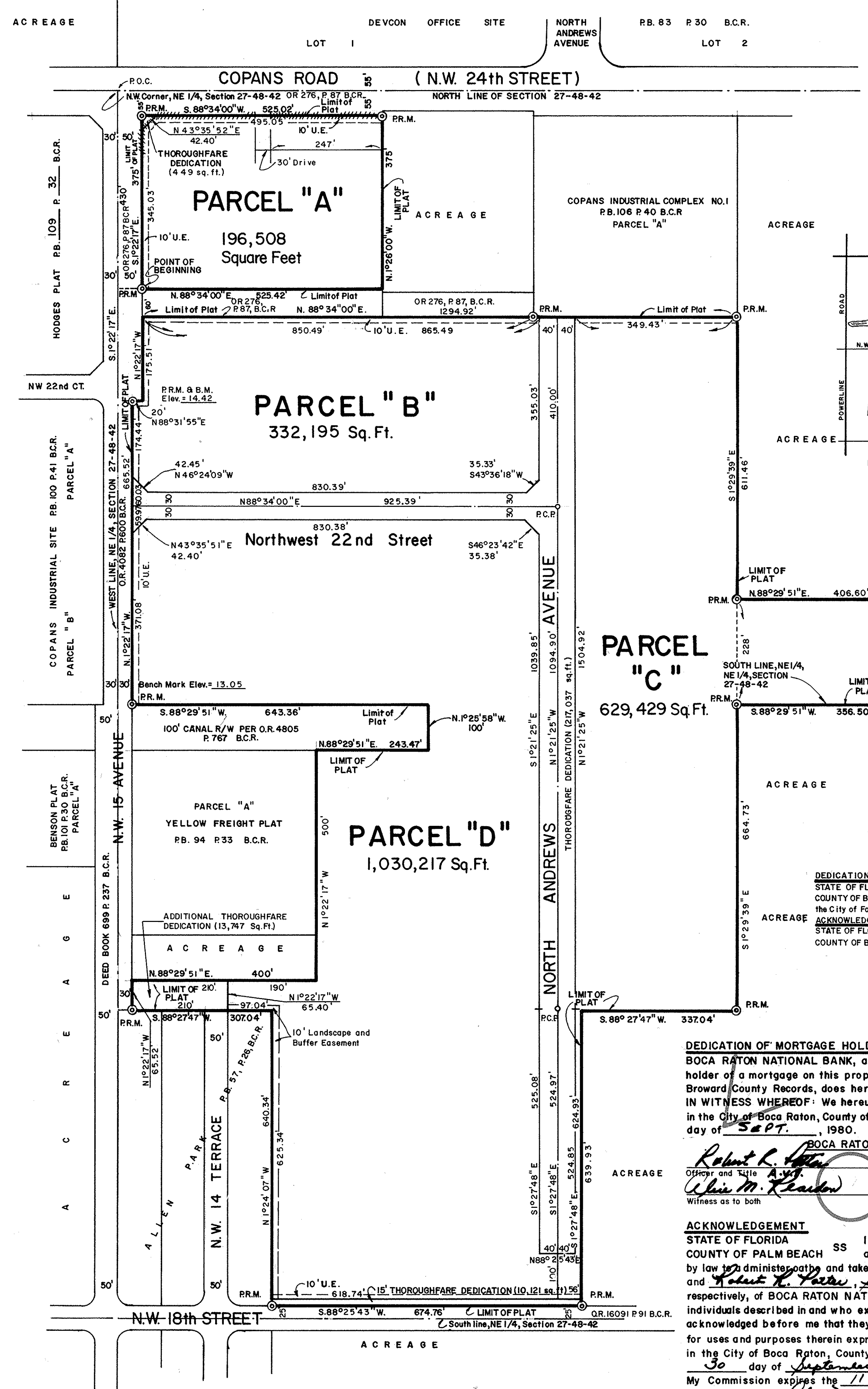


"ADDITION TO COPANS INDUSTRIAL COMPLEX NO. 1"

A portion of the Northwest one-quarter (NW 1/4) of the Northeast one-quarter (NE 1/4) of Section 27, Township 48 South, Range 42 East, more fully described as follows: Commencing at the Northwest corner of the Northeast one-quarter (NE 1/4) of Section 27, thence South 1°22'17" East along the West line of the said Northeast one-quarter (NE 1/4) of Section 27, a distance of 430 feet; thence North 88°34'00" East, a distance of 50 feet to the Point of Beginning; thence continuing North 88°34'00" East, a distance of 525.42 feet; thence North 1°26'00" West a distance of 375 feet; thence South 88°34'00" West along a line 55 feet South of and parallel with the North line of said Section 27, a distance of 525.02 feet; thence South 1°22'17" East along a line 50 feet East of and parallel with the West line of said Northeast one-quarter (NE 1/4) of Section 27, a distance of 375 feet to the Point of Beginning; TOGETHER WITH: The Northwest one-quarter (NW 1/4) of the Northeast one-quarter (NE 1/4) of said Section 27, LESS the North 490 feet thereof, AND LESS that certain right-of-way as recorded in O.R.
