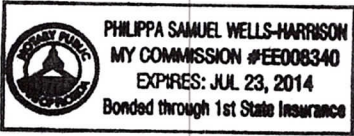

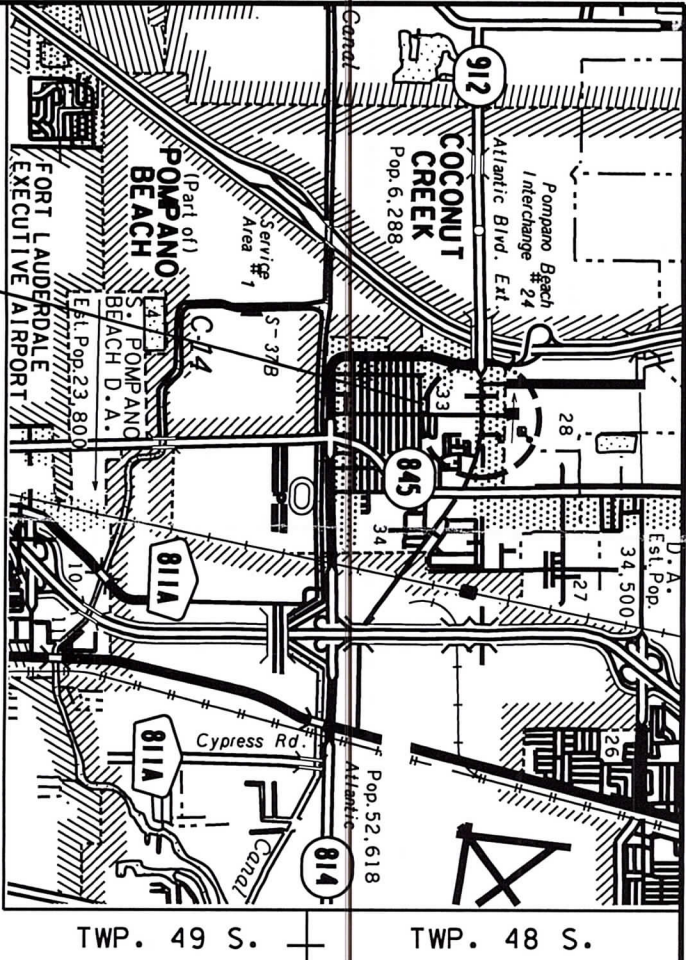

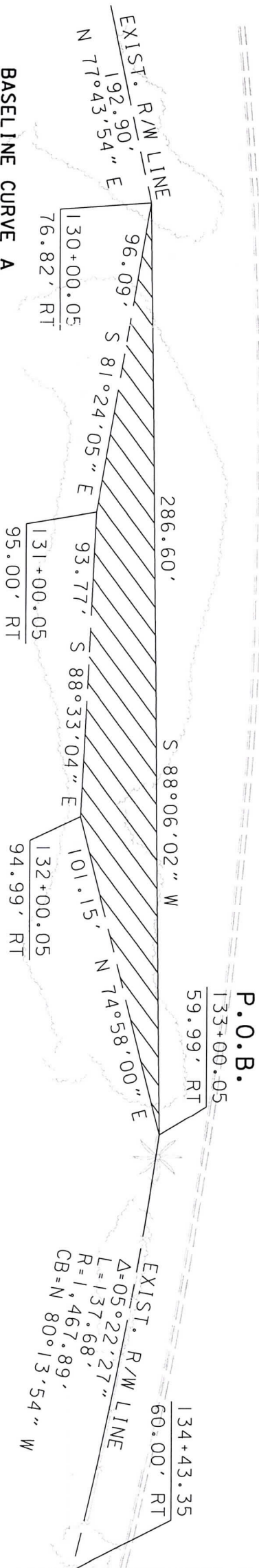

A portion of the Southeast 1/4 of Section 32, Township 48 South, Range 42 East, Broward County, Florida, being more particularly described as follows.

Commence at the Southeast corner of Section 32; thence North 01°22'14" West, 242.77 feet along the East line of said section to the Southerly Existing Right of Way line of State Road 814 (Atlantic Boulevard), on a non-tangent curve, concave to the South, having a chord bearing of North 80°13'54" West; a radius of 1,467.89 feet, and central angle of 05°22'27"; thence Westerly along said curve and Southerly Existing Right of Way line 137.68 feet to the end of said curve and the POINT OF BEGINNING; thence South 88°06'02" West, 286.60 feet; thence South 81°24'05" East, 96.09 feet; thence South 88°33'04" East, 93.77 feet; thence North 74°58'00" East, 101.15 feet to the POINT OF BEGINNING.
