The City previously had a one year agreement with this provider. The purpose of this agreement is to allow for the continuation of services for the City. As such, this is a continuation of services. The device serves as an additional enforcement tool for individuals with 3 or more regular parking citations or at least 1 ADA citation. The City's Parking system is supported 100% by parking revenues, inclusive of utilizing such revenues to pay debt service on outstanding debt. The City provides for over 1,800 public parking spaces throughout the City. Availability of parking is paramount to supporting the public and businesses in our community.
