REQUIRED NON-FEDERAL SUPPORT

Required non-Federal support is the amount required by ACTION regulations and guidelines as non-Federal support against the project's Federal funds. For all FGP and SCP grants and for first-year RSVP grants, the required amount is 10% of the combined Federal and non-Federal required shares. For second year RSVP grants the amount is \$20%, and for third and subsequent years, 30%.

To compute this amount, divide the Federal amount by 90%, 80% or 70% for a required non-Federal support of 10%, 20% or 30%, respectively, to determine the total amount, and deduct the amount of the Federal share.

In this example, \$21,429 would be the required non-Federal support to be shown in the application budget and in the "Required non-Federal Support" column of the budget page included as a part of the Notice of Grant Award (NGA). Note that the excess local support is not considered in establishing the amount against which the 10%, 20% or 30% required support is calculated. The grantee has the option of including in the required non-Federal share any cost that meets ACTION'S regulations and guidelines.
