Health condition ratings are in accordance with the CTLA 10<sup>th</sup> Edition Guide for Plant Appraisal. While onsite I discovered an additional three trees and have added them accordingly to the attached markup of the tree survey showing the numbering of the trees reviewed for this portion of the property. A total of 25 trees were inspected.

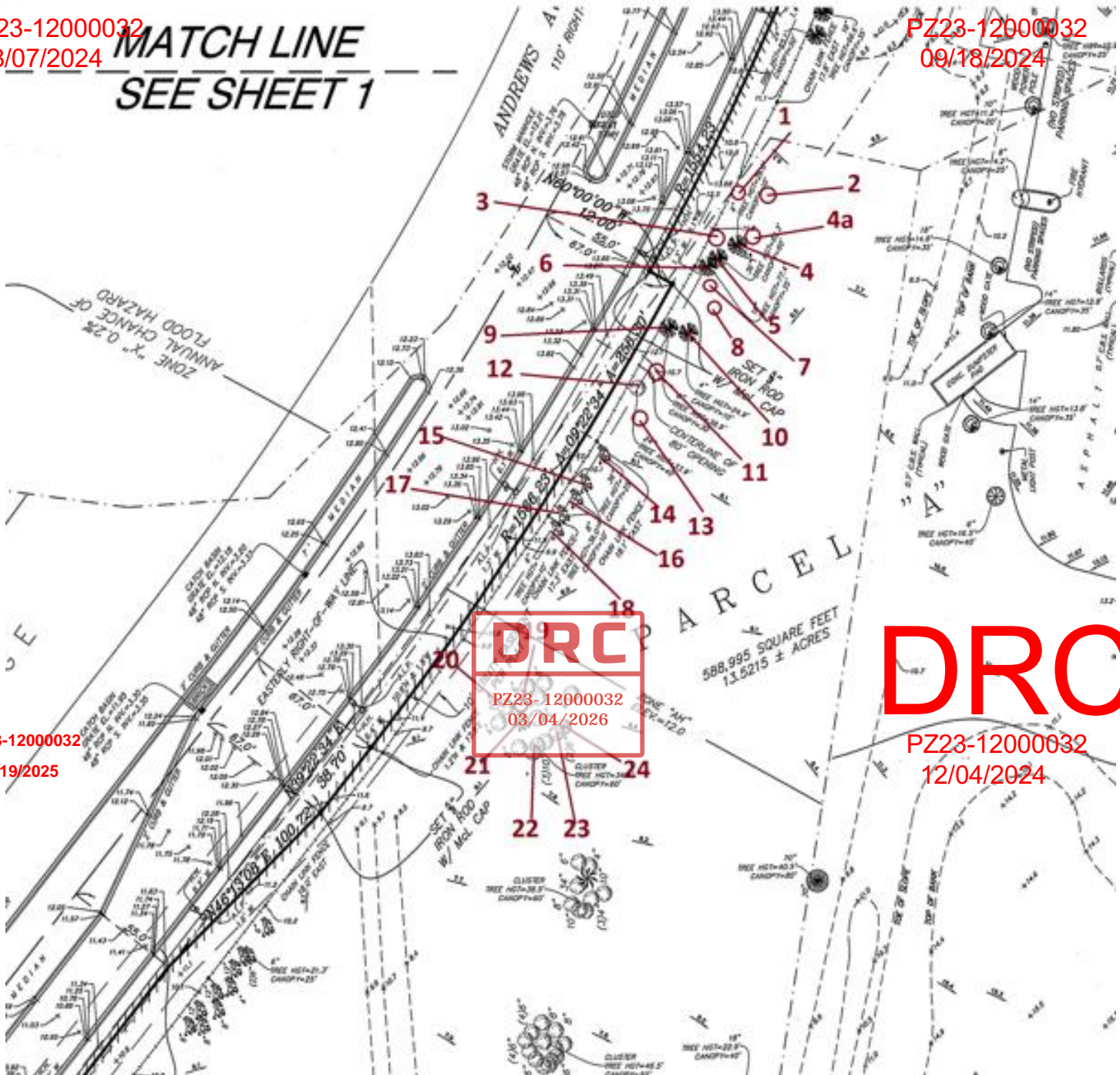


