**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, APPROVING MOSAIC MURAL FLOOR DESIGN AND INSTALLATION IN THE BEACH SIDEWALK STARTING AT THE GREAT LAWN AND STRETCHING NORTHWARD TO THE POMPANO MUNICIPAL PIER PURSUANT TO TERM TWO OF THE MOSAIC TEAM PROJECT; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, on April 28, 2017, pursuant to Ordinance 2017-40, the City Commission approved an agreement with Sonata Kazimieraitiene which commissioned her to design, fabricate and install four (4) mosaic mural projects in the City of Pompano Beach with the assistance of five (5) apprentices over a two year period (the “Mosaic Team Project”), the term of which was subsequently extended for an additional year ending April 27, 2020 pursuant to Resolution 2019-152;

**WHEREAS**, on January 14, 2020, pursuant to Resolution 2020-94, a copy of which is attached as Exhibit 1, the City Commission approved a second agreement with Sonata Kazimieraitiene which commissioned her to design, fabricate and install a mosaic floor mural in the beach sidewalk to the north of the Great Lawn;

**WHEREAS**, pursuant to Section 160.04 of the City’s Code of Ordinances, the Public Art Committee (“PAC”) is empowered to make recommendations to the City Commission regarding certain public art issues, including artist selection and location of public art; and

**WHEREAS**, on February 20, 2020, pursuant to Term Two of the Mosaic Team Project, the PAC unanimously recommended approval of the mosaic mural floor design theme and installation location described in Exhibit 2 attached hereto and made a part hereof.

**WHEREAS, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:**

**SECTION 1.** That pursuant to Term 2 of the Mosaic Team Project, the City Commission has approved the mosaic floor mural described in Sonata Kazimieraitiene’s Design Proposal attached hereto and made a part hereof as Exhibit 2 and its installation location in the beach sidewalk starting at the Great Lawn and stretching north to the Pompano Municipal Pier.

**SECTION 2.** This Resolution shall become effective upon passage.
