

**FIRST AMENDMENT TO
PROPERTY DISPOSITION AND DEVELOPMENT AGREEMENT**

This First Amendment to Property Disposition and Development Agreement between the Pompano Beach Community Redevelopment Agency (CRA) and Big Tree BBQ, Inc., (Developer) is entered into this ____ day of _____, 2025.

WHEREAS, by Resolution 2024-19, the CRA approved the Property Disposition and Development Agreement entered into by the parties on March 19, 2024 (the Agreement); and

WHEREAS, the Agreement contemplated completion of construction of approximately a 1,500 square foot restaurant and site improvements including parking, drainage, driveway area and landscaping on four (4) separate parcels by April 11, 2025; and

WHEREAS, the Developer has completed the preliminary site plan drawings and has updated the preliminary construction schedule for the restaurant and site improvements; and

WHEREAS, due to specific ingress and egress requirements on the south side of the proposed development site, the Developer has concluded that the inclusion of the adjacent property owned by the CRA west of the project site and identified by Folio Number 404233040770, is required to ensure site access and vehicular circulation; and

WHEREAS, the Developer has requested to extend the timeline for completion of construction of the restaurant and site improvements on the five (5) separate parcels as per the revised construction schedule.

NOW, THEREFORE, the parties agree as follows:

1. Each “Whereas” clause stated above is true and correct and incorporated in this First Amendment by reference.
2. The Agreement shall remain in full force and effect except as specifically amended below.
3. Article 2.2.9 is amended to read as follows:

Developer agrees that construction of the Building and Improvements on the Property shall be substantially completed according to the Project Schedule, but that in no event shall the completion of said construction extend beyond ~~April 11, 2025~~ June 30, 2026, even taking into account Permitted Delays.

4. Article 4.1 – is amended to read as follows:

5. Article 4.5.1 is amended to read as follows:

Developer agrees to complete construction of the Building and Improvements for the Project, according to the Project Schedule (Exhibit 4), but in no event shall completion of said construction extend beyond ~~April 11, 2025~~ June 30, 2026, even taking into account Permitted Delays. Developer’s failure to complete construction shall, upon notice to the Developer and a thirty (30) day opportunity to cure, cancel this Agreement and require Developer to immediately re-convey the Property back to the CRA in accordance with Article 20 herein and the Agreement for Re-Conveyance of Property attached as Exhibit 6.

6. Exhibit 1, The Property and Exhibit 4, Project Schedule, are replaced with the revised Exhibit 1, The Property and Exhibit 4, Project Schedule, attached to this First Amendment.

7. All documents referenced in the Agreement which refer to the construction completion date, such as the Agreement for Re-conveyance, shall be revised to reflect this First Amendment.

8. No other amendments to the Agreement shall be effective unless contained in a written document executed with the same formality and of equal dignity with this First Amendment.


