Budget Justification

A. Requested Funds

- Program Supplies: \$35 X 40 students = \$1,400. Cost includes:
 - o Each student will receive five G.R.E.A.T. logo t-shirts to be worn daily and on each field trip;
 - o G.R.E.A.T. logo water bottles;
 - o Books, pens, paper, arts and crafts supplies;
 - o Board games, sports equipment (footballs, basketballs, etc).
- Field trips: \$42/ea X 40 students X 6 weeks = \$10,100;
- Lunches: \$10.42/ea X 40 students X 6 weeks = \$2,500
- Snacks: \$4.16/ea X 40 students X 6 weeks = \$1,000

B. Other Sources

• Crystal Lakes Middle School provides breakfast and lunch to students during the summer program except on weekly field trip days. The school receives its funding from the national Title 1 program, which provides free meals to schools in low income areas.
