PROCLAMATION

22-180 Proclamation for Black History Month

Mayor Rex Hardin proclaimed February as Black History Month in Pompano Beach.

Mayor Hardin invited former Commissioner Woodrow Poitier to join him at the podium, as well as anybody else who would like to join in to proclaim February as Black History Month. Members of the City Commission joined the Mayor as he read a Proclamation proclaiming February 2022 as Black History Month.

Mr. Poitier accepted the Proclamation from Mayor Hardin on behalf of the members of the Community who have worked diligently for many years to unite the community to make Pompano Beach the great City that it is today. He thanked the MLK Jr. Committee, the Historical Society and its present and past Presidents, especially the late Hazel Armbrister who always spearheaded this event. He also thanked former Mayor E. Pat Larkins, present Commissioners that are present today, and also the other organizations that are pushing forward to making the City better.

A. PRESENTATION

22-147 Strategic Plan 2020-2025 and Action Agenda 2020-2021 Quarterly Progress Presentation. (Fiscal Impact: N/A)

Ernesto Reyes, Strategic Performance Manager, presented the item and stated that the purpose of the presentation is to communicate the progress staff has made towards the implementation of the strategies in the strategic plan, specifically in the progress made during the months of July, August, and September during 2021.

The backup material includes a comprehensive analysis to update the Commission on the 241 strategies in 2021 fiscal year, and the 107 and 44 strategies in the fiscal years 2020 and 2019 respectively. A copy of the overhead presentation is attached as **Exhibit 1.**

The Presentation was READ AND PRESENTED INTO THE RECORD.

B. AUDIENCE TO BE HEARD

Mayor Hardin announced that it was time for "Audience To Be Heard" and offered the following guidelines: Once your name is called, please come forward to the podium in front of the commission, state your name and address for the record. Speakers will be limited to three minutes to speak on any item of concern or interest, including those items pulled from the Consent Agenda. In addition, he asked speakers not to speak on any items on tonight's agenda, as they will have that opportunity to do so when that item comes forward. Lastly, he requested that speakers refrain from any emotional outbursts in either support or non-support of the speaker's comments. All persons interested in speaking during "Audience To Be Heard" must fill out a request form and turn it in to the City Clerk prior to the meeting. A request form is located on the last page of the agenda program.

The following persons were called to speak:

<u>Bulk Pickup Issues</u> - Janice Simmons, 208 NW 15th Place, Pompano Beach, FL, expressed a few concerns she has with incidents continuously going on in her neighborhood and mostly in the Northwest section of the City. The first issue is with the bulk trash pickup. She stated that pickup was taking place twice per week, Wednesdays and Saturdays. Currently, they are only picking up trash on Saturdays every other week. This is becoming a big problem with trash piling up in the neighborhood.

Overgrown Tree and Loitering in Apollo Park - Ms. Simmons stated the second issue is with a big overgrown tree located at the Boys' and Girls' Club property. This encourages drug activities that take place under the tree, as well as people who were actually sleeping at night under the tree. She mentioned that she had complained about the tree prior. There are a couple of sober homes nearby on NW 2nd Avenue and NW 15th Court. It appears the people in the sober homes are drinking and doing drugs in the area, as well as near the Apollo Park. The residents are urging the City to find a way to step in and control these negative types of activities.

Mayor Hardin asked about the exact location of the overgrown tree, whether it is in the Park or the Boys' and Girls' Club property.

Ms. Simmons confirmed it is located at the Boys' and Girls' Club property.

<u>City of Pompano Beach becoming a Smart City</u> - Maureen Gaviola, 2811 NE 9th Court, Pompano Beach, FL, noted the current Agenda posted on line, under the Presentation Item File ID #22-147, referenced the streetlight policy and expansion. She read a little excerpt from it, "This project aims to promote Pompano

Beach as a Smart City by replacing City and FPL owned streetlights with LED fixtures, and providing Wi-Fi throughout the City." However, she opined that this is not a Smart City, and provided her comments on what is currently taking place with the traffic situation that has been created on Atlantic Boulevard and Dixie Highway, and the various issues that the current residents are experiencing in delays to get to and from their homes to other parts in and out of the City. Finally, she mentioned that the City may need to print extra agendas for the next meeting on February 22, 2022 at 6:00 p.m. as the Audience to be Heard is already requesting them.

<u>Poem on Being Black</u> - Carlene Duncan, 1851NW 15th Street, Pompano Beach, FL, read a poem she wrote on being black. "Being black in the community, where there is strength, there is unity. Being black we are still fighting for justice, because the US laws cannot be trusted. Freedom to live, freedom to speak, freedom to have equal opportunity."

<u>Birthday Wishes</u> - Ms. Duncan indicated she wanted to give something to Vice Mayor Beverly Perkins-Moody. She thanked her for standing with powerless citizens, and stated that they love her. Thereafter, she displayed a birthday card and said she wanted to give it to Vice Mayor Perkins because she is a princess, and wanted to wish her Happy Birthday when it comes tomorrow.

Mayor Hardin wished Vice Mayor Perkins Happy Birthday.

Robert McCaughan, Director, Public Works Department, presented the item and stated the Resolution is requesting the City Commission's approval of a contract between the City and Weekley Asphalt Paving, Inc. to implement the City's 5-year paving plan. This is a contract for an initial 1-year term and then 4 x 1-year renewals. He explained the Consumer Price Index that is in the contract, which protects the City and the contractor if there are significant differences in prices from year to year.

Comr. Eaton mentioned that there was a recent situation in the Cresthaven area off Federal Highway and 17th Street, and one of the City Engineers as well as a Public Works staff member came out to investigate it. She understood that both agreed that the roadway looked bad, and it could be assumed that it could do with some repaving. Based on that, even though this project needs attention now, maybe because of the paving done in the past, which was inferior or specific issues with drainage. This roadway does look worse than some of the other streets in the area. Therefore, she wanted to know if they would have to wait for the 5-year plan to top out before it can get on a plan to have that particular street done.

Mr. McCaughan explained the 5-year plan, which is based on a pavement assessment done Citywide, and has an objective score at a Pavement Condition Index (PCI). This issue has come up many times where there are some ugly streets in the City caused from using a product called Micro Paving. However, the strength of the pavement is in good condition. A lot of streets were done with the Micro Paving at one time, so, they all now have to be redone at one time. However, it costs 3 times the amount to do an overlay, than what was done prior. There are 300 miles of streets in the City, so it depends on the condition of the road not being in a condition that it is going to fail, which could mean major reconstruction if the road is failing. In sum, a priority list has to be established for all these roads throughout the City.

Comr. Eaton wanted to know when would they get to the roads in her District, whether it would be the next 5 or 10 years, because this will address the residents' expectation.

Gregory Harrison, City Manager indicated that he does not readily have a plan as to when a particular street would be on a 5-year plan. However, anytime anyone of the Commissioners have a question about where a particular street needs more attention than it is getting, then he asked that they send him an email, which will go through the email chain to get it documented and prioritized.

Comr. Eaton stated that the block she is referring to is an important arterial into the Cresthaven area and she would appreciate an answer as to a timeline when this will be done.

Mr. Harrison promised to get back to her with more specific information on the timing of repaying this road.

Comr. Eaton inquired if the Asphalt company will be responsible to do speed humps that will be installed in the future.

Mr. McCaughan responded yes. In addition, he understands that there are 17 streets that need speed humps. There is a projected schedule for mid-April and they are currently ahead of schedule. Moreover, he stated that 3 streets were done last week that were all situated in Cresthaven as they were at the top of the list.

Comr. Eaton concluded that she would like to be informed as to what is taking place with the speed humps and repaving in her district, so she can communicate this information to her constituents that are constantly sending her emails requesting updates.

Comr. McGee mentioned that she has one street that is in the 5-year plan and asked if the plan is set or whether they annually review the ranking of the roads.

Mr. McCaughan responded that they do reassess roads to determine priority, as well as work closely with the Utilities and Police departments. In addition, he provided information on the improvement in the asphalt paving process that they are currently using.

Mayor Hardin asked if staff could look at the process and not to stop the resurfacing that has already commenced but to try and determine what the costs will be for the resurfacing of the roads throughout the City over the next 20 years.

Brian Donovan, Assistant City Manager, presented the item and stated the purpose of the Resolution is for the Commission to authorize staff to provide notice of termination of the Code Compliance agreement with Calvin Giordano & Associates. This termination would be without cause, and once this notice is sent, staff would provide an estimated timeline for transition. Given all the activities going on in the City, this is a good time to bring those forces in-house.

Doug Borden, 525 North Ocean Boulevard, Pompano Beach, FL, thanked Comr. Eaton and Mayor Hardin for the good questions brought up on the last Resolution discussed under Item #10. He inquired if this termination would be replaced by a private firm. Also, he asked would the compliance officials go onto the City's payroll.

Mayor Hardin responded that the function will be brought in-house and the City Manager has reviewed this to determine the most cost-effective way to provide the services. On this particular item there is no fiscal impact

as this is just a notification to terminate the current contract.

Mr. Borden argued that there will be a "fiscal cause and effect on this." Also, he inquired if any of the code enforcement/compliance officers, who currently work for Calvin Giordano & Associates, will come over to work with the City.

Mayor Hardin responded that has not yet been determined. There will be an application process if someone wanted to work with the City, which would be the same process for any other department with the City.

Mr. Borden expressed his concern with the expansion of government. He then asked if there is a known fiscal impact after the City terminates with Calvin Giordano.

Mr. Donovan responded staff has been looking at this operation for several months and an analysis was done to bring this service in-house, in terms of getting better services for the residents. Actually, it ended up being an efficiency for the City saving some money. The projection is approximately \$100,000 in savings annually. Mr. Donovan invited Mr. Borden to come in and meet with himself and Mr. Sotolongo and they would be able to provide details on the analysis and to answer any further questions that he may have.

Mayor Hardin pointed out that as with all the items on the agenda, the Commission has had numerous meetings with staff on an individual basis. So staff has investigated all types of questions before they bring them forward.

Comr. Eaton stated that Code Enforcement is a huge issue especially in her district. Being dependent on an outside corporate entity, there were things that were outside the City's control. They had numerous employees turnover, which meant that there would be one person that the Commission would get to know working within his/her district on the Code Enforcement team, and the next day that person would be gone. Historical or any code issues that may have been identified would go with that person when they left. She is happy to hear that the City will have cost savings. Therefore, taking this in-house will allow the City more control over the staff and create a good relationship and knowledge with the individual districts and residents over a long period of time. She will support this issue, and recognizes that there is no fiscal impact at this time.

Mark Berman, City Attorney clarified for the record that Commissioners met with staff individually not as a whole body. There are no private meetings held.

Vice Mayor Perkins agreed with having the code compliance in-house, and recalled years ago when the City was in charge of its own code compliance it worked well, because there was more control of things happening in the City. She has numerous issues in the northwest area with code compliance, so the City can better control this with in-house code compliance. In addition, she thinks it would be also a good thing to do the same with the Broward Sheriff's Office.

Mayor Hardin agrees that there is better control with in-house code compliance. He mentioned that one speaker earlier was complaining about bulk pickup, so a certain amount of control is lost with an outside contractor. However, the discussion is on this particular item.

Ed Beecher, Director of Human Resources Department, presented the item and stated that this is the Second Reading of an Ordinance, and there have been no changes since the First Reading.

Doug Borden, 525 North Ocean Boulevard, Pompano Beach, FL, indicated that he has a "gut feeling" that this is the expansion of the City government at the expense of the taxpayers. At the end it states that fiscal impact not applicable. He understands that this Ordinance specifically addresses definitions of contributions. He asked for an example of an actual case of why this is being done and what will be the ramifications.

Mr. Beecher responded that there are 2 employees that work for the Retirement Board. It is an autonomous

board of the City of Pompano Beach. They currently receive a retirement benefit in a form of a 401(k) type program. Staff has done some analysis on this and at the request of the Pension Board they have asked to include those employees in the City's overall pension system. Rather than continue to receive the 401(k) benefit, they will get the City's benefit and the actuaries have come back with the numbers. It is actually a cost neutral and a slight savings to the City. These employees will be giving up their 401(k) benefit and will receive the City's pension benefit. The employees will have to make the same contributions to the Plan just as any other City employee would.

In response to Mr. Borden's question, Mr. Beecher responded that the City was paying for their 401(k) system. As well as, the positions are the Executive Director of the City's Retirement system and her Assistant.

Mr. Beecher explained that the Board of Directors are not members of the Pension system. They have the 2 employees, which is the Executive Director and Assistant Director.

Mr. Borden asked if the language changed from First Reading.

Mark Berman, City Attorney confirmed nothing changed since First Reading.

Paul O'Connell, Chairperson for the Pompano Beach Police and Fire Pension System, stated he has been in this capacity since 2005. He complimented the City Commission and thanked them and staff for implementing this visionary accommodation. This will allow the City to attract and retain qualified people. Hiring and retaining qualified people is becoming more difficult. He congratulated the City for doing this, however, he mentioned that 2 people were left behind. These are the Executive Director and the Deputy Executive Director for the Pompano Beach Police & Firefighters' Pension System. The Executive Director has been with the Pension System for 8 years and the Deputy Executive Director has been with them for 4 years. Therefore, he requested that the City Commission consider including them in this package for the exact same reason, to retain quality people over a long period of time, which is what this magnate does.

Mayor Hardin indicated that this action was initiated by the pension board to the City.

Mr. O'Connell stated that he would address a letter to the City Manager, the Assistant City Manager and the Human Resources Director to do the same for the other 2 Executive Directors for the Police and Firefighters' Pension System.

Gregory Harrison - City Manager - Money Available from American Recovery Act Program - Mr. Harrison stated that the City received Federal money under the American Recovery Act (ARA), and there is money remaining for people who can receive up to \$2,000 maximum award to assist with paying their water bills that they got behind on during COVID. They need to contact City staff who will coach them on how to do this online. She mentioned that the affordable housing buyout is not necessarily something that all cities have or need to have. Therefore, the City of Pompano Beach may want to consider altering its policy and the way it is written, and what is being asked for in having it all. The City is a hot enough market that they could try to ensure in the new developments, rentals, etc., that there is space carved out for the workforce and to ensure we are able to continue getting people of all levels of the economy living in Pompano Beach. So, she suggested to have staff look into what other cities are doing, what their economies look like, and the pros and cons of it, to open up a discussion on this.

<u>Commissioner Tom McMahon - Roadways Repaving</u> - Comr. McMahon wanted to follow-up on the paving of the "ugly" streets. If the City is going to do 8 miles per year, 300 miles of roads will never satisfy the residents, when it comes to paving. So, when the budget process is considered, he would like to ask the City Manager's Office to closely look at this major improvement. As the Mayor mentioned earlier, if there are alternative methods that will cost less, to consider this. However, he reiterated that doing only 8 miles per year is not going to fix the road conditions that are in the City.

<u>Vice Mayor Beverly Perkins - Update on Speed humps at NW 6th Avenue</u> - Vice Mayor Perkins asked for an update on the speed humps on NW 6th Avenue. The last meeting she had discussed trying to get those speed humps lowered because they are too high. She received an email from Assistant City Manager Brian Donovan, and wanted to know where is the City at this point in time.

Greg Harrison, City Manager believes the speed humps have been removed around the roundabouts. However, he will double check on this to ensure that they are removed. He can discuss this off line with Vice

Mayor Perkins.

<u>Black History Month Guide</u> - Comr. Perkins mentioned that she received a Black History month guide from Adriane Clarke of Cultural Affairs, and she thinks this is good for the community to have so that they will know what events are taking place for the month of February. She suggested that they give some of these guides out to the churches and perhaps in the schools. She applauded whoever put this guide together as this is great for the community.

Vice Mayor Perkins thanked the community for her "Princess Birthday Card" and the birthday wishes as well.

Mayor Rex Hardin - Sun Sentinel Coverage of Black History Month - Mayor Hardin in piggybacking on Black History month comments made earlier, stated he was thrilled to see Pompano Beach listed in the Sun Sentinel newspaper that mentioned a number of Black History Month events. Pompano Beach for years has been overlooked, which is one of his pet peeves. All other cities would be listed in the papers regarding what they are doing during this time, but Pompano Beach has never been mentioned, and he knows that the City has been doing some stuff. However, this year the City was listed in the Sun Sentinel and he wanted to thank them for listing all the things that are going on in Pompano Beach for Black History month. Notwithstanding, he also appreciates the Black History Month guide published.

<u>Panhandling Issues</u> - Mayor Hardin shouted "Hallelujah" to one of Comr. McMahon's pet projects about panhandling on I-95. He thanked Major Wayne Adkins of Broward Sheriff's Office (BSO) for his persistence by contacting the Florida Department of Transportation (FDOT), and they sent a letter to the City, which now gives the BSO permission to actually take care of the panhandling problem on FDOT property out of I-95 interchanges. So hopefully, there will be a change in activities out there. It has been a hot topic of this Commission for a long time about panhandling on I-95 and how it impacts the look of the community.

<u>Anti-Semitism Activities</u> - Mayor Hardin indicated a lot of things have been happening nationwide and locally, but luckily he has not heard of any incident in Pompano Beach. However, it is important for the City to condemn any sort of anti-Semitism that ever gets witnessed or heard about or see happening. There is too much of this going on. There have been issues with flyers on people's driveway down in the Miami area.

Mayor Hardin stated that the 2022 Broward County Mayors' Gala was coming up, which was sidelined a few years due to COVID. This benefits the United Way organization. In the past, the City has purchased a table for this Gala, which will be held on Saturday, April 30th at the Hard Rock hotel in the City of Hollywood.

MOTION: A motion was made by Mayor Hardin, seconded by Comr. Eaton to purchase a table for the Broward County Mayors' Gala. On voice vote the motion carried unanimously.

Mayor Hardin wished Vice Mayor Perkins a Happy Birthday.



- Local Business Community Video This strategy consist of a promotional film showcasing the city of Pompano Beach's strengths to entice relocating businesses. A 6 minute video is being produced, which focuses on the City's high quality of life, ideal location and transportation links, and abundant amount of recent public and private investing within the City. In addition, the video contains business testimonials about why Pompano Beach is a great place to do business. Staff developed the video script, managed narration, and video filming and editing. Grapeseeker Video and Graphic Inc. was used to film the project.
- Long-Term Tax Base Growth Model Municast software representative is assisting staff with updating the actual financials for the end of year months. Moreover, future and historical rates and fees are being entered, as well; along with historical economic data. Budget staff met with Municast to discuss assumptions and scenario options for sensitivity analysis. Cumulatively, the information entered will help staff visualize how scenarios based on selected assumptions will impact the current and future EMS and General Fund budgets.
