WHEREAS, the citizens of the Cities of Pompano Beach, Florida, and Comune di Golfo Aranci, Italy, have expressed their willingness and desire, through their respective representatives to become Friendship Cities and to share ideas and encourage exchanges of our citizens that will lead to a lasting friendship between our people; and

WHEREAS, it is hoped that the Friendship City relationship will provide opportunities for cultural, educational and business exchanges, as well as, providing our citizens, students and youth with international experiences to broaden the perspectives, and

WHEREAS, City of Pompano Beach is in receipt of a letter indicating a willingness to partner with the City of Pompano Beach as a Friendship City; and

WHEREAS, the Mayor and the City Commission of the City of Pompano Beach, Florida, wish to join with Honorable Giuseppe Fasolino, Mayor of Golfo Aranci, Italy, to approve the formal establishment of a Friendship Cities Relationship between the City of Pompano Beach, Florida, and Golfo Aranci, Italy, to promote cultural, educational, and economic exchanges between the two cities; now, therefore,
