Who approved the vote on such an important matter for the citizens of Pompano Beach to take place on Tuesday at 1 PM, when most people are at work?

I would like to know the names of these "representatives of the citizens of Pompano Beach" who approved this vote at that time?

I am a resident of Pompano Beach and I'm in writing to express my opposition to the proposed zoning Text Amendment PH2025-57, which seeks to change the cities code to allow hospital based off campus emergency departments. The applicant initially went through the normal planning and zoning process and did not receive the approval; a 6-1 denial. Now they are requesting a code amendment to force their way in. This approach bypasses the site specific review and effectively changes the rules after the fact, undermining the intent of the cities Zoning and Planning procedure. I am concerned that approving this amendment will:

1. Set a precedence for overriding planning and zoning recommendations through code amendments
2. Allow high impact medical facilities and areas not planned for such uses affecting neighborhoods, traffic and city infrastructure
3. Limit meaningful public input especially with weekday afternoon meeting and minimal notice to residence.

For these reasons, I respectfully urge the city commission to reject this. ode amendment and uphold the integrity of the city Zoning and planning process.
